

SENATE BILL No. 368

May 21, 2013, Introduced by Senators COLBECK, ROCCA, JONES, MARLEAU, SCHUITMAKER, MEEKHOF, EMMONS, BRANDENBURG, BOOHER, GREEN, CASWELL, JANSEN, NOFS, PAPPAGEORGE, HILDENBRAND, HUNE, KOWALL, PROOS, PAVLOV, CASPERSON, RICHARDVILLE, ROBERTSON and HANSEN and referred to the Committee on Government Operations.

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
(MCL 257.1 to 257.923) by adding section 811x.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 811X. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
2 SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE
3 RECOGNIZING RIGHT TO LIFE OF MICHIGAN. THE SECRETARY OF STATE IN
4 CONJUNCTION WITH RIGHT TO LIFE OF MICHIGAN SHALL DESIGN THE FUND-
5 RAISING PLATES AUTHORIZED IN THIS SECTION.

6 (2) THE RIGHT TO LIFE OF MICHIGAN FUND IS CREATED WITHIN THE
7 STATE TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR OTHER
8 ASSETS FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE
9 TREASURER SHALL DIRECT THE INVESTMENT OF THE FUND. THE STATE
10 TREASURER SHALL CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND

1 INVESTMENTS. MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR
2 SHALL REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.

3 (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY
4 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING RIGHT TO LIFE OF
5 MICHIGAN TO THE STATE TREASURER, WHO SHALL CREDIT THE DONATION
6 MONEY TO THE RIGHT TO LIFE OF MICHIGAN FUND CREATED UNDER
7 SUBSECTION (2).

8 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE RIGHT TO
9 LIFE OF MICHIGAN FUND CREATED UNDER SUBSECTION (2) ON A QUARTERLY
10 BASIS TO RIGHT TO LIFE OF MICHIGAN.

11 (5) THE SECRETARY OF STATE SHALL BE THE ADMINISTRATOR OF THE
12 RIGHT TO LIFE OF MICHIGAN FUND CREATED UNDER SUBSECTION (2) FOR
13 AUDITING PURPOSES.

14 Enacting section 1. This amendatory act takes effect January
15 1, 2014.
