#### **Motions and Resolutions**

The Speaker, on behalf of the entire membership of the House of Representatives, offered the following resolution: **House Resolution No. 49.** 

A resolution of tribute offered as a memorial for John M. Maynard, former member of the House of Representatives. Whereas, It is with deep respect for his dedicated service that we mark the passing of John M. Maynard. For sixteen years, he represented the residents of St. Clair Shores and nearby areas in Macomb County, fighting for what he believed and for what he thought best for his district; and

Whereas, John Maynard lived a life of service to our country, our state, and his community. As a young man, he served our country during the Korean War in the United States Marine Corps, and remained an active member of the AMVETS, the American Legion, Veterans of Foreign Wars, and the Disabled American Veterans. Later in his life, he served six years as a St. Clair Shores city councilman. In 1974, he was elected to the Michigan House of Representatives; and

Whereas, John Maynard brought his unique perspective, concern, and diligence in public service to the work of the Michigan Legislature. Often remembered as an advocate for reinstating the death penalty, he always demonstrated a sincere concern for the best interests of his constituents. In the early part of his legislative career, he served on a number of different committees, but he would spend his last eight years in Lansing as a hardworking and effective member of the Appropriations Committee: and

Whereas, John Maynard remained politically active to the end of his life. Despite his failing health, he ran unsuccessfully for the 2012 Democratic nomination in 18th House District because he felt that he still had something valuable to contribute to the debate. Only a few months later, he would pass away, leaving behind his loving family and a legacy of honorable service; now, therefore, be it

Resolved by the House of Representatives, That we offer this expression of our highest tribute to honor the memory of John M. Maynard, a member of this legislative body from 1975 to 1990; and be it further

Resolved, That copies of this resolution be transmitted to the Maynard family as evidence of our lasting esteem for his memory.

## House Resolution No. 45.

A resolution to declare March 20, 2013, as Agriculture Day in the state of Michigan.

#### Substitute for House Resolution No. 45.

A resolution to declare March 20, 2013, as Agriculture Day in the state of Michigan.

Whereas, Agriculture is the second largest industry in the state of Michigan and agriculture continues to grow; and

Whereas, Michigan is a national leader in the production of commodities with more than 200 separate commodities produced on a commercial basis. Our state is the leading producer in 17 of those commodities; and

Whereas, Michigan's agricultural economy is stronger than the economy in general. There are 55,000 farms and over 500 food processors in Michigan; and

Whereas, According to the 2012 Michigan State University Product Center Strategic Marketing Institute Report on the economic impact of Michigan's food and agriculture system Michigan farmers contribute more than \$91 billion in high-quality food, fiber, and floriculture annually to the state's economy; and

Whereas, Michigan's many microclimates permit the growing of grains, corn, beans, celery, apples, cherries and grapes among others: and

Whereas, Michigan's livestock and dairy sectors produce superior quality beef, poultry, pork, and dairy products enjoyed throughout the world; and

Whereas, Our abundant natural resources continue to make Michigan a great place to live, work, and play. As the state continues to recover from the most recent economic struggles, agriculture will continue to play a vital role in our long-term recovery; and

Whereas, Michigan agriculture is a renewable economic resource for the state, employing more than one million people and creating income that is replenished every year in the state; and

Whereas, Michigan agriculture is a family affair with families or partners owning the overwhelming majority of the state's farms and agricultural facilities; now, therefore, be it

Resolved by the House of Representatives, That the members of this legislative body declare March 20, 2013, as Agriculture Day in the state of Michigan. We recognize and honor the achievements and contributions of farmers and the thousands of people involved in jobs relating to Michigan agriculture.

"(4) THIS ACT DOES NOT APPLY TO A PERSON WHO ALLOWS A PATRON TO COME INTO CONTACT WITH A LARGE CARNIVORE UNDER SUBSECTION (3)(D)(i) OR (ii) IF THE LARGE CARNIVORE IS A BEAR LESS THAN 36 WEEKS OF AGE OR A BEAR WEIGHING 90 POUNDS OR LESS IF THE PERSON OTHERWISE MEETS THE REQUIREMENTS OF SUBSECTION (3) AND SATISFIES 1 OF THE FOLLOWING:

(A) THE PERSON WAS IN POSSESSION OF A BEAR ON THE EFFECTIVE DATE OF THE 2013 AMENDATORY ACT THAT AMENDED THIS SECTION.

## (B) THE PERSON ACQUIRED A BUSINESS DESCRIBED IN SUBSECTION (3)(A) FROM A PERSON WHO WAS IN POSSESSION OF A BEAR ON THE EFFECTIVE DATE OF THE 2013 AMENDATORY ACT THAT AMENDED THIS SECTION." and renumbering the remaining subsection.

The proposals contain measures that will make it more difficult and expensive for seniors to obtain comprehensive insurance, specifically, the proposal that ends Blue Cross and Blue Shield of Michigan's obligation to subsidize the cost of Medigap insurance after 2016.

I voted NO on these bills because I'm opposed to putting increased financial burdens on Michigan's seniors, who are already struggling to pay a new tax on retirement income and have had tax credits and deductions reduced or eliminated."
