Senators Pappageorge, Proos, Nofs, Anderson, Marleau, Booher and Brandenburg offered the following resolution: Senate Resolution No. 23.

A resolution proclaiming March 24-30, 2013, as Michigan STEM Awareness Week.

Whereas, An education in science, technology, engineering, and mathematics (STEM) is critical to our children's future and the continued growth and prosperity of Michigan; and

Whereas, We look to deliver a world-class education that will determine Michigan's success in the 21st century; and Whereas, If Michigan students become inspired by science, technology, engineering, and mathematics at an early age, there is a greater likelihood they will want to enter those growing career fields when they graduate; and

Whereas, Increased awareness in our community of STEM education and STEM-related careers will advance Michigan's workforce; and

Whereas, STEM-related careers will be pivotal in the 21st century economy; and

Whereas, A STEM education will ensure our state's workforce will be better equipped for the jobs of tomorrow; now, therefore, be it

Resolved by the Senate, That we hereby proclaim the week of March 24-30, 2013, as Michigan STEM Awareness Week. We call upon parents, educators, community organizations, businesses, governments, and the people of Michigan to observe the week with appropriate programs and activities.

#### **Statements**

Senators Green, Jones, Kahn and Colbeck asked and were granted unanimous consent to make statements and moved that the statements be printed in the Journal.

The motion prevailed.

Senator Green's statement is as follows:

I rise today to offer some brief remarks regarding a number of proposals before the Michigan Senate today. We all know the phrase "lead by example." I believe that Michigan can serve as an example to the rest of the nation in many respects. *Site Selection* magazine recently ranked Michigan 4th in the nation for major new corporate facilities and expansions. That is good news. We didn't get there by following Washington's lead, and this chamber is currently considering proposals that do just that.

We're poised to drink their Kool-Aid and accept their funny money. From health care exchanges to the Medicaid expansion, that's all the great promise of federal aid is—funny money. It is funny money that is not free, that our taxpayers will have to pay back. Worst of all, it is a credit card bill we will be leaving to our kids and grandkids. With 20 grandkids, that kind of makes me sick. After what? The unprecedented expansion of the size and power of the federal government. I just won't play their shell game; I won't drink their Kool-Aid; I won't agree to take their funny money. It is nothing less than aiding and abetting Washington's drunken sailor spending habits.

The 10th Amendment to the United States Constitution reads: "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people." We either believe in it or we don't. We either believe in fiscal responsibility or we don't. I believe it is hypocritical to grandstand against Obamacare and then heavily extol the virtues of its very implementation. From exchanges to the growing size of the federal government, to 2nd Amendment rights, to auto control regulators, this madness in Washington has got to stop. It is time that this chamber, that this Legislature, take a stand on the 10th Amendment in defense of our state. Our taxpayers and our future generation can say: "Enough is enough."

I do not have all the answers to every problem, but Michigan can do better. Washington, keep your funny money.

Senator Jones' statement is as follows:

I want to thank the Senators today for the unanimous vote on Senate Bill No. 94. Senate Bill No. 94 asserts our 10th Amendment states' rights that we will not allow the federal government to grab a U.S. citizen and hold them without charges.

Today you stand with the Michigan Senators of 1855 who defied the federal government's Fugitive Slave Act and then granted escaped slaves habeas corpus, trial by jury. We stand with them in history telling the federal government: "Do not imprison U.S. citizens without charges."

Senator Kahn's statement is as follows:

My dear friend and seatmate, the Senator from the 13th District, is his usual eloquent self. There are some other issues that we in this chamber need to bear in mind as we go forth with this decision. One of these is that there are budget consequences if we fail to implement this exchange; we will have to come up with the dollars for that. They're fairly substantial, \$20 million or so. The second is the characterization of the options that would be available to us with a state-federal exchange. While it is true that we in this chamber favor a state exchange, I do not believe that it is an all-or-nothing choice. A state-federal partnership still allows us to have a say on the choice of plans that will be included. It allows us to promote a state plan. It is the choice to support our own businesses here in Michigan. If we reject this, it is a federal-only exchange. We, of course, lose that opportunity. We lose our seat at the table on making decisions going forward.

My other point, that my good friend did not bring up, is that we in general need to remember about these exchanges is that this isn't a decision that is cast in stone forever. This could be rethought going forward and not in a year or two or three or four. You could rethink your participation in this in fairly short order. You might not want to rethink it because the federal government, at least over the short haul, is going to be picking up most of the costs; actually, 100 percent of the costs. That, too, needs to be borne in mind.

Our side of the aisle will be hearing tomorrow from Director Headen. I would urge members to listen to him tomorrow with an open mind.

Senator Colbeck's statement is as follows:

There has been a lot of discussion around the health exchange today, and I would like to frame it for my colleagues what the alternatives and options before us are. The federal government, the HHS has come out with a blueprint. This came out after the passage of the Affordable Care Act. This blueprint specifies three different options for people and the state to pursue. One is a state-based exchange, another is a partnership exchange, and the third is a federally-facilitated exchange. The common ingredient on all of these different exchanges beside the word "exchange" is the fact that the state has no control over the policies associated with each of those exchanges where they matter most—which is around the actual health care that is offered to the citizens of Michigan.

I don't care about bureaucratic policies or how you run your call center or anything like that. What I care about is what happens to the people who are supposed to be cared for as a result of this health insurance. There is no difference in any

three of the options in that regard. So I want to highlight and agree with my colleague from the 13th District that we should not be running the complaint department for the Affordable Care Act at all.

The supplemental that will be discussed here has three different components to it. There is a plan manager component, a minor portion of it. There is also a \$19 million allocation for the consumer assistance personnel, which, by the way, is a one-time grant, and we pick up the bill afterward. These are people hired to man the complaint desks. The last part is for an IT fix, which I would submit that we have \$47 million worth of IT project funds in the budget from last year, and also we are looking at doing a similar budget this year. We have projects in the queue that can help manage a lot of those interfaces right now if you just adjust the specs to synch up, so we don't need this supplemental that is coming down the train.

It is a bad deal for Michigan, and I would welcome a talk about exchange options that actually do benefit the citizens of Michigan. I think there is some room within state-based exchanges if we went back to proposals that were taken off the table when we talked about the MIHealth Marketplace, something that we preserve a degree of free-market accountability. That wasn't discussed; it was left on the table, so we are left with what we have right now.

I encourage everyone to be wary. When you read the fine print on this, we get to do all the puppet work, but the puppeter back in D.C. is making all the rules.
