These events have raised the level of attention to issues of safety in our school buildings and those who occupy them. Preparedness is the key to saving lives; and

Whereas, School boards and administrators should continuously review new lockdown and school safety technology in order to revise their own policies as needed. Input from local emergency management coordinators and first responders will build upon current plans and strengthen the ability to protect against any encountered threat, whether natural or manmade; now, therefore, be it

LAND SHALL NOT BE PURCHASED UNDER THIS SUBDIVISION UNTIL THAT PURCHASE IS APPROVED BY THE JOINT CAPITAL OUTLAY SUBCOMMITTEE."
- 4. Amend page 33, line 12, after "MANAGEMENT." by inserting "EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, NOT MORE THAN 0.25% OF THE MONEY UNDER THIS SECTION SHALL BE USED TO ACQUIRE LANDS. HOWEVER, IF ALL OF THE MONEY APPROPRIATED FROM THE NATURAL RESOURCES TRUST FUND FOR ECO-REGION ACQUISITION CARRIED OVER FROM PREVIOUS FISCAL YEARS IS SPENT, THEN THE 0.25% LIMITATION UNDER THIS SECTION DOES NOT APPLY. LAND SHALL NOT BE ACQUIRED UNDER THIS SECTION UNTIL THAT ACQUISITION IS APPROVED BY THE JOINT CAPITAL OUTLAY SUBCOMMITTEE."
