

**SENATE SUBSTITUTE FOR
HOUSE BILL NO. 4451**

A bill to amend 1975 PA 120, entitled
"Michigan commercial feed law,"
by amending sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14,
and 15 (MCL 287.521, 287.522, 287.523, 287.524, 287.525, 287.526,
287.527, 287.528, 287.529, 287.530, 287.531, 287.532, 287.533,
287.534, and 287.535), sections 3 and 6 as amended by 1980 PA 338,
and by adding sections 16, 17, 18, and 19.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. This act shall be known and may be cited as the
2 ~~"Michigan commercial"~~ "feed law".

3 Sec. 2. This act shall be administered by the director of the
4 department of agriculture **AND RURAL DEVELOPMENT**.

5 Sec. 3. As used in this act:

6 **(A) "AAFCO OFFICIAL PUBLICATION" MEANS THE DOCUMENT ENTITLED**

1 "2015 OFFICIAL PUBLICATION", AS PUBLISHED BY THE ASSOCIATION OF
2 AMERICAN FEED CONTROL OFFICIALS.

3 (B) "ANIMAL" MEANS ANY VERTEBRATE ANIMAL, OTHER THAN HUMANS,
4 INCLUDING MAMMALS, BIRDS, FISH, REPTILES, AND AMPHIBIANS, AND ANY
5 DOMESTICATED INSECT.

6 (C) "ANIMAL FEED" MEANS EDIBLE MATERIAL THAT IS CONSUMED BY AN
7 ANIMAL AND CONTRIBUTES ENERGY, NUTRIENTS, OR BOTH, TO THE ANIMAL'S
8 DIET.

9 (D) ~~(a)~~—"Brand" means a word, name, symbol, or device, or A
10 combination thereof which ~~OF ANY OF THESE THAT~~ identifies the
11 commercial feed of a MANUFACTURER OR distributor and distinguishes
12 it from that of ~~others~~. OTHER MANUFACTURERS OR DISTRIBUTORS.

13 ~~—— (b) "Bulk feed" means a type of commercial feed in solid or~~
14 ~~liquid state in a nonpackaged form.~~

15 (E) "BULK" OR "IN BULK" MEANS FEED THAT IS NOT DIVIDED INTO
16 PARTS OR PACKAGED IN SEPARATE UNITS OR ANY LOT THAT IS NOT IN A
17 CLOSED CONTAINER AT THE TIME IT PASSES TO THE POSSESSION OF THE
18 PURCHASER AND INCLUDES THAT FEED AT ANY STAGE OF DISTRIBUTION.

19 (F) "CEASE ORDER" MEANS A CEASE ORDER ISSUED BY THE DIRECTOR
20 PURSUANT TO SECTION 15.

21 (G) ~~(e)~~—"Commercial feed" means ALL materials OR COMBINATION
22 OF MATERIALS, INCLUDING FEED INGREDIENTS, THAT ARE distributed OR
23 INTENDED FOR DISTRIBUTION for use as ANIMAL feed or for mixing in
24 ANIMAL feed. ~~, for animals other than humans except:~~ COMMERCIAL FEED
25 DOES NOT INCLUDE ANY OF THE FOLLOWING:

26 (i) Unmixed seed, ~~whole or mechanically altered, made directly~~
27 ~~from the entire seed, when~~ WHOLE SEEDS OR PHYSICALLY ALTERED ENTIRE

1 UNMIXED SEEDS, AS DEFINED BY UNITED STATES GRAIN STANDARDS, 7 USC
2 CHAPTER 3, IF BOTH OF THE FOLLOWING CONDITIONS ARE MET:

19 (iv) FEED PROVIDED TO CONTRACT FEEDERS THAT IS MANUFACTURED BY
20 INTEGRATED OPERATORS THAT IS NOT ADULTERATED WITHIN THE MEANING OF
21 SECTION 8.

22 (v) UNMIXED MEAT, POULTRY, FISH, AND OTHER PORTIONS OF ANIMAL
23 CARCASSES TO BE COMMERCIALY SOLD IN THEIR RAW OR NATURAL STATE
24 WITHOUT FURTHER PROCESSING OR PACKAGING, EXCEPT FREEZING OR
25 DENATURING, IF BOTH OF THE FOLLOWING CONDITIONS ARE MET:

26 (A) THE PRODUCTS ARE NOT ADULTERATED WITHIN THE MEANING OF
27 SECTION 8.

1 (B) THE PRODUCTS ARE NOT INTENDED AS COMMERCIAL FEED OR FOR
2 USE AS A FEED INGREDIENT.

3 (vi) FEEDER MICE, OTHER LIVE FEEDER ANIMALS, AND CRICKETS THAT
4 ARE NOT ADULTERATED WITHIN THE MEANING OF SECTION 8.

5 (H) "COMMISSION" MEANS THE COMMISSION OF AGRICULTURE AND RURAL
6 DEVELOPMENT.

7 (I) "CONTRACT FEEDER" MEANS A PERSON THAT IS AN INDEPENDENT
8 CONTRACTOR THAT FEEDS ANIMALS PURSUANT TO A CONTRACT IF THE FEED IS
9 SUPPLIED, FURNISHED, OR OTHERWISE PROVIDED TO THE PERSON.

23 A "distributor" is a person who distributes.

14 (T) **"GUARANTOR" MEANS A PERSON THAT AGREES TO BE RESPONSIBLE**
15 **FOR LABELING, INFORMATION, GUARANTEES, AND CLAIMS.**

16 (U) **"INTEGRATED OPERATOR" MEANS A PERSON LOCATED WITHIN THIS**
17 **STATE THAT MANUFACTURES ANIMAL FEED FOR OTHER INTEGRATED OPERATORS**
18 **IF THERE IS A MINIMUM OF 5% OWNERSHIP BY ALL PERSONS INVOLVED IN**

2 (X) "LICENSE" MEANS A COMMERCIAL FEED LICENSE ISSUED UNDER
3 THIS ACT.

4 (Y) "LICENSEE" MEANS A PERSON THAT HAS BEEN ISSUED A LICENSE.

5 (Z) "LOCAL UNIT OF GOVERNMENT" MEANS A COUNTY, TOWNSHIP, CITY,
6 OR VILLAGE.

7 (AA) ~~(t)~~ "Manufacture" means to ~~process~~, **PREPARE**, grind, mix,
8 package, **REPACKAGE**, or ~~blend custom or~~ **RELABEL** commercial feed for
9 distribution. A ~~"manufacturer" is~~

16 (DD) "OFFICIAL SAMPLE" MEANS A SAMPLE OF FEED TAKEN BY THE
17 DIRECTOR IN ACCORDANCE WITH SECTION 7.

18 (EE) ~~(m)~~ "Percent" or "percentage" means the percentage by
19 weight.

20 (FF) ~~(n)~~ "Person" means an individual, partnership,
21 ~~association, firm, or corporation~~, **ASSOCIATION, GOVERNMENTAL**
22 **ENTITY, OR OTHER LEGAL ENTITY.**

23 (GG) "PET FOOD" MEANS ANY COMMERCIAL FEED PREPARED AND
24 DISTRIBUTED FOR CONSUMPTION BY DOGS OR CATS.

11 ADMINISTRATIVE PROCEDURES ACT OF 1969, 1969 PA 306, MCL 24.201 TO

13 (KK) "SEIZURE ORDER" MEANS A SEIZURE ORDER ISSUED BY THE
14 DIRECTOR PURSUANT TO SECTION 15.

26 Sec. 4. ~~(1) Beginning January 1, 1976, a person shall not~~
27 ~~manufacture or distribute in this state a commercial feed until a~~

~~1 license is obtained by the manufacturer or distributor from the
2 department. A license shall be issued by the director upon receipt
3 of an application on forms provided by the director and upon
4 payment of a \$25.00 fee. Licenses expire on December 31 of each
5 year, except a license issued before January 1, 1976, shall not
6 expire until December 31, 1976.~~

~~7 (2) A label for each brand or product, except for customer
8 formula feed, distributed in this state shall be submitted to the
9 director for approval before distribution in this state.~~

~~10 (3) A distributor shall not be required to obtain a license to
11 distribute a brand or product if the manufacturer is already
12 licensed under subsection (1).~~

13 (1) EXCEPT AS PROVIDED IN SUBSECTION (2), THE FOLLOWING
14 PERSONS SHALL OBTAIN A LICENSE UNDER THIS ACT:

15 (A) A MANUFACTURER OF COMMERCIAL FEED FOR EACH FACILITY IN
16 THIS STATE USED TO MANUFACTURE COMMERCIAL FEED.

17 (B) A PERSON, OTHER THAN A MANUFACTURER, THAT DISTRIBUTES
18 COMMERCIAL FEED WITHIN THIS STATE OR THAT SERVES AS GUARANTOR OF
19 COMMERCIAL FEED DISTRIBUTED WITHIN THIS STATE.

20 (2) THE FOLLOWING PERSONS ARE NOT REQUIRED TO OBTAIN A
21 LICENSE:

22 (A) A PERSON THAT MAKES ONLY RETAIL SALES OF COMMERCIAL FEED
23 THAT CONTAINS LABELING OR ANOTHER APPROVED INDICATION THAT THE
24 COMMERCIAL FEED IS FROM A LICENSED MANUFACTURER, DISTRIBUTOR, OR
25 GUARANTOR THAT HAS ASSUMED FULL RESPONSIBILITY FOR THE INSPECTION
26 FEE DUE UNDER SECTION 6.

27 (B) AN ON-FARM MIXER-FEEDER, IF THE PERSON IS NOT DISTRIBUTING

1 FEED COMMERCIALY.

2 (C) AN INTEGRATED OPERATOR THAT DOES NOT DISTRIBUTE FEED
3 COMMERCIALY.

4 (3) A PERSON THAT WISHES TO OBTAIN A LICENSE SHALL SUBMIT AN
5 APPLICATION TO THE DEPARTMENT ON A FORM PROVIDED BY OR APPROVED BY
6 THE DIRECTOR AND ACCOMPANIED BY A LICENSE FEE PAYABLE TO THIS STATE
7 IN THE FOLLOWING AMOUNT:

8 (A) FOR A MANUFACTURER, \$100.00 FOR EACH MANUFACTURING
9 FACILITY, EXCEPT THAT THE FEE FOR A MANUFACTURER THAT MANUFACTURES
10 COMMERCIAL FEED IN CONTAINERS OF 5 POUNDS OR LESS IS \$25.00 FOR
11 EACH MANUFACTURING FACILITY.

12 (B) FOR A DISTRIBUTOR OR GUARANTOR WHOSE NAME APPEARS ON THE
13 LABEL, \$100.00, EXCEPT THAT THE FEE FOR A DISTRIBUTOR OR GUARANTOR
14 OF COMMERCIAL FEED THAT IS DISTRIBUTED IN CONTAINERS OF 5 POUNDS OR
15 LESS IS \$25.00.

16 (4) A NEW APPLICANT THAT FAILS TO OBTAIN A LICENSE WITHIN 30
17 CALENDAR DAYS AFTER NOTIFICATION OF THE REQUIREMENT TO OBTAIN A
18 LICENSE, OR ANY LICENSEE THAT FAILS TO COMPLY WITH LICENSE RENEWAL
19 REQUIREMENTS BY JUNE 30, SHALL PAY A \$50.00 LATE FEE IN ADDITION TO
20 THE LICENSE FEE.

21 (5) LICENSE FEES AND LATE FEES COLLECTED UNDER THIS SECTION
22 SHALL BE FORWARDED TO THE STATE TREASURER FOR DEPOSIT INTO THE
23 FUND.

24 (6) THE DIRECTOR SHALL ISSUE AN INITIAL OR RENEWAL LICENSE NOT
25 LATER THAN 90 DAYS AFTER THE APPLICANT SUBMITS A COMPLETE
26 APPLICATION ACCOMPANIED BY THE APPROPRIATE LICENSE FEE. IF THE
27 APPLICATION IS INCOMPLETE, THE DEPARTMENT SHALL NOTIFY THE

1 APPLICANT WITHIN 60 DAYS AFTER THE DEPARTMENT RECEIVES THE
2 APPLICATION.

3 (7) AFTER APPROVAL BY THE DIRECTOR, A LICENSE SHALL BE
4 FURNISHED TO THE APPLICANT. THE LICENSE SHALL BE DISPLAYED
5 PROMINENTLY AT EACH MANUFACTURING FACILITY USED TO MANUFACTURE
6 COMMERCIAL FEED AND SHALL BE AVAILABLE AT THE PRINCIPAL BUSINESS
7 OFFICE OR THE REGISTERED OFFICE OF EACH DISTRIBUTOR OR GUARANTOR.

8 (8) A LICENSE EXPIRES ON JUNE 30. A LICENSE IS NOT
9 TRANSFERABLE FROM 1 PERSON TO ANOTHER, FROM 1 OWNER TO ANOTHER, OR
10 FROM 1 LOCATION TO ANOTHER.

11 (9) TO DETERMINE COMPLIANCE WITH THIS ACT AND RULES
12 PROMULGATED UNDER THIS ACT, THE DIRECTOR MAY REQUIRE A CURRENT
13 LICENSEE OR AN APPLICANT FOR A NEW LICENSE TO SUBMIT LABELS OR
14 LABELING BEING USED OR INTENDED FOR USE WITH A COMMERCIAL FEED.

15 (10) THE DIRECTOR MAY DO 1 OR MORE OF THE FOLLOWING:

16 (A) PLACE CONDITIONS THAT LIMIT THE MANUFACTURE OR
17 DISTRIBUTION OF A PARTICULAR COMMERCIAL FEED ON THE LICENSE OF ANY
18 PERSON FOUND NOT IN COMPLIANCE WITH THIS ACT OR THE RULES
19 PROMULGATED UNDER THIS ACT.

20 (B) REFUSE TO LICENSE AN APPLICANT, OR REVOKE OR SUSPEND THE
21 LICENSE OF ANY PERSON NOT IN COMPLIANCE WITH THIS ACT OR THE RULES
22 PROMULGATED UNDER THIS ACT.

23 (11) A LICENSE SHALL NOT BE REFUSED, CONDITIONED, REVOKED, OR
24 SUSPENDED UNTIL THE LICENSEE OR APPLICANT FOR A LICENSE IS GIVEN
25 THE OPPORTUNITY FOR A HEARING PURSUANT TO THE ADMINISTRATIVE
26 PROCEDURES ACT OF 1969, 1969 PA 306, MCL 24.201 TO 24.328.

27 (12) AFTER A HEARING IS CONDUCTED PURSUANT TO THE

1 ADMINISTRATIVE PROCEDURES ACT OF 1969, 1969 PA 306, MCL 24.201 TO
2 24.328, UNDER SUBSECTION (11), THE DEPARTMENT MAY REVOKE OR REFUSE
3 TO ISSUE OR RENEW A LICENSE IF ANY OF THE FOLLOWING OCCURRED WITHIN
4 THE 3 YEARS PRECEDING THE DATE OF THE LICENSE APPLICATION:

5 (A) A PREVIOUS LICENSE ISSUED UNDER THIS ACT TO A PERSON WITH
6 AN OWNERSHIP OR MANAGEMENT INTEREST IN THE NEW OPERATION WAS
7 REVOKED DUE TO THE ADULTERATION OF COMMERCIAL FEED UNDER SECTION 8
8 OR A VIOLATION OF SECTION 9.

9 (B) THE APPLICANT, A MANAGER EMPLOYED BY THE APPLICANT, OR ANY
10 OTHER INDIVIDUAL WITH MANAGEMENT RESPONSIBILITIES FOR THE FEED
11 MANUFACTURING OPERATION OF THE APPLICANT WAS CONVICTED OF ANY
12 FELONY INVOLVING FRAUD, CONVERSION, OR EMBEZZLEMENT.

13 (C) THE APPLICANT'S LICENSE UNDER THE FEDERAL FOOD, DRUG, AND
14 COSMETIC ACT, REGISTRATION UNDER THE BIOTERRORISM ACT, 21 USC 350D,
15 OR COMMERCIAL FEED LICENSE IN ANOTHER STATE WAS REVOKED OR CANCELED
16 BECAUSE OF A VIOLATION OF THE RESPECTIVE ACT.

17 (13) EACH DISTRIBUTOR AND GUARANTOR HOLDING A LICENSE THAT
18 OPERATES FROM A BUSINESS LOCATION OUTSIDE THIS STATE SHALL DO
19 EITHER OF THE FOLLOWING:

20 (A) CONTINUOUSLY MAINTAIN IN THIS STATE A REGISTERED OFFICE
21 AND A RESIDENT AGENT, WHICH AGENT MAY BE AN INDIVIDUAL RESIDENT IN
22 THIS STATE WHOSE BUSINESS OFFICE OR RESIDENCE IS IDENTICAL WITH THE
23 REGISTERED OFFICE, A DOMESTIC CORPORATION OR LIMITED LIABILITY
24 COMPANY, OR A FOREIGN CORPORATION OR LIMITED LIABILITY COMPANY
25 AUTHORIZED TO TRANSACT BUSINESS IN THIS STATE AND HAVING A BUSINESS
26 OFFICE IDENTICAL WITH THE REGISTERED OFFICE. THE LICENSEE SHALL
27 FILE WITH THE DEPARTMENT THE NAME, ADDRESS, AND TELEPHONE NUMBER OF

1 THE RESIDENT AGENT AND SHALL MAINTAIN AND MAKE AVAILABLE RECORDS
2 REQUIRED BY THIS ACT.

3 (B) MAINTAIN AND MAKE AVAILABLE TO THE DEPARTMENT RECORDS
4 REQUIRED BY THIS ACT AND PAY ALL COSTS INCURRED BY THE DEPARTMENT
5 IN AUDITING THE RECORDS IF THEY ARE HELD AT AN OUT-OF-STATE
6 LOCATION.

7 (14) A LICENSE ISSUED PRIOR TO THE EFFECTIVE DATE OF THE
8 AMENDATORY ACT THAT ADDED THIS SUBSECTION REMAINS IN EFFECT UNTIL
9 JULY 1, 2016, SUBJECT TO REVOCATION OR SUSPENSION AS OTHERWISE
10 PROVIDED IN THIS ACT. BEGINNING JULY 1, 2016, ALL PERSONS REQUIRED

8 (5) A PERSON THAT VIOLATES OR ATTEMPTS TO VIOLATE THIS ACT OR
9 A RULE PROMULGATED UNDER THIS ACT IS GUILTY OF A MISDEMEANOR
10 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS OR A FINE OF
11 NOT MORE THAN \$5,000.00, OR BOTH, FOR EACH VIOLATION OR ATTEMPTED
12 VIOLATION, IN ADDITION TO ANY ADMINISTRATIVE FINES IMPOSED.

13 (6) A PERSON THAT KNOWINGLY AND WITH MALICIOUS INTENT VIOLATES
14 OR ATTEMPTS TO VIOLATE THIS ACT OR A RULE PROMULGATED UNDER THIS
15 ACT IS GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT
16 MORE THAN 90 DAYS OR A FINE OF NOT MORE THAN \$25,000.00, OR BOTH,
17 FOR EACH OFFENSE.

18 (7) THE DIRECTOR MAY BRING AN ACTION TO ENJOIN A VIOLATION OR
19 THREATENED VIOLATION OF THIS ACT OR A RULE PROMULGATED UNDER THIS
20 ACT IN A COURT OF COMPETENT JURISDICTION IN THE COUNTY IN WHICH THE
21 VIOLATION OCCURS OR IS ABOUT TO OCCUR.

22 (8) A PERSON THAT USES TO HIS OR HER OWN ADVANTAGE OR REVEALS
23 TO A PERSON, OTHER THAN THE DIRECTOR, OFFICERS OF THE DEPARTMENT,
24 THE ATTORNEY GENERAL, OR THE DEPARTMENT OF TREASURY, OR THE COURTS
25 WHEN RELEVANT IN ANY JUDICIAL PROCEEDING, ANY INFORMATION ACQUIRED
26 UNDER THIS ACT CONCERNING ANY METHOD, RECORD, FORMULATION, OR
27 PROCESS THAT AS A TRADE SECRET IS ENTITLED TO PROTECTION, IS GUILTY

1 OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90
2 DAYS AND SHALL BE FINED NOT LESS THAN \$500.00. THIS PROHIBITION
3 DOES NOT PROHIBIT THE DIRECTOR FROM EXCHANGING INFORMATION OF A
4 REGULATORY NATURE WITH APPOINTED OFFICIALS OF THE UNITED STATES

11 IN ADDITION, THE ATTORNEY GENERAL MAY BRING AN ACTION IN CIRCUIT
12 COURT TO RECOVER THE REASONABLE COSTS OF THE INVESTIGATION FROM ANY
13 PERSON THAT VIOLATED THIS ACT OR ATTEMPTED TO VIOLATE THIS ACT.
14 MONEY RECOVERED UNDER THIS SUBSECTION SHALL BE FORWARDED TO THE
15 STATE TREASURER FOR DEPOSIT INTO THE FUND.

16 (10) AS AN AFFIRMATIVE DEFENSE OF AN ACTION FILED UNDER THIS
17 SECTION, IN ADDITION TO ANY OTHER LAWFUL DEFENSE, A PERSON MAY
18 PRESENT EVIDENCE THAT, AT THE TIME OF THE ALLEGED VIOLATION OR
19 ATTEMPTED VIOLATION, THE PERSON WAS IN COMPLIANCE WITH THIS ACT AND
20 THE RULES PROMULGATED UNDER THIS ACT.

21 (11) A PERSON THAT VIOLATES THIS ACT IS LIABLE FOR ALL DAMAGES
22 SUSTAINED BY A PURCHASER OF A PRODUCT SOLD IN VIOLATION OF THIS
23 ACT. IN AN ENFORCEMENT ACTION, A COURT, IN ADDITION TO OTHER
24 REMEDIES OR PENALTIES PROVIDED BY LAW, MAY ORDER RESTITUTION TO A
25 PERSON INJURED BY THE PURCHASE OF A PRODUCT SOLD IN VIOLATION OF
26 THIS ACT.

27 SEC. 17. (1) THE FEED CONTROL FUND IS CREATED WITHIN THE STATE

1 TREASURY.

2 (2) THE STATE TREASURER SHALL RECEIVE FOR DEPOSIT IN THE FUND
3 ALL FEES, ADMINISTRATIVE OR CIVIL FINES, AND PAYMENTS FOR THE COSTS
4 OF INVESTIGATIONS INCURRED BY THE DIRECTOR COLLECTED UNDER THIS
5 ACT. IN ADDITION, THE STATE TREASURER MAY RECEIVE MONEY OR OTHER

2 RECEIVED PRIOR WRITTEN AUTHORIZATION FROM THE DEPARTMENT, THAT
3 LOCAL UNIT OF GOVERNMENT MAY ADOPT AN ORDINANCE THAT IS IDENTICAL
4 TO THIS ACT AND RULES PROMULGATED UNDER THIS ACT, EXCEPT AS

1 ADOPTED UNDER SUBSECTION (3) SHALL NOT BE ENFORCED BY A LOCAL UNIT
2 OF GOVERNMENT UNTIL APPROVED BY THE COMMISSION. THE COMMISSION
3 SHALL PROVIDE A DETAILED EXPLANATION OF THE BASIS OF A DENIAL

5 (5) WITHIN 60 DAYS AFTER THE LEGISLATIVE BODY OF A LOCAL UNIT

7 UNREASONABLE ADVERSE EFFECTS ON THE ENVIRONMENT OR PUBLIC HEALTH AS
8 PROVIDED FOR IN SUBSECTION (3) (A), THE DIRECTOR SHALL HOLD A LOCAL
9 PUBLIC MEETING TO DETERMINE THE NATURE AND EXTENT OF UNREASONABLE
10 ADVERSE EFFECTS ON THE ENVIRONMENT OR PUBLIC HEALTH DUE TO THE

17 (6) THE DIRECTOR MAY CONTRACT WITH A LOCAL UNIT OF GOVERNMENT
18 TO ACT AS ITS AGENT FOR THE PURPOSE OF ENFORCING THIS ACT AND THE
19 RULES PROMULGATED UNDER THIS SECTION. THE DIRECTOR HAS SOLE
20 AUTHORITY TO ASSESS FEES AND LICENSE FEE MANUFACTURERS AND
21 DISTRIBUTORS.

22 (7) A LOCAL UNIT OF GOVERNMENT THAT ADOPTS AN ORDINANCE UNDER
23 SUBSECTION (2) OR (3) SHALL REQUIRE PERSONS ENFORCING THE ORDINANCE
24 TO COMPLY WITH TRAINING AND ENFORCEMENT REQUIREMENTS DETERMINED

26 SEC. 19. TO FACILITATE CONTINUED ACCESS TO MARKETS FOR FEED

2 (A) AT THE REQUEST OF A LICENSEE OR BASED UPON RECORDS

11 REQUIRED UNDER THIS SECTION. THE SCHEDULE OF FEES SHALL NOT
12 DUPLICATE THOSE PROVIDED IN OTHER SECTIONS OF THIS ACT.
