

SUBSTITUTE FOR
SENATE BILL NO. 91

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
(MCL 257.1 to 257.923) by adding section 811dd.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 811DD. (1) NO LATER THAN OCTOBER 1, 2015, THE SECRETARY
2 OF STATE SHALL DEVELOP UNDER SECTION 811E AND ISSUE UNDER SECTION
3 811F A FUND-RAISING PLATE OR COLLECTOR PLATE RECOGNIZING THE
4 SLEEPING BEAR DUNES NATIONAL LAKESHORE. THE SECRETARY OF STATE IN
5 CONJUNCTION WITH PRESERVE HISTORIC SLEEPING BEAR SHALL DESIGN THE
6 FUND-RAISING PLATE AUTHORIZED IN THIS SECTION.

7 (2) THE SLEEPING BEAR DUNES NATIONAL LAKESHORE FUND IS CREATED
8 WITHIN THE STATE TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR
9 OTHER ASSETS FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE
10 TREASURER SHALL DIRECT THE INVESTMENT OF THE FUND. THE STATE

1 TREASURER SHALL CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND
2 INVESTMENTS. MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR
3 SHALL REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
4 THE STATE TREASURER SHALL BE THE ADMINISTRATOR OF THE FUND FOR
5 AUDITING PURPOSES.

6 (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY
7 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING THE SLEEPING BEAR
8 DUNES NATIONAL LAKESHORE TO THE STATE TREASURER, WHO SHALL CREDIT
9 THE DONATION MONEY TO THE SLEEPING BEAR DUNES NATIONAL LAKESHORE
10 FUND ESTABLISHED UNDER SUBSECTION (2).

11 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE FUND
12 ESTABLISHED UNDER SUBSECTION (2) ON A QUARTERLY BASIS TO PRESERVE
13 HISTORIC SLEEPING BEAR.

14 (5) MONEY DISBURSED TO PRESERVE HISTORIC SLEEPING BEAR UNDER
15 THIS SECTION SHALL BE EXPENDED ON PROJECTS THAT PRESERVE THE
16 HISTORIC AND NATURAL FEATURES OF THE SLEEPING BEAR DUNES NATIONAL
17 LAKESHORE FOR THE USE AND ENJOYMENT OF THE PUBLIC.

18 Enacting section 1. This amendatory act takes effect 90 days
19 after the date it is enacted into law.
