A bill to amend 1915 PA 31, entitled

"Youth tobacco act,"

by amending section 4 (MCL 722.644), as amended by 2006 PA 236, and by adding section 2b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2B. (1) A PERSON SHALL NOT SELL IN THIS STATE AN
- 2 ELECTRONIC SMOKING DEVICE UNLESS THE ELECTRONIC SMOKING DEVICE IS
- 3 PACKAGED IN A CHILD-RESISTANT CONTAINER THAT MEETS THE REQUIREMENTS
- 4 OF THE POISON PREVENTION PACKAGING ACT OF 1970, 15 USC 1471 TO
- 1477, AND OF 16 CFR PART 1700.
- 6 (2) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A
- 7 MISDEMEANOR PUNISHABLE BY A FINE OF NOT MORE THAN \$50.00 FOR THE
- 8 FIRST VIOLATION AND NOT MORE THAN \$500.00 FOR A SECOND OR
- 9 SUBSEQUENT VIOLATION.

- 6 MANUFACTURED, DISTRIBUTED, MARKETED, OR SOLD AS AN E-CIGARETTE, E-
- 7 PIPE, VAPE PEN, E-HOOKAH, OR ANY OTHER SIMILAR DEVICE. ELECTRONIC
- 8 SMOKING DEVICE DOES NOT INCLUDE ANY BATTERY OR BATTERY CHARGER THAT
- 9 IS SOLD SEPARATELY FROM AN ELECTRONIC SMOKING DEVICE.
- 10 (B) (a) "Minor" means an individual under WHO IS LESS THAN 18
- 11 years of age.
- 12 (C) (b)—"Person who sells tobacco products at retail" means a
- 13 person whose ordinary course of business consists, in whole or in
- 14 part, of the retail sale of tobacco products subject to state sales
- **15** tax.
- 16 (D) (c) "Public place" means a public street, sidewalk, or
- 17 park or any area open to the general public in a publicly owned or
- 18 operated building or public place of business.
- 19 (E) (d)—"Tobacco product" means a product that contains
- 20 tobacco and is intended for human consumption, including, but not
- 21 limited to, cigarettes, noncigarette smoking tobacco, or smokeless
- 22 tobacco, as those terms are defined in section 2 of the tobacco
- 23 products tax act, 1993 PA 327, MCL 205.422, and cigars.
- 24 (F) (e) "Use a tobacco product" means to smoke, chew, suck,
- inhale, or otherwise consume a tobacco product.
- 26 Enacting section 1. This amendatory act takes effect 90 days
- 27 after the date it is enacted into law.
