## **HOUSE BILL No. 5734**

June 8, 2016, Introduced by Reps. Barrett, Glenn, Hughes, Hooker, Outman, McBroom, Aaron Miller, Whiteford and LaGrand and referred to the Committee on Military and Veterans Affairs.

A bill to amend 1978 PA 368, entitled

"Public health code,"

by amending sections 20109 and 21711 (MCL 333.20109 and 333.21711), section 20109 as amended by 2015 PA 156.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 20109. (1) "Nursing home" means a nursing care facility,
- 2 including a county medical care facility AND A VETERANS' FACILITY
- 3 CREATED UNDER 1885 PA 152, MCL 36.1 TO 36.12, that provides
- 4 organized nursing care and medical treatment to 7 or more unrelated
- 5 individuals suffering or recovering from illness, injury, or
- 6 infirmity. As used in this subsection, "medical treatment" includes
- 7 treatment by an employee or independent contractor of the nursing
  - home who is an individual licensed or otherwise authorized to

- 1 engage in a health profession under part 170 or 175. Nursing home
- 2 does not include any of the following:
- 3 (a) A unit in a state correctional facility.
- 4 (b) A hospital.
- 5 (c) A veterans facility created under 1885 PA 152, MCL 36.1 to

- 7 (C) (d)—A hospice residence that is licensed under this
- 8 article.
- 9 (D) (e) A hospice that is certified under 42 CFR 418.100.
- 10 (2) "Person" means that term as defined in section 1106 or a

- 12 (3) "Public member" means a member of the general public who
- 13 is not a provider; who does not have an ownership interest in or
- 14 contractual relationship with a nursing home other than a resident
- 15 contract; who does not have a contractual relationship with a

- 17 is not the spouse, parent, sibling, or child of an individual who
- 18 has an ownership interest in or contractual relationship with a
- 19 nursing home, other than a resident contract.
- 20 (4) "Skilled nursing facility" means a hospital long-term care
- 21 unit, nursing home, county medical care facility, or other nursing
- 22 care facility, or a distinct part thereof, OF ANY OF THESE,
- 23 certified by the department to provide skilled nursing care.
- Sec. 21711. (1) A nursing home shall be licensed under this
- 25 article.
- 26 (2) "Nursing home", "nursing center", "convalescent center",
- 27 "extended care facility", or a similar term or abbreviation shall

- 1 not be used to describe or refer to a health facility or agency
- 2 unless the health facility or agency is licensed as a nursing home
- 3 by the department under this article.
- 4 (3) A person shall not purport to provide formal or informal
- 5 nursing care services of the kind normally provided in a nursing
- 6 home without obtaining a license as provided in this article. This
- 7 subsection does not apply to a hospital or a facility created by
- 8 Act No. 152 of the Public Acts of 1885, as amended, being sections
- 9 36.1 to 36.12 of the Michigan Compiled Laws.
- 10 Enacting section 1. This amendatory act takes effect 90 days
- 11 after the date it is enacted into law.
