**House Concurrent Resolution No. 28.**

A concurrent resolution of tribute offered as a memorial for the Honorable Thomas Brennan, former Justice of the Michigan Supreme Court.

Whereas, This body was saddened to learn of the passing of Judge Thomas Brennan, the eighty-first justice of the Michigan Supreme Court and founder of the Thomas M. Cooley Law School. He was an engaged legal and creative thinker and left an indelible imprint on the Michigan system of jurisprudence; and

Whereas, Thomas Brennan graduated from Detroit Catholic Central High School and the University of Detroit, earning his law degree from the University of Detroit Law School in 1952. There were no limits to his dreams in his multi-faceted career, as attorney, politician, judge, and educator. He worked as an attorney and became active in state politics, running multiple times for legislative seats, before being elected to sit on the Common Pleas Bench in 1961. He was later appointed, then elected, to the Wayne County Circuit Court; and

Whereas, At the urging of Governor Romney, Justice Brennan ran for and was elected to the Michigan Supreme Court in 1966 at age 37, the youngest justice in state history. Later, he led his judicial colleagues as Chief Justice, also the youngest ever; and

Whereas, Justice Brennan founded the Cooley Law School in 1972 and resigned from the Supreme Court to serve as its first dean and president for the next 20 years. He mentored many future attorneys and was extremely proud of the success of Cooley's students, faculty, and staff as they collaborated to learn and teach the law and its practice. With a philosophy of better access to legal education, Justice Brennan imparted legal knowledge, skills, and ethics to generations of students. Cooley Law School was the second largest law school in the country in 2002, when Justice Brennan retired; and

Whereas, In later years, Justice Brennan became an author and blogger. His works, *Judging the Law Schools* and *Starting a Law School*, imparted his ideas on using data to rank law schools and the act of creating, founding, and launching an institution. His insightful blog, *oldjudgesays*, was online for about ten years and enjoyed by many; now, therefore, be it

Resolved by the House of Representatives (the Senate concurring), That we offer this expression of our highest tribute to honor the memory of Justice Thomas Brennan and his commitment, courage, and ingenuity; and be it further

Resolved, That copies of this resolution be transmitted to the Brennan family as evidence of our lasting esteem for his memory.

The House of Representatives has adopted the concurrent resolution.

**Protests**

Senators Warren, Ananich, Gregory, Young, Knezek, Hood and Hollier, under their constitutional right of protest (Art. 4, Sec. 18), protested against the passage of Senate Bill Nos. 1248, 1249, 1250, 1251, and 1252.

Senators Warren and Hollier moved that the statements they made during the discussion of Senate Bill No. 1248 be printed as their reasons for voting “no.”

The motion prevailed.

Senator Warren’s statement, in which Senators Ananich, Gregory, Young, Knezek and Hood concurred, is as follows:

I rise to give my “no” vote explanation on this bill and the entire package, Senate Bill Nos. 1248 through 1252. Colleagues, exactly one month ago today voters throughout the state of Michigan flocked to the polls. In fact, we saw higher voter turnout in November 2018 than in any other gubernatorial year since 1962, before I was born. Those voters spoke loudly and clearly. Their message was this: We want a new direction in this state. We, the citizens of Michigan, want more ownership over our political process, and to have more opportunities and more easily accessible opportunities to participate. Colleagues, I am mystified at how we have seemingly decided that we should respond to that very clear message.

This legislation that we are voting on this afternoon goes completely the opposite direction. This legislation would, quite literally, give the two major political parties in our state the ability to name the folks who will be overseeing campaign finance in our state. There is no reason to think that this will work well. In fact, I would like to point out that on other legislation that I've been working on recently, our own Legislative Service Bureau specifically encouraged me to avoid having even-numbered boards to avoid deadlock. That's exactly what we're creating here. The example of a federal election commission-style panel shows us that partisan-appointed campaign finance regulators are nearly always unable to agree on whether the law has been violated or not.

As all of you know, I have frequently stood at this microphone and talked about the importance of changing our state's campaign finance laws, in ways that I think would reduce the influence of big money interests on our politics and public policy. Frequently, most of you have disagreed with me about that, but I have to believe that we can all agree on this—there should be rules and there are rules about how elected officials can raise and spend money in this process, and they should be enforced equally and fairly. Instead of copying a failed federal system, Michigan should be trusting the people of our state and the elected Secretary of State to help oversee these important decisions.

I urge my colleagues to vote “no.”

Senator Hollier's statement is as follows:

I would like to talk about this package. I think it's premature and I think it's unnecessary. I think that we elected a Secretary of State this fall who campaigned on fixing a number of these issues, and who made it a big component to prioritize getting big money out of politics. Somebody who is an expert nationally and someone who has made this a completely important part of the discussion. I wanted to say that this is someone whom I know very well, someone whom I have worked with, someone whom I have the utmost trust in, and someone whom an overwhelming majority of Michigan residents trust as well. I hope we would follow their heed and allow her to do her job.

### Protest

Senator Bieda, under his constitutional right of protest (Art. 4, Sec. 18), protested against the passage of Senate Bill Nos. 1248, 1249, 1250, 1251, and 1252.

Senator Bieda's statement is as follows:

I rise to make a “no” vote explanation on Senate Bill Nos. 1248 to 1252, if I may.

It's important to remember that while we make the laws, we are not above them. Voters did not send us here to make it easier for negligent politicians to hide campaign finance violations. In fact, they elected a wave of Democrats this year to fix this very problem. Now we have a Governor-elect who's going to reform decades of failed policy and fix our dang roads; we have an incoming Attorney General who will defend people, not corporate profits; and we have an incoming Secretary of State who will protect our elections and ensure that every Michigander has the right to vote.

Despite all these great changes, some in this very room refused to accept the consequences of the election. The bills that we just passed attempt to strip all authority from the Secretary of State when it comes to enforcing the Campaign Finance Act. This is a group of unelected bureaucrats purposely modeled after the Federal Election Commission with goals of being equally ineffective.

The new commission composed by this bill would consist of six members, three from each party, appointed by the Governor. But understand the catch here, the Governor would be forced to appoint the names submitted by the state central committees of the political parties. The bill literally says the party will give the Governor a list of three names, and the Governor will appoint those three names, so the parties will be hand-picking the people who will be on this bogus commission to enforce campaign finance issues.

The motive seems clear to me. I refuse to allow the fox to guard the henhouse, and for that reason, I voted “no” on Senate Bill Nos. 1248 through 1252.

Whereas, David Robertson received a bachelor's degree in political science and history from the University of Michigan-Flint and has worked in the insurance industry. His public service includes time as a Genesee County Commissioner and four terms of office in the House of Representatives. Also active in the community, he has done work with the Grand Blanc Rotary Club and local chambers of commerce, among other endeavors; and

Whereas, In his two terms and eight years of service in this chamber beginning in 2011, Senator Robertson has worked toward the betterment of the state. His leadership was illustrated as chair of the Local Government and Elections Committee and the Elections and Government Reform Committee. He also served on the Health Policy and Finance committees as vice chair, and was a member of the Insurance; Reforms, Restructuring, and Reinventing; Natural Resources; and Michigan Competitiveness committees. He contributed heavily to policy matters involving elections and campaign finance. Additionally, he tackled a wide swath of legislation dealing with other important matters such as taxation and economic development; now, therefore, be it

Resolved by the Senate, That we offer this expression of tribute to commend and thank the Honorable David B. Robertson for his notable contributions to this legislative body and to our state; and be it further

Senator Robertson asked and was granted unanimous consent to make a statement and moved that the statement be printed in the Journal.

Senator Robertson's statement is as follows:

Well, it's been a wonderful life. My service in the Legislature and the fact that I am standing here is inseparable from my family history. The only way to begin my remarks is to once again acknowledge the greatness that is America.

In coming to America, my parents basically gave me the greatest gift a parent can give a child—American citizenship. My father came from such an impoverished background in Scotland, he suffered from such malnutrition, his growth was stunted, he would wake up in the middle of the night screaming in agony from leg cramps, and his adult teeth grew in undeveloped from malnutrition. He came to America because he wanted a better life for himself and for his children. He told me once that he never ate better in his life than when the American soldiers came to Scotland prior to the D-Day invasion and the civilians got Spam. He loved Spam to his dying day.

The fact that I could be standing here a generation later having served eight years in this chamber and 16 years in this Legislature is a testament to the American Dream. Like nearly every immigrant story, my parents' definition of success in life was to see their children be just a little better off than they were. They succeeded. We are.

I'm proud of having been a part of debates over these last many years, part of the property tax revolt that defined legislative campaigns in the 1980s and '90s and culminated first in a property tax freeze and then the passage of Proposal A. I'm also proud of the vote we cast in September 1991 to end general assistance welfare for single, able-bodied adults which freed many from dependency and triggered welfare reform efforts all over the United States, but those welfare reform efforts started in Michigan.

My philosophy of government service to my constituents has always been the same—make me your first phone call, not your last, because I can usually accomplish more in an hour or a day than you can in weeks of frustration. My greatest satisfaction in this job has been when I've been able to solve a problem or remove an obstacle for my constituent so they can get a permit, meet a payroll, fix a pothole, you name it.

I also knew that the best way to win a vote or an election is to simply do the job I was elected to do. I'm very pleased at some of the legislation that I've been able to get passed into law. Public Act No. 77 of 2006—my ultrasound bill—which required abortion providers to make available for viewing the ultrasound image of the baby if the mother asks to see it. One moment I will always remember was when I received a phone call from Ed Rivet of Right to Life of Michigan who wanted me to know that one of their sidewalk counselors had informed a young woman of her right to see her ultrasound. She did, and made the decision—the choice—not to abort her child. We all work diligently here every day in the fervent hope and belief that our efforts will benefit the lives of our citizens, and I believe we do, but to know that you've saved a life, that there is someone out there living their life—I will never know his or her name—but that's the greatest satisfaction of all, knowing that I made a difference there.

Other issues that you're acquainted with: sales tax-on-the-difference, it seems I've kind of defined my time here in large measure. Very simply, nobody should be taxed twice for the same value. Again and again, a simple principle, it took a long time to get it done, but we got it done. I'm very pleased about that. Boxing and mixed martial arts. Honestly, this flowed from my love of the fight game that was passed on to me from my father. Mixed martial arts didn't exist then, I'm still a boxing guy more than MMA, but I support both sports and my goal was just to make the sport safe and better for the fighters and advance it in Michigan. Oh, and by the way, here's a teachable moment for all of you. The greatest fighter of all time is a fighter with Detroit ties. He was born Walker Smith, Jr., but he is better known to all of us as Sugar Ray Robinson—85-0 as an amateur, 200 fights, 173 wins, 108 by knockout, even the great Muhammad Ali said he was the best of all time. Case closed. Win a trivia contest on that little piece of information.

Horse racing. I got involved in this issue because of the number of stables in my district and because a dear friend of mine moved to Kentucky, fell in love with horses, and got me hooked on the sport. I'm very pleased about that.

The *Citizens United* codification. It's important to remember this. The United States Supreme Court, led by Anthony Kennedy, the moderate, rejected a regulatory model for political speech and issue advocacy and overturned a Michigan case in the process of doing so. We, I believe, as a state were duty-bound to place those protections for First Amendment rights in statute.

Individual legislation is important for me to be sure, but my view has always been that the most important work that we do, and the aspect of the job that I will remember most, is the conversations we've had in the caucus room. Why? Because for me the most important battle every day is the battle between two different governing philosophies that our political parties represent. I have spoken little from the floor, but my colleagues have no difficulty recognizing the sound

of my voice in the caucus room. Maybe when I call caucus they don't recognize my voice, but in the caucus room they have no difficulty recognizing. I let my vote do my talking for me in committee and on the Senate floor. To me, the "R"s and the "D"s always mean something because philosophy always matters.

Honestly, in my heart, I have always been an ideological or partisan kind of political warrior. I suppose if I am to be remembered for anything, I would hope it would be this: that I won some very tough elections under difficult conditions at critical times in our state's history. When I ran for office in 1990, we Genesee County Republicans had nothing. Nothing. No Representatives, no Senators, nothing. Genesee County Democrats—my good friends—had no conception of defeat. I was determined to reacquaint them with it. Honestly, I wanted to be nothing less than a wrecking ball through the Genesee County Democratic Party. I am an incumbent now, but I will always have the heart of a challenger. In our profession, incumbents rarely lose but I've been involved and beaten four incumbents in my time—twice as a campaign manager as I was making my bones in Macomb County for the late Doug Carl. The incumbents I beat were three Democrats and one Republican State Senator. I became the first Republican to represent Genesee County—along with Oakland County, I don't want to short them in any way—the first Republican to represent Genesee County in the Senate in 40 years.

As I leave office, I get great satisfaction out of the fact that my home county now has two Republican Senators, a Republican State Representative, two Republican county commissioners, and nearly the entire suburban ring of townships is represented by the G.O.P. The two-party system has been restored in my backyard.

A few comments about those I've served with and those I leave behind, and I could say wonderful things about each and every one of you. My history and memory does go back a generation. After all, I've served with Curtis Hertel the elder and Curtis Hertel the younger. Curtis, when you talk on the floor, I always listen. I always take note. I don't always agree, but I hear your voice and I hear your father's voice as well. Morris Hood the elder and the younger; two generations of Roccas, father and son; two generations of Posthumuses, father and daughter; Paul Hillegonds, Frank Fitzgerald, and Dominic Jacobetti. It's just an extraordinary opportunity for me to have served with these people who are such a big part of Michigan political history.

I have to say something about Randy Richardville. I've always referred to him as the Steve McQueen of the Senate. He's the Cincinnati Kid, Virgil Hiltz, and Frank Bullitt all rolled into one. He even bought the car—the same car—that was used in the famous chase scene in that movie. Never was there a man more suited for and at home in the spotlight. He's a truly dynamic individual and I'm honored to have served with him.

Arlan Meekhof, the perfect counterpoint to Randy stylistically. Cool, calm, professional, the model of quiet effectiveness. A greybeard literally and figuratively. Thank you, Arlan, for supporting me in my work and all of us in our chairmanship duties and for being a great leader.

Jack Brandenburg, my dearest friend. We've heard a lot about Jack in these farewell speeches over the last little while. The living, breathing personification of Macomb County politics. "Hey. How you doin'?" I'll say this and I mean this with great affection. He's the only guy I know who could have a campaign slogan, "Hey. I'm Jack Brandenburg. Vote for me or I'll kill ya." Actually, he comes off as a tough guy but he's really a gentle-hearted soul to be sure all the way. But we've been fighting for tax cuts our entire time together and we're going to do it right to the end, aren't we Jack? Then we'll ride off into the sunset together. He's much taller in the saddle than I am, but nevertheless we will.

Joe Hune, I'm going to miss that cackling laugh. He is the happiest man I have ever met and he is teaching me about being happy in life because he certainly is every day. I will miss him very, very much. Tory Rocca, I'm sorry he's not here. He's been my seatmate for eight years, he is his father's son, and no man has a better handle on his district. He's a soft-spoken political genius. Tom Casperson, my dear friend, I wear my honorary Yooper designation with pride. You have done so much good for our state and single-handedly reshaped the political landscape of the Upper Peninsula. You're a great friend.

Tonya, I love ya. That's as much as I'll say. Margaret, the best is yet to come for you, that's for sure. Patrick Colbeck, the good word, the greatest word, will always be John 3:16. Rebekah Warren, charming, delightful, and really, really smart. I always appreciated her genius. Jim Ananich, you're so amiable you make it hard to be a political adversary. You really are. I really appreciate you and your friendship and your demeanor.

I could go on and on and say wonderful things about each and every of you. But I'm also pleased to have had a hand in launching some other careers and I'm delighted at the people I leave behind. Steve Daunt, my brother-in-law, came in with me in 1991 and has made a 30-year career out of his service in this Legislature in the House. Terry Marquart and Fred Hall, who retired a few years ago, were bridges from my first term to my service years and years later. Pete Lund, another political veteran forged in the cauldron of Macomb County politics. Suzanne Miller Allen, who helped me so much when I needed it most. Randy Thompson, Michael Telliga, people who worked for me, Anthony Markwort. Ben Frederick who started with me as a lanky, 20-year-old. To finish my career with him as a colleague in the House of Representatives fills me with such pride and satisfaction. Ralph Fiebig, an indispensable man in the House staff, maybe you don't always see him very much but he's busy working. He's a computer genius, a number-cruncher, and has been doing great work for the Legislature for 20 years and I wanted to recognize him.

To my current Senate staff and past staff. April Alleman, my legislative aide who has performed so wonderfully for me for so many years. Now she's an attorney working for the daughter of the man who gave me my first political break in

Lansing. Life has truly come full circle. I'm going to say this. I've always paid her a compliment by saying that she looks just like the actress Ava Gardner. I'm going to say that on the record and you can put it in the Senate Journal. I always reference Hollywood movies and Hollywood actresses so I'm going to do that again. Jason, her husband, who came to my office after April left, his devotion to me and to my constituents, and to solving constituent issues, is so deeply appreciated. Steven Robb, the most recent member of my staff to join the Bar, he passed his bar exam recently. Watch for him, he's Michigan's answer to Jerry Maguire, sports agent extraordinaire. Kirsten DellaSantina, whose kindness and gentleness has been such a reassuring and helpful presence in my office.

As you know, I am a man of many passions, perhaps too many. And the legislative calendar perfectly fits my attention span for sure. I don't know whether ADD was a diagnosis when I was born, or when I was first elected, but it certainly describes my demeanor. The most difficult job anyone could have is taking my passions and turning them into words on the page. Erika Farley took those passions and turned them into Public Acts. I've tilted at a lot of windmills in my time; she bulldozed them for me. And I want to thank her for that.

"Now is the time for all good men to come to the aid of their party, to come to the aid of their country." We have all heard that phrase before. But there is one man who personified it like no other. When I gave my farewell address to the House of Representatives, he was sitting next to me on the House floor. Jon Farley is no longer with us, but we must keep his memory and spirit alive by recognizing legislative staff excellence with the award that bears his name.

In closing, I quote from classic films, and I don't want to disappoint Rebekah. There's a scene late in the movie *The Bridge on the River Kwai*, which won Best Picture, by the way, in 1957, and Sir Alec Guinness, in his Oscar-winning role as Colonel Nicholson, just before the climactic scene, is standing on the bridge looking into the sunset, and he says the following:

I've been thinking. Tomorrow it will be 28 years to the day that I've been in the service. 28 years in peace and war. I don't suppose I've been at home more than ten months in all that time. Still, it's been a good life. ... I wouldn't have had it any other way. But there are times when suddenly you realize you're nearer the end than the beginning. And you wonder, you ask yourself, what the sum total of your life represents, what difference your being there at any time made to anything, or if it made any difference at all really. Particularly in comparison with other men's careers. I don't know whether that kind of thinking is very healthy, but I must admit I've had some thoughts on those lines from time to time.

I must tell you that as the end of my career has approached, I've had moments of reflection, I've thought a little bit like Colonel Nicholson, but that particular scene struck me because it has been 28 years since I was first elected to a seat in this Legislature. Twenty-eight years in political peace and political war. I must confess, like I say, Colonel Nicholson's comments resonate with me, but then my spirits are lifted by another scene from another movie, the Frank Capra classic *It's A Wonderful Life* when Clarence, the guardian angel, explains to George Bailey that every man's life, if it were left out, it leaves a pretty big hole. I'll leave others to decide how big of a hole my absence might have made, but the last message of the movie is the most important one, when he says, "Remember, no man is a failure who has friends."

I am so appreciative to have you all as friends, and to call you friends. God bless you all, God bless the state of Michigan, and God bless America.

Senator Kowall moved that rule 3.204 be suspended to name the entire membership of the Senate and the Lieutenant Governor as co-sponsors of the resolution.

The motion prevailed, a majority of the members serving voting therefor.

Senator Proos asked and was granted unanimous consent to make a statement and moved that the statement be printed in the Journal.

The motion prevailed.

Senator Proos' statement is as follows:

I rise today with a grateful heart and truly a thankful spirit that I've had the opportunity to serve the citizens of the 21st District in Michigan's great southwest. In my first term, I was blessed to serve Berrien, Cass, and Van Buren Counties, sharing a portion with the President pro tempore; and then in my second term, in Berrien, Cass, and St. Joseph Counties. I'm continually amazed by the resilience, ingenuity, and faithfulness of the people of this region and what they exhibit every day in their hard work. From a Southwest Michigan common sense perspective to that work ethic that really is second to none. We have our challenges and we have our concerns, no question, but we meet those challenges with a nose-to-the-grindstone attitude of intensity and of an interest in success. I'm a proud product of the Southwest Michigan region, a very diverse region with so many proud communities—proud communities that have trusted me to serve as their voice for some 14 years now here at the Capitol.

As my colleagues have stated so well in their farewell addresses in these past few weeks, we could not possibly do this job without the hundreds of people who support the Legislature and the Michigan Senate in particular. Our role in state government has so many people who give us the opportunity to serve. Chief Sergeant Mike Ferland and your crew, dedicated security, quiet in their work, but interested in one thing and one thing only—that the people's business be done and be done safely, and that we return home to our families. My family sits behind me right now, and I will mention them shortly, but I've made it home every night—in spite of I-94 and I-69. My 12-year-old asked recently, "How many times did you travel back and forth to the Capitol?" And I had to count it up. I think its somewhere in the 1,100 range of that 4-hour round trip.

To the clerks, Secretary Jeff Cobb, Keith Barber at Corrections Ombudsman, the Legislative Service Bureau, the facilities staff—whom by the way, are a key part that we never see. Also happens that one of those very key individuals is the father of my scheduler and office manager, Leanna Schafer, a newly minted Spartan in just a couple of days. Thank you to all who help to make this work. Thank you to Matt VanAcker, your staff here at the Capitol make this historic building shine on a day-to-day basis in ways that we could never know. The granger of this great building has been talked about by many during their farewell addressees, but it is truly an amazing office place, the people's office building.

Thank you to the Senate Fiscal Agency for the many years of work, specifically, in complicated budgets that I had the opportunity to serve. John Maxwell, Ryan Bergan, Abbey Frazier, Michael Siracuse, just to name a few. We are supported by truly amazing people on the budget process and in so many other ways. A hardy and heartfelt thank you to all of the Legislative Service Bureau staff and the staff of the Majority Policy Office, you guys are amazing talents who do the people's business and give us the opportunity to know best what is happening in the legislation that is presented before us. The communications team, you folks do amazing work also. Bill Ivan, Adam Bitely, and Katherine Japinga, you guys are absolutely incredible, top-notch, and so very much appreciated. That's how we're able to communicate to the people who we serve at home.

To the members of the advocacy and lobby community, as well as the media, I say "thank you." I had the opportunity, just this last week, one of the members of the media met with the students who I had visit me at the Capitol and she so eloquently said, "We hold you accountable." And you know what, I felt completely alright with that, because it's true. That's a part of the fourth institution and how important it is. In an era of term limits, we know that institutional memory is fleeting. Members of the advocacy and lobby community are a critical part of that, as are the staff who will remain. That helps to make a difference in the lives of Michiganders.

Now to the people who have helped me serve, the people of the 21st District. You know as well as I do, members, you can't do it without a wonderful team of people. Folks by the names of Laurie Nevin, Bob Wolfe or Ina Mazoine, Danielle Beck, and Leanna Schafer—whom I mentioned already. Go Green—Kim Wadaga, Jonathan Keller, Trenton Miller, and a host of interns who were dedicated to addressing the citizen's needs in Southwest Michigan.

Specifically, though, I need to recognize Adam Mensinger, my district representative who took the job very seriously and recognized that the only way that we could successfully serve was to ensure that all politics remained local. He was my eyes and ears on the ground and followed that to a "T." He now serves as my chief of staff. Thank you, Adam.

In our term-limited environment we lose amazing people early. I don't need to tell you how difficult it is, as Senator Nofs mentioned recently. While Carmen has done a wonderful job, Greg moved on. She wouldn't let me do it, but Rebecca O'Connell joins me today in the Gallery because she refused to ever be recognized on the floor. That's the way Becky does her work. She served as my chief of staff for all eight years here. I had the pleasure of hiring her into Congressman Fred Upton's office—my mentor and friend who trusted me to find good talent to serve the people of Southwest

Michigan—and when Becky joined me, I wouldn't have known at that time that it would be nearly 16 years of working together. As many of you know, we become very close with our staff because these are not easy jobs. This takes away nothing away from those who have incredibly dangerous and difficult jobs, but for those of us in this arena, we need good people. Becky has not only been my eyes and ears, but she has been a trusted friend, a trusted confidante, and someone who kept my best interest at heart. Knowing that if I was in a good place, a good position, I could best serve the people of Southwest Michigan, we never lost sight of that. I can't thank you enough for being such a great friend and supporting me and my family in such an amazing way. I'll forever be indebted to you and Brian and your family. Your three girls are very special, as are you.

To my colleagues, thank you. I've learned so much from each and every one of you. One man could not possibly explain it all. I only have a few moments to say a few words about a couple of people. Senator Nofs, thank you for teaching me how to lead, how to listen, and that listening was far more important than leading. The solutions are there but they are there because others take interest in them, take ownership in them, and sometimes it takes four hour committee meetings every single week of 2016. In fact, sometimes they're so long that Senator Coleman Young has time to hammer through five Red Bulls, three bags of flaming Hot Cheetos, and wash it down with a bunch of Starbursts. Senator Young, it was an impressive effort. That was in three hours of a four-hour meeting.

Senator Schuitmaker, thank you for helping me to understand a very important lesson in life: That in forgiveness we find peace. Senator Brandenburg, thank you for recognizing my colorful socks. I don't know what happened in our first couple of weeks in the Senate. We had served together in the House, but you stormed on to the floor—Chief Sergeant Ferland will remember this—you stormed onto the floor as if I had completely turned your life upside down. You were hotter than a fire-cracker, I have no idea what I did or said, but you were convinced it was me. So all 6'6" of his frame came over the top of my desk—over there where Senator Shirkey's desk is—and he towered over me. Well I brought my 6'3" frame up as close as I could to your nose and I said, "I have no idea what you're talking about Senator." That was about the time I noticed that Chief Sergeant Ferland was a good three feet from us at that point. Literally, to this day, I don't know what you thought I did. But I have to tell you—this is the beauty of it—you taught me something very important Senator Brandenburg: It is absolutely not wrong to say you're sorry. You came up to me about two hours after that—you may not even remember this—you came up to me about two hours after that and you hovered over my desk—all 6'6" of you, 245 I understand, not 300—and I was like there is no way this is going to happen again, and I'm sure Chief Sergeant Ferland saw this. I stood right up and went right nose to nose with you because I'm not going to let him hover over me. "Hey Proos, I was wrong, I'm sorry. Eh, I like your socks." I got to tell you, it was in that moment that the Senate began to make sense as to why this is all so important.

Senator Warren, thank you for helping me to pass the resolution about criminal justice reform and so many other things, but the one that stands out is Erin's Law. I could not have done it without your support, your effort, your time, and your trust. If there is anything that I can leave with this body it's the idea of trust. The more trust we build in this chamber, the more opportunity we have for trust to be built in our communities. That's what seems to be missing these days folks. I wish that more of our constituents understood that Senator Warren and Senator Proos consistently sit on opposite sides of the aisle but have so much respect for each other, as I do for you Senator Warren. I could not have passed Erin's Law addressing child sex abuse, and allowing the survivors of child sex abuse to have a voice, without you. Thank you. As you noted, my wife, Kristy, stands ready to write that episode of "You Can Not Make This Up" the first episode of "The Legislature."

Senator Meekhof, thank you for your trust and for being a man of honor. You've led this institution with honor and integrity. You've given us leave to do what we think is best and to try and make a difference in the lives of so many countless others, thank you.

Senator Ananich, my fellow Senate Fellowship Chairman—I spoke of trust earlier—you cannot possibly gather together once a month, closing the door, setting aside partisan differences, and sharing each other's story. It's your story, it's our story, it's the story we shared together. That helped to build trust in ways that I can't even begin to fathom, and I hope that it continues in the next term. Building that trust, in fellowship together, with that door closed and partisan labels aside, gives the chance for this institution to run so very well. It will make Michigan strong.

And then, finally, Senator Pavlov, my friend. Your amazing and unique perspective on life is one that kept me in stitches virtually every day that we were in the Legislature together for 14 years. I'll be forever grateful for you, and those who joined me in my grief as my father suddenly passed almost five years ago: Senators Brandenburg, Caswell, Schuitmaker, and Pavlov, all took time to come to visit St. Joseph, Michigan and to pay their respects to my father. Phil, I'll never forget, in my Catholic church, right after communion, there's a time for prayer and taking into account that in fact, you've participated in the Eucharist of Christ. I was fairly well in a bad place, to be honest. In that grief, right up at the front of church, right next to my father's casket, with my family, I simply had my hands folded, my head down, and tears in my eyes, as it had been for days at that point. You received communion and touched my hand as you walked by. That was a lifeline, a buoy, that I couldn't possibly understand. Thank you. Thank you for that one touch.

Members, nearly half my adult life has been spent with you all right here. As amazing as that may sound, we've walked these halls together, we are better and more enriched for having served together, and we have fulfilled the hopes and dreams of so many. Sometimes we failed to get across the line what we thought was so important, but what I have found

as I've reminisced, is that in fact, what's most important is each and every one of us as human beings, and as people in this chamber. I understand a little bit more what my mom and dad were trying to teach me. I get it now, in these days and years, why my father cared so very much about the patients who he served, and why my father cared so much about the community that he lived in. You all taught me the importance of that human touch. Caring more than was reasonable, loving more than seemed possible.

And last but not least, my wife, Kristy, for recognizing that my service was sincere, and my desire to make a difference was necessary in the deepest parts of my heart. My interest in positive outcomes for the people I served really was the reason I served. Your unconditional love, your advice and your support, in this very public position that you didn't ask for—I did—can never properly be recognized other than to say thank you and that I love you.

Elena, Jack, and Nora, my children. I hope that with these years of service, that you know how very much I love you, and how very much I am proud to call you my children, number one. But just as importantly, I hope that you have seen the kind of lessons that my mom and dad taught me: That community matters, that the human touch matters. If you've caught any of this along the way, the members will be in good hands in the future.

Senators and staff and those assembled here today, in my Catholic and Jesuit training from Marquette University, I learned a very important phrase that will sum up how I feel today: We're compelled to act *in Cura Personalis*. Care for the whole person. Another way to characterize this moral imperative is to love one another. Love is not simply as an emotion, but love is defined by St. Thomas Aquinas: "Willing the good of the other as other." I pray that I have, while certainly imperfect, strived each day to care for the whole person, and to seek the will and the good of the other. To seek the good of each of you, and your constituents, and to seek the good of the people who I serve. This active and intentional effort has been my single objective while working in the Senate and while working in this great institution with each and every one of you. I pray that this body will continue to serve in the future, remembering the importance of caring for the whole person, and at the heart of this noble endeavor, remains love.

Thank you all for the chance to reminisce today, and for the amazing chance to serve the people of Southwest Michigan. Thank you, each of you, and may God bless the state of Michigan and continue to bless the United States of America.
