

**SUBSTITUTE FOR  
HOUSE BILL NO. 5259**

A bill to amend 2016 PA 345, entitled  
"Limousine, taxicab, and transportation network company act,"  
by amending section 11 (MCL 257.2111).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 11. **(1) A—SUBJECT TO SUBSECTION (2), A** vehicle subject to  
2 this act shall display a consistent and distinctive signage or  
3 emblem ~~that is approved by the department~~ at all times while the  
4 vehicle is being used to provide transportation services or while  
5 the vehicle is being used by a transportation network company  
6 driver for a transportation network company prearranged ride or  
7 while the transportation network company driver is available to  
8 receive a transportation request. **SUBJECT TO SUBSECTION (2), A**  
9 **VEHICLE SUBJECT TO THIS ACT MAY ALSO DISPLAY A DEPARTMENT OF**  
10 **LICENSING AND REGULATORY AFFAIRS REGISTRATION NUMBER.** The signage,

1 ~~or~~-emblem, OR DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS  
2 REGISTRATION NUMBER shall satisfy ~~all~~-BOTH of the following:

3 (a) The signage, ~~or~~-emblem, OR DEPARTMENT OF LICENSING AND  
4 REGULATORY AFFAIRS REGISTRATION NUMBER shall be ~~sufficiently large~~  
5 ~~and color-contrasted~~ to be ~~readable~~-VISIBLE during daylight hours  
6 from a distance of at least 50 feet.

7 ~~— (b) The signage or emblem shall be reflective.~~

8 (B) ~~(c)~~-The signage, ~~or~~-emblem, OR DEPARTMENT OF LICENSING AND  
9 REGULATORY AFFAIRS REGISTRATION NUMBER shall sufficiently identify  
10 the limousine carrier, taxicab carrier, ~~or~~-transportation network  
11 company, OR DISPATCH SYSTEM PROVIDER with which the vehicle is  
12 affiliated.

13 (2) IF A LIMOUSINE CARRIER, TAXICAB CARRIER, OR TRANSPORTATION  
14 NETWORK COMPANY IS PROVIDING SERVICES IN ASSOCIATION WITH A  
15 DISPATCH SYSTEM PROVIDER, THE LIMOUSINE CARRIER, TAXICAB CARRIER,  
16 OR TRANSPORTATION NETWORK COMPANY SHALL DISPLAY ITS SIGNAGE OR  
17 EMBLEM OR THE SIGNAGE OR EMBLEM OF THE DISPATCH SYSTEM PROVIDER. IF  
18 A LIMOUSINE CARRIER, TAXICAB CARRIER, OR TRANSPORTATION NETWORK  
19 COMPANY DISPLAYS THE SIGNAGE OR EMBLEM OF A DISPATCH SYSTEM  
20 PROVIDER AS PROVIDED IN THIS SUBSECTION, IT SHALL ALSO DISPLAY ITS  
21 DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS REGISTRATION NUMBER.

22 (3) IF A LIMOUSINE CARRIER, TAXICAB CARRIER, OR TRANSPORTATION  
23 NETWORK COMPANY DISPLAYS A DEPARTMENT OF LICENSING AND REGULATORY  
24 AFFAIRS REGISTRATION NUMBER, THE 10-DIGIT REGISTRATION NUMBER SHALL  
25 BE DISPLAYED WITH THE "#" SYMBOL PRIOR TO THE REGISTRATION NUMBER  
26 AND SHALL USE NUMBERS AND SYMBOLS THAT ARE AT LEAST 1-1/2 INCHES IN  
27 HEIGHT.

1           Enacting section 1. This amendatory act takes effect 90 days  
2 after the date it is enacted into law.
