

**SENATE SUBSTITUTE FOR  
HOUSE BILL NO. 5200**

A bill to amend 1994 PA 451, entitled  
"Natural resources and environmental protection act,"  
by amending sections 1301, 48705, and 48710 (MCL 324.1301,  
324.48705, and 324.48710), section 1301 as amended by 2014 PA 215  
and sections 48705 and 48710 as added by 1995 PA 57.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 1301. As used in this part:

2           (a) "Application period" means the period beginning when an  
3 application for a permit is received by the state and ending when  
4 the application is considered to be administratively complete under  
5 section 1305 and any applicable fee has been paid.

6           (b) "Department" means the department, agency, or officer  
7 authorized by this act to approve or deny an application for a  
8 particular permit.

1 (c) "Director" means the director of the state department  
2 authorized under this act to approve or deny an application for a  
3 particular permit or the director's designee.

4 (d) "Permit" means a permit or operating license required by  
5 any of the following sections or by rules promulgated thereunder,  
6 or, in the case of section 9112, by an ordinance adopted  
7 thereunder:

8 (i) Section 3104, floodplain alteration permit.

9 (ii) Section 3503, permit for use of water in mining iron ore.

10 (iii) Section 4105, sewerage system construction permit.

11 (iv) Section 6516, vehicle testing license.

12 (v) Section 6521, motor vehicle fleet testing permit.

13 (vi) Section 8310, restricted use pesticide dealer license.

14 (vii) Section 8310a, agricultural pesticide dealer license.

15 (viii) Section 8504, license to manufacture or distribute  
16 fertilizer.

17 (ix) Section 9112, local soil erosion and sedimentation  
18 control permit.

19 (x) Section 11509, solid waste disposal area construction  
20 permit.

21 (xi) Section 11512, solid waste disposal area operating  
22 license.

23 (xii) Section 11542, municipal solid waste incinerator ash  
24 landfill operating license amendment.

25 (xiii) Section 11702, septage waste servicing license or  
26 septage waste vehicle license.

27 (xiv) Section 11709, septage waste site permit.

1 (xv) Section 30104, inland lakes and streams project permit.

2 (xvi) Section 30304, state permit for dredging, filling, or  
3 other activity in wetland. Permit includes an authorization for a  
4 specific project to proceed under a general permit issued under  
5 section 30312.

6 (xvii) Section 31509, dam construction, repair, or removal  
7 permit.

8 (xviii) Section 32312, flood risk, high risk, or environmental  
9 area permit.

10 (xix) Section 32512, permit for dredging and filling  
11 bottomland.

12 (xx) Section 32603, permit for submerged log removal from  
13 Great Lakes bottomlands.

14 (xxi) Section 35304, department permit for critical dune area  
15 use.

16 (xxii) Section 36505, endangered species permit.

17 (xxiii) Section 41702, game bird hunting preserve license.

18 (xxiv) Section 42101, dog training area permit.

19 (xxv) Section 42501, fur dealer's license.

20 (xxvi) Section 42702, game dealer's license.

21 (xxvii) Section 44513, charter boat operating permit under  
22 reciprocal agreement.

23 (xxviii) Section 44516, boat livery operating permit.

12 Michigan Trail.

13 ~~(xxxviii)~~ ~~(xxxviii)~~—Section 76109, sunken aircraft or  
14 watercraft abandoned property recovery permit.

15 ~~(xxxix)~~ ~~(xxxix)~~—Section 76504, Mackinac Island motor vehicle  
16 and land use permits.

17 ~~(xxxx)~~ ~~(xxxx)~~—Section 80159, buoy or beacon permit.

18 (e) "Processing deadline" means the last day of the processing  
19 period.

20 (f) "Processing period" means the following time period after  
21 the close of the application period, for the following permit, as  
22 applicable:

23 (i) Twenty days for a permit under section 61525 or 62509.

24 (ii) Thirty days for a permit under section 9112 or 44516.

25 (iii) Thirty days after the department consults with the  
26 underwater salvage and preserve committee created under section  
27 76103, for a permit under section 76109.

1           (iv) Sixty days, for a permit under section 30104 for a minor  
2 project established under section 30105(7) or 32512a(1), or an  
3 authorization for a specific project to proceed under a general  
4 permit issued under section 30105(8) or 32512a(2), or for a permit  
5 under section 32312.

6           (v) Sixty days or, if a hearing is held, 90 days for a permit  
7 under section 35304.

8           (vi) Sixty days or, if a hearing is held, 120 days for a  
9 permit under section 30104, other than a permit or authorization  
10 described in subparagraph (ii) or (iv), or for a permit under  
11 section 31509.

12           (vii) Ninety days for a permit under section 11512, a revision  
13 of a surface coal mining and reclamation permit under section  
14 63525, or a permit under section 72108.

15           (viii) Ninety days or, if a hearing is held, 150 days for a  
16 permit under section 3104 or 30304, or a permit under section 32512  
17 other than a permit described in subparagraph (iv).

18           (ix) Ninety days after the close of the review or comment  
19 period under section 32604, or if a public hearing is held, 90 days  
20 after the date of the public hearing for a permit under section  
21 32603.

22           (x) One hundred twenty days for a permit under section 11509,  
23 11542, 63103a, 63514, or 63704.

24           (xi) One hundred fifty days for a permit under section 36505.  
25 However, if a site inspection or federal approval is required, the  
26 150-day period is tolled pending completion of the inspection or  
27 receipt of the federal approval.

1           (xii) For any other permit, 150 days or, if a hearing is held,  
2 90 days after the hearing, whichever is later.

3           Sec. 48705. (1) Reptiles, amphibians, mollusks, and  
4 crustaceans may only be taken in a manner and during those times  
5 prescribed by the ~~department. Persons~~ **COMMISSION. AN INDIVIDUAL**  
6 taking, trapping, catching, or fishing for ~~turtles or frogs~~  
7 **REPTILES, AMPHIBIANS, MOLLUSKS, OR CRUSTACEANS** for their personal  
8 use shall have a valid fishing license issued ~~pursuant~~ **UNDER** part  
9 435.

10           (2) ~~A person~~ **AN INDIVIDUAL** shall not take, trap, catch, or  
11 fish for reptiles or amphibians for commercial purposes. ~~unless he~~  
12 ~~or she purchases an annual commercial reptile and amphibian license~~  
13 ~~for a fee of \$150.00.~~

14           (3) **THE DEPARTMENT MAY, PURSUANT TO PART 13, ISSUE PERMITS TO**  
15 **TAKE AMPHIBIANS AND REPTILES AT ANY SEASON OF THE YEAR FOR**  
16 **SCIENTIFIC OR EDUCATIONAL PURPOSES. THE DEPARTMENT MAY REVOKE A**  
17 **PERMIT ISSUED UNDER THIS SUBSECTION.**

18           Sec. 48710. ~~(1)~~ This part does not prohibit the use of a gaff,  
19 except on or along trout streams, or a landing net to assist in  
20 landing fish already caught by a lawful device. This part does not  
21 apply to a person engaged in the business of propagating fish under  
22 part 459 or to fish caught by a device for which a lawful permit or  
23 license is obtained from the department under this part.

24 ~~—— (2) A person shall not use or possess a landing net more than~~  
25 ~~5 1/2 feet in circumference or with a handle exceeding 14 inches in~~  
26 ~~length on a trout stream during the months of April, May, and June.~~

27           Enacting section 1. This amendatory act does not take effect
