

**SUBSTITUTE FOR
HOUSE BILL NO. 6081**

A bill to amend 1885 PA 152, entitled

"An act to authorize the establishment of facilities for former members of the armed forces of the United States in the state of Michigan; to create funds; and to provide for the promulgation of rules,"

by amending section 10 (MCL 36.10), as added by 2016 PA 562.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 10. (1) The board of managers may enter into contracts
2 with ~~an~~**THE** authority under the Michigan veterans' facility
3 authority act, **2016 PA 560, MCL 36.101 TO 36.112**, to do ~~1 or more~~
4 **ANY** of the following:

5 (a) Lease, sell, or otherwise convey property to that
6 authority for the development of a veterans' facility. ~~as that term~~
7 ~~is defined in the Michigan veterans' facility authority act.~~

8 (b) ~~Any other agreement regarding~~**PROVIDE FOR** the care or
9 housing of veterans in a ~~Michigan~~veterans' facility.

1 (2) The board of managers shall provide staffing to ~~any~~ **THE**
2 authority ~~operated~~ under the Michigan veterans' facility authority
3 act, **2016 PA 560, MCL 36.101 TO 36.112**, that is sufficient to
4 provide for the care, housing of veterans, and operations of any
5 veterans' facility. ~~as that term is defined in the Michigan~~
6 ~~veterans' facility authority act.~~

7 **(3) THE BOARD OF MANAGERS SHALL CONDUCT SAMPLING, ANALYSIS,**
8 **AND REMEDIATION OF LEAD CONTAMINATION IN DRINKING WATER FROM**
9 **DRINKING WATER TAPS AND OTHER SOURCES OF DRINKING WATER USED FOR**
10 **HUMAN CONSUMPTION AT EACH VETERANS' FACILITY UNDER ITS SUPERVISION**
11 **IN THE SAME MANNER AS IS REQUIRED FOR ADULT FOSTER CARE FACILITIES,**
12 **CHILD CARE CENTERS, HOSPITALS, NURSING HOMES, AND SCHOOLS UNDER**
13 **SECTION 7A OF THE SAFE DRINKING WATER ACT, 1976 PA 399, MCL**
14 **325.1007A.**

15 **(4) AS USED IN THIS SECTION, "VETERANS' FACILITY" MEANS THAT**
16 **TERM AS DEFINED IN SECTION 2 OF THE MICHIGAN VETERANS' FACILITY**
17 **AUTHORITY ACT, 2016 PA 560, MCL 36.102.**

18 Enacting section 1. This amendatory act does not take effect
19 unless House Bill No. 4124 of the 99th Legislature is enacted into
20 law.
