

**SENATE SUBSTITUTE FOR
HOUSE BILL NO. 6475**

A bill to amend 1986 PA 182, entitled "State police retirement act of 1986," by amending sections 3, 4, 11, 12, 14, 14a, 15, 23, 24, 25, 26, 27, 28, 32, 33, 34, and 42 (MCL 38.1603, 38.1604, 38.1611, 38.1612, 38.1614, 38.1614a, 38.1615, 38.1623, 38.1624, 38.1625, 38.1626, 38.1627, 38.1628, 38.1632, 38.1633, 38.1634, and 38.1642), section 3 as amended by 2010 PA 220, section 4 as amended by 2004 PA 83, sections 14 and 42 as amended by 2004 PA 50, section 14a as amended by 2008 PA 366, and sections 25 and 26 as amended by 2000 PA 374, and by adding sections 15a, 24b, 42a, 42b, 60, 61, 62, 63, 64, 65, 66, 67, 68, 69, 70, 72, 73, and 74.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3. (1) "Banked leave time program" means the part B
2 annual leave hours within the state's annual and sick leave program
3 approved by a ruling of the ~~internal revenue service~~ **INTERNAL**
4 **REVENUE SERVICE** on September 5, 2003, in which a pay reduction or
5 other concessions are applied to a member in exchange for
6 additional part B annual leave hours.

7 (2) "Credited service" means the sum of the prior service and
8 membership service credited to a member's account.

9 (3) "Deferred member" means a member who separates from
10 service with entitlement to a deferred retirement allowance as
11 provided in section 30, but who is not a retirant.

12 (4) "Department" means the department of **TECHNOLOGY**,
13 management, and budget.

14 (5) "Direct rollover" means a payment by the retirement system
15 to the eligible retirement plan specified by the distributee.

16 (6) "Distributee" includes a member or deferred member.
17 Distributee also includes the member's or deferred member's
18 surviving spouse or the member's or deferred member's spouse or
19 former spouse under an eligible domestic relations order, with
20 regard to the interest of the spouse or former spouse.

21 (7) "DROP participant" means an officer who participates in
22 the deferred retirement option plan established in section 24a.

23 (8) Beginning January 1, 2002, except as otherwise provided in
24 this subsection, "eligible retirement plan" means 1 or more of the
25 following:

26 (a) An individual retirement account described in section
27 408(a) of the internal revenue code, 26 USC 408.

1 (b) An individual retirement annuity described in section
2 408(b) of the internal revenue code, 26 USC 408.

3 (c) An annuity plan described in section 403(a) of the
4 internal revenue code, 26 USC 403.

5 (d) A qualified trust described in section 401(a) of the
6 internal revenue code, 26 USC 401.

7 (e) An annuity contract described in section 403(b) of the
8 internal revenue code, 26 USC 403.

9 (f) An eligible plan under section 457(b) of the internal
10 revenue code, 26 USC 457, ~~which~~**THAT** is maintained by a state,
11 political subdivision of a state, or an agency or instrumentality
12 of a state or political subdivision of a state and ~~which~~**THAT**
13 agrees to separately account for amounts transferred into the
14 eligible plan under section 457(b) of the internal revenue code, 26
15 USC 457, from this retirement system, that accepts the
16 distributee's eligible rollover distribution.

17 (g) Beginning January 1, 2008, a Roth individual retirement
18 account as described in section 408A of the internal revenue code,
19 26 USC 408A, subject to the rules that apply to rollovers from a
20 traditional individual retirement account to a Roth individual
21 retirement account.

22 (9) Beginning January 1, 2007, "eligible rollover
23 distribution" means a distribution of all or any portion of the
24 balance to the credit of the distributee. Eligible rollover
25 distribution does not include any of the following:

26 (a) A distribution made for the life or life expectancy of the
27 distributee or the joint lives or joint life expectancies of the

1 distributee and the distributee's designated beneficiary.

2 (b) A distribution for a specified period of 10 years or more.

3 (c) A distribution to the extent that the distribution is
4 required under section 401(a)(9) of the internal revenue code, 26
5 USC 401.

6 (d) The portion of any distribution that is not includable in
7 federal gross income, except to the extent ~~such~~ **THE** portion of the
8 distribution is paid to either of the following:

9 (i) An individual retirement account or annuity described in
10 section 408(a) or 408(b) of the internal revenue code, 26 USC 408.

11 (ii) A qualified plan described in section 401(a) of the
12 internal revenue code, 26 USC 401, or an annuity contract described
13 in section 403(b) of the internal revenue code, 26 USC 403, and the
14 plan providers agree to separately account for the amounts paid,
15 including any portion of the distribution that is includable in
16 federal gross income, and the portion of the distribution ~~which~~
17 **THAT** is not so includable.

18 (10) "Final average compensation" means, **EXCEPT AS OTHERWISE**
19 **PROVIDED IN THIS SUBSECTION**, the average annual salary for the last
20 2 years of service with the department of state police for which
21 the member was compensated as defined in subsection (13). ~~In the~~
22 ~~case of~~ **EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION, FOR** a
23 nonclassified member of the department holding the rank of colonel,
24 final average compensation means the same average annual salary as
25 that computed for the highest salaried classified member of the
26 department, or at the average annual salary for the last 2 years of
27 service with the department of state police for which the member

1 was compensated, whichever is greater. BEGINNING WITH THE EFFECTIVE
2 DATE OF THE AMENDATORY ACT THAT ADDED SECTION 42A, FOR A MEMBER WHO
3 FIRST BECAME A MEMBER ON OR AFTER JUNE 10, 2012, FINAL AVERAGE
4 COMPENSATION MEANS THE AVERAGE SALARY FOR THE LAST 5 YEARS OF
5 SERVICE FOR WHICH THE MEMBER WAS COMPENSATED AS DEFINED IN
6 SUBSECTION (14). Average annual salary includes only the following
7 compensation items:

8 (A) BEGINNING WITH THE EFFECTIVE DATE OF THE AMENDATORY ACT
9 THAT ADDED SECTION 42A, FOR A MEMBER WHO FIRST BECAME A MEMBER
10 BEFORE JUNE 10, 2012, ONLY THE FOLLOWING COMPENSATION ITEMS:

11 (i) ~~(a)~~—Regular salary paid for the last 2 years of service,
12 including, but not limited to, that salary that is deferred
13 pursuant to a state deferred compensation program.

14 (ii) ~~(b)~~—Overtime, shift differential, and shift differential
15 overtime paid for the last 2 years of service.

16 (iii) ~~(c)~~—Gross pay adjustments paid affecting the last 2
17 years of service, including compensatory time and emergency
18 response compensation.

19 (iv) ~~(d)~~—Up to a maximum of 240 hours of accumulated annual
20 leave, paid at the time of retirement separation excluding part B
21 annual leave hours paid at the time of retirement separation.

22 (v) ~~(e)~~—Deferred hours under Plan B of the fiscal years ending
23 September 30, 1981, and September 30, 1982, that are paid at the
24 time of retirement separation.

25 (vi) ~~(f)~~—Longevity pay equal to 2 full years.

26 (vii) ~~(g)~~—Bomb squad pay paid for the last 2 years of service.

27 (viii) ~~(h)~~—Post 29 freeway premium paid for the last 2 years

1 of service.

2 (ix) ~~(i)~~—On-call pay paid for the last 2 years of service.

3 (x) ~~(j)~~—Beginning October 1, 2003, the value of any unpaid
4 furlough hours or the value of any unpaid hours exchanged for part
5 B annual leave hours, calculated at the member's then-current
6 hourly rate or rates of pay, for a period during which a member is
7 participating in the banked leave time program.

8 (xi) ~~(k)~~—Beginning May 1, 2009, the value of temporary layoff
9 hours. As used in this ~~subdivision~~, **SUBPARAGRAPH**, "temporary layoff
10 hours" means hours attributable to the layoff of a member if the
11 layoff does not exceed 1 month and has a fixed, predetermined, and
12 announced recall date.

13 (B) BEGINNING WITH THE EFFECTIVE DATE OF THE AMENDATORY ACT
14 THAT ADDED SECTION 42A, FOR A MEMBER WHO FIRST BECAME A MEMBER ON
15 OR AFTER JUNE 10, 2012, ONLY THE FOLLOWING COMPENSATION ITEMS:

16 (i) REGULAR SALARY PAID FOR THE LAST 5 YEARS OF SERVICE,
17 INCLUDING, BUT NOT LIMITED TO, THAT SALARY THAT IS DEFERRED
18 PURSUANT TO A STATE DEFERRED COMPENSATION PROGRAM.

19 (ii) SHIFT DIFFERENTIAL.

20 (iii) GROSS PAY ADJUSTMENTS PAID AFFECTING THE LAST 5 YEARS OF
21 SERVICE, INCLUDING COMPENSATORY TIME AND EMERGENCY RESPONSE
22 COMPENSATION.

23 (iv) UP TO A MAXIMUM OF 240 HOURS OF ACCUMULATED ANNUAL LEAVE,
24 PAID AT THE TIME OF RETIREMENT SEPARATION EXCLUDING PART B ANNUAL
25 LEAVE HOURS PAID AT THE TIME OF RETIREMENT SEPARATION.

26 (v) LONGEVITY PAY EQUAL TO 5 FULL YEARS.

27 (vi) BOMB SQUAD PAY PAID FOR THE LAST 5 YEARS OF SERVICE.

1 (vii) POST 29 FREEWAY PREMIUM PAID FOR THE LAST 5 YEARS OF
2 SERVICE.

3 (viii) ON-CALL PAY PAID FOR THE LAST 5 YEARS OF SERVICE.

4 (ix) THE VALUE OF ANY UNPAID FURLOUGH HOURS OR THE VALUE OF
5 ANY UNPAID HOURS EXCHANGED FOR PART B ANNUAL LEAVE HOURS,
6 CALCULATED AT THE MEMBER'S THEN-CURRENT HOURLY RATE OR RATES OF
7 PAY, FOR A PERIOD DURING WHICH A MEMBER IS PARTICIPATING IN THE
8 BANKED LEAVE TIME PROGRAM.

9 (x) THE VALUE OF TEMPORARY LAYOFF HOURS. AS USED IN THIS
10 SUBPARAGRAPH, "TEMPORARY LAYOFF HOURS" MEANS HOURS ATTRIBUTABLE TO
11 THE LAYOFF OF A MEMBER IF THE LAYOFF DOES NOT EXCEED 1 MONTH AND
12 HAS A FIXED, PREDETERMINED, AND ANNOUNCED RECALL DATE.

13 (11) "Furlough hours" means unworked hours incurred in
14 conjunction with the banked leave time program.

15 (12) "Internal revenue code" means the United States internal
16 revenue code of 1986.

17 (13) "Last 2 years of service" means the 2-year period
18 immediately preceding the member's last day of service or that
19 period of 2 consecutive years of service with the department of
20 state police immediately preceding the date the duty disability
21 occurred according to the medical examinations conducted pursuant
22 ~~to~~ UNDER section 29 or, if the officer participated in the deferred
23 retirement option plan, the 2-year period immediately preceding
24 participation in the deferred retirement option plan.

25 (14) "LAST 5 YEARS OF SERVICE" MEANS THE 5-YEAR PERIOD
26 IMMEDIATELY PRECEDING THE MEMBER'S LAST DAY OF SERVICE OR THAT
27 PERIOD OF 5 CONSECUTIVE YEARS OF SERVICE WITH THE DEPARTMENT OF

1 STATE POLICE IMMEDIATELY PRECEDING THE DATE THE DUTY DISABILITY
2 OCCURRED ACCORDING TO THE MEDICAL EXAMINATIONS CONDUCTED UNDER
3 SECTION 29.

4 Sec. 4. (1) "Member", except where the context otherwise
5 requires, means an employee of the ~~Michigan~~ department of state
6 police who has subscribed to the constitutional oath of office.

7 (2) "Officer" means a nonexclusively represented member of the
8 retirement system.

9 (3) "QUALIFIED PARTICIPANT" MEANS AN INDIVIDUAL WHO FIRST
10 BECOMES A MEMBER ON OR AFTER JUNE 10, 2012 AND WHO IS ALSO A
11 PARTICIPANT OF TIER 2.

12 (4) "REGULAR INTEREST" MEANS A RATE OR RATES PER ANNUM,
13 COMPOUNDED ANNUALLY, AS THE RETIREMENT BOARD DETERMINES. FOR THE
14 PURPOSES OF EMPLOYEE REFUNDS, THE INTEREST RATE PAYABLE MUST NOT
15 EXCEED 4% PER ANNUM, COMPOUNDED ANNUALLY.

16 (5) ~~(3)~~ "Retirant" means a member who separates from service
17 and retires with a retirement allowance payable from the
18 appropriate reserve of the retirement system.

19 (6) ~~(4)~~ "Retirement allowance" means the annual amount,
20 payable monthly, to which a retirant, retirement allowance
21 beneficiary, or refund beneficiary is entitled ~~pursuant to~~ **UNDER**
22 this act.

23 (7) ~~(5)~~ "Retirement allowance beneficiary" means a person who
24 is being paid or has entitlement to the payment of a retirement
25 allowance in the event of the death of a member, deferred member,
26 or retirant.

27 (8) ~~(6)~~ "Retirement board" means the retirement board created

1 in section 6.

2 (9) ~~(7)~~—"Retirement system" means the system of benefits for
3 members **AND QUALIFIED PARTICIPANTS** of the department of state
4 police and their survivors and beneficiaries provided by this act.

5 (10) ~~(8)~~—"Surviving spouse" means the spouse at the time of
6 death of the member or retirant.

7 (11) **"TIER 1" MEANS THE RETIREMENT PLAN AVAILABLE TO A MEMBER**
8 **UNDER THIS ACT.**

9 (12) **"TIER 2" MEANS THE RETIREMENT PLAN ESTABLISHED PURSUANT**
10 **TO SECTION 401(K) OF THE INTERNAL REVENUE CODE, 26 USC 401, THAT IS**
11 **AVAILABLE TO QUALIFIED PARTICIPANTS UNDER SECTIONS 62 TO 74.**

12 Sec. 11. (1) The retirement board, in consultation with the
13 department, shall engage an actuary, in conformance with section
14 261 of the management and budget act, ~~Act No. 431 of the Public~~
15 ~~Acts of 1984, being section 18.1261 of the Michigan Compiled~~
16 ~~Laws 1984 PA 431, MCL 18.1261.~~

17 (2) The actuary shall prepare ~~a biennial~~ **AN ANNUAL** valuation
18 of the assets, liabilities, financial condition, and contribution
19 rate of the retirement system, upon information supplied by the
20 department.

21 (3) The retirement board and the department shall **CONDUCT AND**
22 **REVIEW AN EXPERIENCE INVESTIGATION STUDY AND** adopt risk assumptions
23 ~~upon~~ **ON** which actuarial valuations are to be based, after
24 consultation with the actuary, and the state treasurer. ~~These risk~~
25 ~~assumptions shall~~ **THE EXPERIENCE INVESTIGATION STUDY MUST** be
26 periodically reviewed at least once every 5 years.

27 (4) **EVERY APRIL 1 FOLLOWING A PERIODIC REVIEW OF RISK**

1 ASSUMPTIONS UNDER SUBSECTION (3), THE OFFICE OF RETIREMENT SERVICES
2 ON BEHALF OF THE DEPARTMENT AND THE STATE TREASURER SHALL
3 COLLABORATE TO SUBMIT A REPORT TO THE SENATE MAJORITY LEADER, THE
4 SPEAKER OF THE HOUSE OF REPRESENTATIVES, THE SENATE AND HOUSE OF
5 REPRESENTATIVES APPROPRIATIONS COMMITTEES, THE SENATE AND HOUSE
6 FISCAL AGENCIES, AND THE DEPARTMENT OF STATE POLICE. A REPORT
7 REQUIRED UNDER THIS SUBSECTION MUST BE PUBLISHED ON THE OFFICE OF
8 RETIREMENT SERVICES'S WEBSITE AND INCLUDE AT LEAST ALL OF THE
9 FOLLOWING:

10 (A) FORECASTED RATE OF RETURN ON INVESTMENTS AT ALL OF THE
11 FOLLOWING PROBABILITY LEVELS:

- 12 (i) 5%.
- 13 (ii) 25%.
- 14 (iii) 50%
- 15 (iv) 75%.
- 16 (v) 95%.

17 (B) THE ACTUAL RATE OF RETURN ON INVESTMENTS FOR 10-, 15-, AND
18 20-YEAR TIME INTERVALS.

19 (C) MORTALITY ASSUMPTIONS.

20 (D) RETIREMENT AGE ASSUMPTIONS.

21 (E) PAYROLL GROWTH ASSUMPTIONS.

22 (F) ANY OTHER ASSUMPTIONS THAT HAVE A MATERIAL IMPACT ON THE
23 FINANCIAL STATUS OF THE RETIREMENT SYSTEM.

24 Sec. 12. The retirement board shall elect from its membership
25 a chairperson who shall take office immediately ~~upon~~ ON election
26 and serve until a successor is elected. The director of the ~~bureau~~
27 OFFICE of retirement ~~systems,~~ SERVICE, department of TECHNOLOGY,

1 management, and budget, ~~shall be~~ **IS** the executive secretary of the
2 retirement system.

3 Sec. 14. (1) The funding objective of the retirement system is
4 to establish and receive contributions during each fiscal year that
5 are sufficient to fully cover the actuarial cost of benefits likely
6 to be paid on account of services rendered by members during the
7 fiscal year, the normal cost requirements of the retirement system,
8 and finance the unfunded actuarial costs of benefits likely to be
9 paid on account of service rendered ~~prior to~~ **BEFORE** the fiscal
10 year, the unfunded actuarial accrued liability of the retirement
11 system, and health, dental, and vision insurance.

12 (2) ~~The~~ **SUBJECT TO SUBSECTIONS (5) TO (7), THE** annual level
13 percentage of payroll contribution rate ~~shall~~ **MUST** be actuarially
14 determined using experience assumptions and level percent of
15 payroll actuarial cost methods adopted by the retirement board and
16 the department pursuant to an annual actuarial valuation, which
17 ~~shall~~ **MUST** be sufficient to finance benefits being provided and to
18 be provided by the retirement system.

19 (3) ~~For~~ **SUBJECT TO SUBSECTIONS (5) TO (7), FOR** differences
20 occurring in fiscal years beginning on or after October 1, 2001, a
21 minimum of 20% of the difference between the estimated and the
22 actual aggregate compensation and the estimated and the actual
23 contribution rate described in subsection (2), if any, may be
24 submitted in the executive budget to the legislature for
25 appropriation in the next succeeding state fiscal year and a
26 minimum of 25% of the remaining difference ~~shall~~ **MUST** be submitted
27 in the executive budget to the legislature for appropriation in

1 each of the following 4 state fiscal years, or until 100% of the
2 remaining difference is submitted, whichever first occurs. In
3 addition, interest ~~shall~~**MUST** be included for each year that a
4 portion of the remaining difference is carried forward. The
5 interest rate ~~shall~~**MUST** equal the actuarially assumed rate of
6 investment return for the state fiscal year in which payment is
7 made.

8 (4) For each fiscal year that begins on or after October 1,
9 2003, if the actuarial valuation prepared ~~pursuant to~~**UNDER** this
10 section for each fiscal year demonstrates that as of the beginning
11 of a fiscal year, and after all credits and transfers required by
12 this act for the previous fiscal year have been made, the sum of
13 the actuarial value of assets and the actuarial present value of
14 future normal cost contributions exceeds the actuarial present
15 value of benefits, the amount based on the annual level percent of
16 payroll contribution rate ~~pursuant to~~**UNDER** subsections (1) and (2)
17 may be deposited into the health advance funding subaccount created
18 by section 42.

19 (5) **BEGINNING WITH THE STATE FISCAL YEAR ENDING SEPTEMBER 30,**
20 **2022 UNTIL THE PENSION AND RETIREE HEALTH CARE PAYROLL GROWTH**
21 **ASSUMPTION RATE IS ZERO, THE PAYROLL GROWTH ASSUMPTION RATE MUST BE**
22 **REDUCED BY 50 BASIS POINTS. BEGINNING WITH THE STATE FISCAL YEAR**
23 **ENDING SEPTEMBER 30, 2022, THE OFFICE OF RETIREMENT SERVICES WITHIN**
24 **THE DEPARTMENT OF TECHNOLOGY, MANAGEMENT, AND BUDGET AND THE**
25 **RETIREMENT BOARD MAY AGREE TO REDUCE THE RATE DESCRIBED IN THIS**
26 **SUBSECTION BY ANY NUMBER OF ADDITIONAL BASIS POINTS.**

27 (6) **BEGINNING WITH THE STATE FISCAL YEAR ENDING SEPTEMBER 30,**

1 2019 AND FOR EACH SUBSEQUENT FISCAL YEAR, THE NORMAL COST
2 CONTRIBUTION RATE MUST NOT BE LESS THAN THE NORMAL COST
3 CONTRIBUTION RATE IN THE IMMEDIATELY PRECEDING FISCAL YEAR.
4 ADDITIONALLY, THE EMPLOYER PORTION OF THE CONTRIBUTION RATE MUST
5 NOT BE LESS THAN THE EMPLOYER PORTION OF THE CONTRIBUTION RATE IN
6 THE IMMEDIATELY PRECEDING FISCAL YEAR.

7 (7) SUBJECT TO THIS SUBSECTION, BEGINNING WITH THE STATE
8 FISCAL YEAR ENDING SEPTEMBER 30, 2019 AND FOR EACH SUBSEQUENT
9 FISCAL YEAR UNTIL THE UNFUNDED ACTUARIAL ACCRUED LIABILITY IS PAID
10 OFF, THE UNFUNDED ACTUARIAL ACCRUED LIABILITY CONTRIBUTION SUM AND
11 DUE PAYABLE MUST NOT BE LESS THAN THE UNFUNDED ACTUARIAL ACCRUED
12 LIABILITY CONTRIBUTION SUM AND DUE PAYABLE IN THE IMMEDIATELY
13 PRECEDING FISCAL YEAR. THE UNFUNDED ACTUARIAL ACCRUED LIABILITY
14 MUST BE PAID OFF NO LATER THAN SEPTEMBER 30, 2038. ADDITIONALLY,
15 THE EMPLOYER PORTION OF THE UNFUNDED ACTUARIAL ACCRUED LIABILITY
16 CONTRIBUTION SUM AND DUE PAYABLE MUST NOT BE LESS THAN THE EMPLOYER
17 PORTION OF THE UNFUNDED ACTUARIAL ACCRUED LIABILITY CONTRIBUTION
18 SUM AND DUE PAYABLE IN THE IMMEDIATELY PRECEDING FISCAL YEAR.

19 (8) ~~(5)~~ Notwithstanding any other provision of this act, if
20 the retirement board establishes an arrangement and fund as
21 described in section 6 of the public employee retirement benefit
22 protection act, 2002 PA 100, MCL 38.1686, the benefits that are
23 required to be paid from that fund ~~shall~~ **MUST** be paid from a
24 portion of the employer contributions described in this section or
25 other eligible funds. The retirement board shall determine the
26 amount of the employer contributions or other eligible funds that
27 must be allocated to that fund and deposit that amount in that fund

1 before it deposits any remaining employer contributions or other
2 eligible funds in the pension fund.

3 Sec. 14a. (1) This section is enacted ~~pursuant to~~ **UNDER**
4 section 401(a) of the internal revenue code, **26 USC 401**, that
5 imposes certain administrative requirements and benefit limitations
6 for qualified governmental plans. This state intends that the
7 retirement system be a qualified pension plan created in trust
8 under section 401 of the internal revenue code, **26 USC 401**, and
9 that the trust be an exempt organization under section 501 of the
10 internal revenue code, **26 USC 501**. The department shall administer
11 the retirement system to fulfill this intent.

12 (2) The retirement system ~~shall~~ **MUST** be administered in
13 compliance with section 415 of the internal revenue code, 26 USC
14 415, and regulations under that section that are applicable to
15 governmental plans and, beginning January 1, 2010, applicable
16 provisions of the final regulations issued by the ~~internal revenue~~
17 ~~service~~ **INTERNAL REVENUE SERVICE** on April 5, 2007. Employer-
18 financed benefits provided by the retirement system under this act
19 ~~shall~~ **MUST** not exceed the applicable limitations set forth in
20 section 415 of the internal revenue code, 26 USC 415, as adjusted
21 by the commissioner of internal revenue under section 415(d) of the
22 internal revenue code, 26 USC 415, to reflect cost of living
23 increases, and the retirement system ~~shall~~ **MUST** adjust the
24 benefits, including benefits payable to retirants and retirement
25 allowance beneficiaries, subject to the limitation each calendar
26 year to conform with the adjusted limitation. For purposes of

17 SEC. 74. (1) THE DEPARTMENT HAS THE RIGHT OF SETOFF TO RECOVER
18 OVERPAYMENTS MADE UNDER THIS ACT AND TO SATISFY ANY CLAIMS ARISING
19 FROM EMBEZZLEMENT OR FRAUD COMMITTED BY A QUALIFIED PARTICIPANT,
20 FORMER QUALIFIED PARTICIPANT, REFUND BENEFICIARY, OR OTHER PERSON
21 WHO HAS A CLAIM TO A DISTRIBUTION OR ANY OTHER BENEFIT FROM TIER 2.

22 (2) THE DEPARTMENT SHALL CORRECT ERRORS IN THE RECORDS AND
23 ACTIONS IN TIER 2 UNDER THIS ACT, AND SHALL SEEK TO RECOVER
24 OVERPAYMENTS AND SHALL MAKE UP UNDERPAYMENTS.
