

SUBSTITUTE FOR  
SENATE BILL NO. 956

A bill to amend 2008 PA 23, entitled  
"Enhanced driver license and enhanced official state personal  
identification card act,"  
by amending section 4 (MCL 28.304), as amended by 2018 PA 47.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 4. (1) The secretary of state may issue an enhanced  
2 driver's license or enhanced official state personal identification  
3 card to an applicant who provides satisfactory proof of his or her  
4 full legal name, United States citizenship, identity, date of  
5 birth, ~~social security~~ **SOCIAL SECURITY** number, residence address,  
6 **PROOF OF ENROLLMENT IN THE ADDRESS CONFIDENTIALITY PROGRAM UNDER**  
7 **THE ADDRESS CONFIDENTIALITY PROGRAM ACT, IF APPLICABLE,** and a  
8 photographic identity document. An applicant may choose to apply  
9 for a standard driver license or standard official state personal  
10 identification card or an enhanced driver license or enhanced state

1 personal identification card.

2 (2) An enhanced driver license or enhanced official state  
3 personal identification card shall include reasonable security  
4 measures to protect against unauthorized disclosure of personal  
5 information regarding residents of this state that is contained in  
6 the enhanced driver license or enhanced official state personal  
7 identification card.

8 (3) An enhanced driver license or enhanced official state  
9 personal identification card may include radio frequency  
10 identification technology that is limited to a randomly assigned  
11 number, which shall be encrypted if agreed to by the Department of  
12 Homeland Security, and does not include biometric data. The  
13 secretary of state shall ensure that the radio frequency  
14 identification technology is secure from unauthorized data access  
15 and includes reasonable security measures to protect against  
16 unauthorized disclosure of personal information. An applicant must  
17 sign a declaration acknowledging his or her understanding of the  
18 radio frequency identification technology before he or she is  
19 issued an enhanced driver license or enhanced official state  
20 personal identification card.

21 (4) The requirements of this act are in addition to the  
22 requirements otherwise imposed on individuals who apply for a  
23 standard driver license or standard official state personal  
24 identification card.

25 (5) The holder of an enhanced driver license issued under this  
26 act is subject to every licensing sanction provided under the  
27 Michigan vehicle code, 1949 PA 300, MCL 257.1 to 257.923. As used

1 in this subsection, "licensing sanction" means the restriction,  
2 suspension, revocation, or denial of a driver license; the addition  
3 of points to a driving record; until October 1, 2018, the  
4 assessment of a driver responsibility fee; the assessment of a  
5 civil fine or criminal penalty resulting from a conviction; a civil  
6 infraction determination; the imposition of probationary terms and  
7 conditions; or any other penalty provided under the Michigan  
8 vehicle code, 1949 PA 300, MCL 257.1 to 257.923.

9 (6) BEGINNING ON FEBRUARY 16, 2021, UPON RECEIPT OF A NOTICE  
10 FROM THE DEPARTMENT OF THE ATTORNEY GENERAL THAT AN INDIVIDUAL WHO  
11 HAS BEEN ISSUED AN ENHANCED DRIVER LICENSE OR ENHANCED OFFICIAL  
12 STATE PERSONAL IDENTIFICATION CARD UNDER THIS ACT HAS BEEN  
13 CERTIFIED AS A PARTICIPANT IN THE ADDRESS CONFIDENTIALITY PROGRAM,  
14 THE SECRETARY OF STATE SHALL ISSUE A CORRECTED ENHANCED DRIVER  
15 LICENSE OR ENHANCED OFFICIAL STATE PERSONAL IDENTIFICATION CARD TO  
16 THAT INDIVIDUAL BY MAILING THE LICENSE OR CARD TO HIS OR HER  
17 DESIGNATED ADDRESS. THE ENHANCED DRIVER LICENSE OR ENHANCED  
18 OFFICIAL STATE PERSONAL IDENTIFICATION CARD SHALL DISPLAY THE  
19 INDIVIDUAL'S DESIGNATED ADDRESS AND SHALL NOT DISPLAY THE  
20 INDIVIDUAL'S RESIDENCE ADDRESS. THE REQUIREMENTS OF THIS SUBSECTION  
21 ARE IN ADDITION TO THE REQUIREMENTS FOR INDIVIDUALS WHO ARE ISSUED  
22 A CORRECTED STANDARD DRIVER LICENSE UNDER SECTION 310F OF THE  
23 MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.310F, OR A CORRECTED  
24 OFFICIAL STATE PERSONAL IDENTIFICATION CARD UNDER SECTION 2A OF  
25 1972 PA 222, MCL 28.292A. AS USED IN THIS SUBSECTION:

26 (A) "ADDRESS CONFIDENTIALITY PROGRAM" MEANS A PROGRAM AS THAT  
27 TERM IS DEFINED IN THE ADDRESS CONFIDENTIALITY PROGRAM ACT.

1           **(B) "DESIGNATED ADDRESS" MEANS THAT TERM AS DEFINED IN THE**  
2           **ADDRESS CONFIDENTIALITY PROGRAM ACT.**

3           Enacting section 1. This amendatory act takes effect 180 days  
4 after the date it is enacted into law.

5           Enacting section 2. This amendatory act does not take effect  
6 unless Senate Bill No. 655 of the 99th Legislature is enacted into  
7 law.
