HOUSE BILL No. 4142

February 1, 2017, Introduced by Rep. Kosowski and referred to the Committee on Education Reform.

A bill to establish a teacher shortage prevention program for certain teachers in certain areas; to establish a teacher shortage prevention grant fund and to provide for its administration; and to prescribe certain powers and duties of certain state officers, agencies, and departments.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the
 "teacher shortage prevention act".
 - Sec. 3. As used in this act:
 - (a) "Authority" means the Michigan finance authority created by Executive Reorganization Order No. 2010-2, MCL 12.194.
 - (b) "Department" means the department of treasury.
 - (c) "Fund" means the teacher shortage prevention grant fund created in section 11.

- 1 (d) "Grant" means money awarded to an individual under this
- 2 act in an amount determined under section 9.
- 3 (e) "Qualified educational loan" means the total unpaid amount
- 4 of all of an individual's unpaid government, commercial, or
- 5 foundation student loans for actual costs paid for tuition and
- 6 reasonable education and living expenses related to a teacher's
- 7 preparation or further education, calculated at the time the
- 8 individual first applies for a grant under this act.
- 9 (f) "School district" means a school district, local act
- 10 school district, or intermediate school district as those terms are
- 11 defined in the revised school code, 1976 PA 451, MCL 380.1 to
- 12 380.1852, or a public school academy established under the revised
- 13 school code, 1976 PA 451, MCL 380.1 to 380.1852.
- 14 (g) "Superintendent" means the superintendent of public
- 15 instruction described in section 3 of article VIII of the state
- 16 constitution of 1963.
- 17 (h) "Teacher" means an individual who holds a valid teaching
- 18 certificate issued by the superintendent under section 1531 of the
- 19 revised school code, 1976 PA 451, MCL 380.1531.
- 20 (i) "Teacher shortage area" means those school districts
- 21 reported by the superintendent as experiencing a teacher shortage.
- 22 Sec. 5. (1) The teachers shortage prevention program is
- 23 created within the department, to be administered by the authority.
- 24 Subject to appropriation, the authority shall do all of the
- 25 following:
- 26 (a) Award grants to eligible teachers under this act.
- 27 (b) Develop an application form and application process for

- 1 teachers applying for grants under this act.
- 2 (c) Promulgate any rules necessary to implement this act
- 3 pursuant to the administrative procedures act of 1969, 1969 PA 306,
- 4 MCL 24.201 to 24.328.
- 5 (2) The superintendent shall survey the state's school
- 6 districts and teacher preparation programs and report to the
- 7 authority and the senate and house committees that have the
- 8 responsibility for education legislation on or before February 1 of
- 9 each odd-numbered year on the status of teacher early retirement
- 10 patterns, the teacher shortage, and the substitute teacher
- 11 shortage, including patterns and shortages in subject areas and
- 12 regions of the state. The report must also include how districts
- 13 are making progress in hiring teachers and substitutes in the areas
- 14 of shortage and a 5-year projection of teacher demand for each
- 15 district. The report must also identify those school districts that
- 16 fall within a teacher shortage area.
- Sec. 7. The authority may award a grant under section 9 to an
- 18 individual determined by the authority to meet all of the following
- 19 eligibility criteria:
- 20 (a) At the time of application, the individual has a qualified
- 21 educational loan.
- 22 (b) Is a legal resident of this state.
- (c) Has not previously defaulted and is not currently in
- 24 default on a qualified educational loan.
- 25 (d) Has accepted an offer of employment or will continue to
- 26 teach in a teacher shortage area in the school's academic year that
- 27 begins on or after the first July 1 following the date of the

- 1 application.
- 2 (e) Has submitted a grant application to the authority on or
- 3 before July 1. The grant application shall include a certification
- 4 that the applicant meets the eligibility criteria described in this
- 5 section and has applied for all state or federal loan forgiveness
- 6 programs applicable to his or her qualified educational loan.
- 7 (f) Has met any other requirements established by the
- 8 authority.
- 9 Sec. 9. (1) The authority shall award an individual eligible
- 10 under section 7 a grant under this subsection. Subject to
- 11 subsection (2) and to adjustment under subsection (3), the maximum
- 12 amount of the grant is \$1,000.00 for not more than 5 consecutive
- 13 years or an amount equal to the individual's qualified educational
- 14 loan, whichever is less.
- 15 (2) A grant under subsection (1) shall be reduced by an amount
- 16 equal to the amount the individual is entitled to receive from any
- 17 state or federal loan forgiveness program applicable to a qualified
- 18 educational loan.
- 19 (3) In any state fiscal year, the authority may adjust the
- 20 amount of each partial grant under subsection (1) on a pro rata
- 21 basis, based upon its determination of money available from the
- 22 fund and from appropriations in that fiscal year. If it makes an
- 23 adjustment under this subsection, the authority shall notify each
- 24 grant recipient of his or her obligation to continue to make
- 25 payments of principal and interest on his or her qualified
- 26 educational loan in the manner described in his or her state
- 27 student loan documents.

- 1 Sec. 11. (1) There is created the teacher prevention grant
- 2 fund as a separate fund in the state treasury, to be administered
- 3 by the department. The department may accept money for the fund
- 4 from any source. The state treasurer shall deposit that money and
- 5 credit the amount to the fund. The department shall use the fund
- 6 only to provide money to the authority for grants awarded under
- 7 this act.
- 8 (2) The state treasurer shall direct the investment of the
- 9 fund money and shall credit earnings to the fund.
- 10 (3) Money in the fund at the end of a fiscal year shall not
- 11 revert to the general fund but shall be carried over in the fund to
- 12 the next fiscal year.
- Sec. 13. Before February 1 of each year, the authority shall
- 14 report to the senate and house committees that have the
- 15 responsibility for education legislation on the number of
- 16 individuals who received a grant under this act, the list of those
- 17 school districts within a teacher shortage area, the average amount
- 18 paid to a teacher participating in the program, and any other data
- 19 to support the operation and effectiveness of the program.
- 20 Sec. 15. A teacher who submits a false or misleading
- 21 application or other false or misleading information to the
- 22 authority may be required to repay the total amount of the grant
- 23 that he or she received under this program, plus interest in
- 24 accordance with section 23 of 1941 PA 122, MCL 205.23.
