HOUSE BILL No. 4764

June 14, 2017, Introduced by Reps. Elder, Sneller, Love, Chirkun, Lasinski, Hertel, Wittenberg, Liberati and Hammoud and referred to the Committee on Commerce and Trade.

A bill to require employers to provide unpaid leave for employees to attend academic activities of their children; to provide the conditions for granting the leave; and to prohibit discrimination against employees who request or use the leave.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. (1) This act shall be known and may be cited as the
 "family education leave act".
 - (2) As used in this act:
 - (a) "Academic activity" means a parent-teacher conference, tutoring, or other activity or event related to the educational advancement of a parent's or legal guardian's child.
 - (b) "Academic year" means the period, not to exceed 12 consecutive months, allotted by a school for the completion of 1

- 1 grade level of study.
- 2 (c) "Employee" does not include an independent contractor, a
- 3 domestic servant employed in or about a private home, or a farm or
- 4 ranch laborer.
- 5 (d) "Employer" means a person, including this state and all
- 6 political subdivisions of this state, that regularly employs 1 or
- 7 more full-time employees.
- 8 Sec. 2. (1) Except as provided in section 4, an employer shall
- 9 allow each of his or her employees who is a parent or legal
- 10 guardian of a minor child to request and take unpaid leave, not to
- 11 exceed 8 hours for each minor child in any academic year, for the
- 12 purpose of attending academic activities for or with the minor
- 13 child.
- 14 (2) An employer may require that the leave be taken in no
- 15 longer than 3-hour increments and that the employee provide written

- 18 Sec. 3. (1) An employee shall provide the employer with notice
- 19 of the intent to use leave under this act 7 or more days in advance
- 20 of the academic activity. If the employee cannot provide the notice
- 21 7 days in advance due to an emergency, the employee shall provide
- 22 the employer with notice of the intent to use the leave as soon as
- 23 possible. The notice to the employer must include the written
- 24 verification specified in section 2(2), if required by the
- 25 employer.
- 26 (2) An employee may elect to substitute accrued paid leave for
- 27 the unpaid leave provided under this act.

- 1 (3) An employee shall make reasonable efforts to schedule
- 2 academic activities for which leave may be taken under this act
- 3 outside of the employee's regular work hours.
- 4 Sec. 4. An employer may deny use of leave requested under this
- 5 act only if granting the leave would disrupt or cause unusual
- 6 difficulty in the employer's business or endanger the public safety
- 7 or welfare.
- 8 Sec. 5. An employer shall not discharge, threaten, or
- 9 otherwise discriminate against an employee regarding the employee's
- 10 compensation, terms, conditions, location, or privileges of
- 11 employment because the employee requests or takes leave under this
- **12** act.
- 13 Enacting section 1. This act takes effect 90 days after the
- 14 date it is enacted into law.
