## **HOUSE BILL No. 5364**

December 13, 2017, Introduced by Rep. Schor and referred to the Committee on Financial Services.

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 5728 (MCL 600.5728).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 5728. (1) Possession may be recovered under section 5726 only after the vendee or person holding possession under him THE

VENDEE has been served with a written notice of forfeiture and has failed in the required time to pay moneys MONEY required to be paid under the contract or to cure any other material breach of the contract. Unless the parties have agreed in writing to a longer time, the person served with a notice of forfeiture shall have HAS

15 days thereafter AFTER BEING SERVED before he OR SHE is required to pay moneys MONEY required to be paid under the contract and cure other material breaches of the contract or to deliver possession of the premises.
