

# HOUSE BILL No. 6042

May 17, 2018, Introduced by Reps. Yanez, Faris, Green, Gay-Dagnogo, Hertel, Chirkun, Sowerby, Hornberger, Marino, Elder and Lucido and referred to the Committee on Law and Justice.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 16d of chapter XVII (MCL 777.16d), as amended  
by 2016 PA 88.

### 1 CHAPTER XVII
