A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1232.

- 4 COMPLETE THE SAFESPORT ONLINE TRAINING PROGRAM ON SEXUAL MISCONDUCT
- 5 PROVIDED BY THE UNITED STATES CENTER FOR SAFESPORT OR AN EQUIVALENT
 - TRAINING PROGRAM, AS DETERMINED BY THE DEPARTMENT.
- 7 (2) AN INDIVIDUAL HIRED BY A SCHOOL DISTRICT OR PUBLIC SCHOOL

- Enacting section 1. This amendatory act takes effect 90 days
