THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- SEC. 811HH. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER

 SECTION 811E AND SHALL ISSUE UNDER SECTION 811F A FUND-RAISING

 PLATE RECOGNIZING FAMILIES AGAINST NARCOTICS. A FUND-RAISING PLATE

 DEVELOPED UNDER THIS SECTION MUST BE OF A DESIGN DETERMINED BY THE

 SECRETARY OF STATE.
 - (2) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING FAMILIES AGAINST NARCOTICS COLLECTED UNDER SECTION 811F TO THE STATE TREASURER, WHO SHALL CREDIT THE DONATION MONEY TO THE FAMILIES AGAINST NARCOTICS FUND CREATED IN SUBSECTION (3).

- 1 (3) THE FAMILIES AGAINST NARCOTICS FUND IS CREATED WITHIN THE
- 2 STATE TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR OTHER
