

SENATE BILL No. 956

April 19, 2018, Introduced by Senator JONES and referred to the Committee on Judiciary.

A bill to amend 2008 PA 23, entitled
"Enhanced driver license and enhanced official state personal
identification card act,"

(MCL 28.301 to 28.308) by adding section 4a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 4A. (1) UPON RECEIPT OF A NOTICE FROM THE DEPARTMENT OF
2 THE ATTORNEY GENERAL THAT AN INDIVIDUAL WHO HAS BEEN ISSUED AN
3 ENHANCED DRIVER LICENSE OR ENHANCED OFFICIAL STATE PERSONAL
4 IDENTIFICATION CARD UNDER THIS ACT HAS BEEN CERTIFIED AS A
5 PARTICIPANT IN THE ADDRESS CONFIDENTIALITY PROGRAM, THE SECRETARY
6 OF STATE SHALL ISSUE A CORRECTED ENHANCED DRIVER LICENSE OR
7 ENHANCED OFFICIAL STATE PERSONAL IDENTIFICATION CARD TO THAT
8 INDIVIDUAL BY MAILING THE LICENSE OR CARD TO HIS OR HER DESIGNATED
9 ADDRESS. THE ENHANCED DRIVER LICENSE OR ENHANCED OFFICIAL STATE
10 PERSONAL IDENTIFICATION CARD SHALL DISPLAY THE INDIVIDUAL'S

1 DESIGNATED ADDRESS AND SHALL NOT DISPLAY THE INDIVIDUAL'S RESIDENCE
2 ADDRESS.

3 (2) THE REQUIREMENTS OF THIS SECTION ARE IN ADDITION TO THE
4 REQUIREMENTS FOR INDIVIDUALS WHO ARE ISSUED A CORRECTED STANDARD
5 DRIVER LICENSE UNDER SECTION 310F OF THE MICHIGAN VEHICLE CODE,
6 1949 PA 300, MCL 257.310F, OR A CORRECTED OFFICIAL STATE PERSONAL
7 IDENTIFICATION CARD UNDER SECTION 2A OF 1972 PA 222, MCL 28.292A.

8 (3) AS USED IN THIS SECTION:

9 (A) "ADDRESS CONFIDENTIALITY PROGRAM" MEANS A PROGRAM AS THAT
10 TERM IS DEFINED IN SECTION 3 OF THE ADDRESS CONFIDENTIALITY PROGRAM
11 ACT.

12 (B) "DESIGNATED ADDRESS" MEANS THAT TERM AS DEFINED IN SECTION
13 3 OF THE ADDRESS CONFIDENTIALITY PROGRAM ACT.

14 Enacting section 1. This amendatory act takes effect 180 days
15 after the date it is enacted into law.

16 Enacting section 2. This amendatory act does not take effect
17 unless Senate Bill No. 655 of the 99th Legislature is enacted into
18 law.
