The question being on concurring in the committee recommendation to give the bill immediate effect,

The recommendation was concurred in, 2/3 of the members serving voting therefor.

The Senate agreed to the title of the bill.

Senators Hertel, Bieda, Meekhof, Rocca and Ananich asked and were granted unanimous consent to make statements and moved that the statements be printed in the Journal.

The motion prevailed.

Senator Hertel's statement is as follows:

I rise to offer an amendment to add \$275 million out of the rainy day fund to this supplemental appropriation. The current proposal is a day late and dollar short—actually, it's about 842 days late and \$275 million short—of what is needed to actually fix our roads.

Every day we do not invest, our roads get worse. It is the ultimate insult to the citizens of Michigan to ask them to pay higher taxes, ask them to pay higher registration fees, and to not solve this problem for them. We continually scramble to fix the problem that we have kicked down the road, and we fail to allocate the money to properly address the issue. As potholes wreak havoc on vehicles and jeopardize drivers' safety, we cannot afford to wait until 2021 to fully fund this problem.

Colleagues, we've seen photos circulating of people standing in knee-deep potholes. Motorists are having flying concrete crash through their windshields. It could not be blatantly clearer that the status quo is not acceptable. My friends, it's raining in Michigan—literally, at times, raining concrete. The people of Michigan have been paying higher registration fees and higher gas taxes, and they deserve to have this issue fixed now. The people are tired of paying more and getting less from their government.

Now, I know we'll have speakers who come up and argue against so I want to take their arguments one by one.

One, people will mention that I didn't vote for the original package. I am proud of my "no" vote. We predicted that the partisan solution would exactly come to this: the people paying more and the roads not being fixed. Instead, we can work on a bipartisan basis right now and put the money needed to fix roads and work on a bipartisan basis to make that happen.

Two, that inflation will lead to too much money being spent on roads or that the cost will go up. First of all, I have to say that I'm not sure everyone in this room understands the free market, but the cost of road construction is set nationally. Adding \$275 million just here in Michigan will not make the cost of fixing roads skyrocket. Beyond that, in fact, a letter from Lance Binoniemi, the vice president of the Michigan Infrastructure and Transportation Association, that's on

your desks says, and I quote, "in fact, during the summer of construction, the industry saw even more competition and competitive prices on final bids than in the prior and future years, proving that the argument of inflated costs is actually not true." Again, colleagues, the free market works. Let's vote for it.

The next argument would be that there's not enough capacity to fix our roads, that we don't have the workers to do it, and that we couldn't get to all these projects. I'd say the answer to that is, one, talk to your constituents. They're tired of the projects being put off year after year. I'd say talk to those who build the roads. The letter from MITA clearly states the workers are ready to actually fix those roads if we fund them, and talk to your local mayors and county commissioners where most of the money goes and those people are waiting for the state to do the right thing to fund the projects that we need.

Finally, you could argue that this money shouldn't come out of the rainy day fund. We have a billion dollars in the rainy day fund. I'm sure it's a good talking point, but it's not solving the problem for the people of Michigan. Again, my friends, it's raining in Michigan—literally, at times, concrete.

Citizens are tired of excuses. The time to act is now. For the people of this state who drive on these roads every day and who are tired of paying higher taxes and seeing no results, I urge you to support this amendment and give our residents relief now.

Senator Bieda's statement is as follows:

Colleagues, I rise today, both as a lawmaker and as a frustrated driver, who makes the trip from my home in Warren to Lansing every week. This bill reminds me that lawmakers in this room had a chance to fix our roads several times—in 2015, in 2016, in 2017, and now, in 2018. Every year, my Democratic colleagues and I have offered comprehensive funding mechanisms to fix our roads once and for all, but this chamber has refused to be proactive. Instead, we come back year after year to toss more pennies into potholes and hope it works. That's the only thing that this bill does today, and frankly, it is woefully inadequate.

Well, I have had enough of this nonsense. The folks in my district don't get the luxury to toss a couple of bucks toward their mangled rims and blown-out tires, and that's in the best case scenarios. I have people in my district who couldn't even make it to work because their suspension or their car was damaged. They needed to spend thousands of dollars and their mornings with mechanics to get their cars fixed. How much more evidence do we need to see that the status quo isn't working?

The Department of Transportation told you, "We need more funding." The Governor's office conducted a study and it said, "We need more funding." Your constituents are calling your office and telling you, "We need more funding." I look outside today and see even more snow falling and I worry how bad it's going to get. If you think the roads are bad today, wait until tomorrow, wait until the next day. This just isn't enough. The measly amount that some cities and municipalities in my district stand to get, won't be able to make up the real difference in the quality of our roads. We will be back here next year—well some of you will be back here next year—simply because we won't appropriate enough money to do a permanent fix.

I have this letter signed by our County Executive, Mark Hackel, and our Macomb County Public Works Commissioner, Candice Miller, which talks about this. It says:

An eminent danger to life and property exists in Macomb County and much of southern Michigan due to the current condition of our roads.

No doubt you have heard numerous constituent complaints about the conditions of our roads due to an unprecedented number of potholes and related issues. The current conditions of our local, county and state roads have far surpasses the level of inconvenience and are now at crisis levels. A number of roads in our county were recently temporarily closed by the Macomb County Dept. of Roads due to the danger. The current road conditions not only endanger drivers, passengers and nearby pedestrians, but could soon also have a direct negative impact on economic development and business attraction efforts.

The recent statewide allocation of \$175 million is woefully insufficient to address the structural needs to fix Macomb County roads. As it now stands, Macomb County's expected share of that \$175 million is in the range of \$4.4 million-a figure that is woefully inadequate to address the current need. According to MDOT's rating system, over 780 of Macomb County's 1,500 lane miles are rated as "poor." Our county highway engineers estimate that bringing all those roads up to standards would cost around \$1.2 billion. We have no doubt that other communities, particularly those in southeast Michigan, will agree that the dollars designated for their communities is inadequate.

Crisis conditions call for extraordinary actions to be taken by our elected leaders. We urge the State Legislature to rap into the state's Rainy Day Fund, to borrow from Designated Reserves or to take such other creative actions that will allow for an immediate application of substantial funds to fix our roads. This action should be taken in addition to the \$175 million allocation recently approved by the state House of Representatives.

We urge you to take direct, immediate action to provide additional funds to fix our roads.

This, again, is signed by Macomb County Executive Mark Hackel—a Democrat—and Macomb County Public Works Commissioner Candice Miller—a Republican. The roads, my friends, are not a partisan issue. The problem is an issue that we are facing in this state. The roads are a huge problem. Our constituents are calling for a solution. My colleague, Senator Hertel, mentioned that we have a huge problem that concrete is coming down—it really is. This is more than a rainy day, this more than a blizzard, this is a catastrophic event that is hitting our state, that is impact our industry, that's impacting our economy, and it's endangering our public, and we need to take strong action and we need to do that today.

#### Senator Meekhof's statement is as follows:

I've listened to my colleagues from the 23rd and 9th districts bloviate over this issue. I think it's important for their public officials, and for our public officials, to understand when they had a chance to vote for \$1.2 billion in road funding on November 3, 2015, all but one of the other side voted "no." I think it's a bit disingenuous, and I'm very disappointed, that this has become a partisan issue when you actually had the opportunity to participate in a long-term funding process and vote "yes." So, when you go back and tell your constituents that you voted "no" on \$1.2 billion, I'd like to see the headline in the newspaper.

#### Senator Rocca's statement is as follows:

I rarely speak on the floor, but I feel compelled to today because the system of road funding in this state is nothing less than institutionalized theft.

The people in my district are driving on roads, the majority of which are rated as "poor" by MDOT and poor does not even begin to describe them. People in this chamber who support Public Act No. 51 in its current form—the system of institutionalized theft from people in my district and other donor counties—I challenge you to come to Sterling Heights, and come to Macomb County and drive on our roads. The majority of them are destroyed. We drive on our roads and use them until the end of their actual service life and then several years afterward. The gaps between the pavement seams on Mound Road and the other roads in my district are chasms. People avoid most of the main roads in my district because of this, and it's because so much of our tax dollars are being taken by other parts of the state—by greedy, grubbing people who steal our money every year, re-paving roads in their districts that are perfectly fine while my constituents, who are paying the bills, drive on roads that are destroyed.

This has to change, but, of course, there is no will in this chamber to change this because so many people benefit from this system of theft in which my constituents get robbed every year and drive on destroyed infrastructure while we waste money on nonsense as our roads in my area are destroyed and people keep taking more and more of our money every year. It has to stop, but, of course, so many people benefit from this system of theft. I've become convinced the only way it'll ever change is by filing a federal lawsuit and getting a federal judge involved because nobody wants to change it because they are in on this scam. It is infuriating and it should not be allowed to continue, but, of course, so many people benefit from it—they just keep taking and taking and living in denial and imagining that a part of the state where there are 18 people per square mile is somehow funding their roads that cost millions of dollars per mile to build while Macomb County, where we have 1,800 people per square mile, our roads are destroyed and it's somehow our fault.

It's not our fault. My constituents are paying enough taxes to fund their roads, it's just being robbed by other people and it has to stop and of course people in this chamber will not.

#### Senator Ananich's statement is as follows:

I offer an amendment that's pretty simple and fair and I ask my colleagues to support it.

Obviously, a few years ago I had some disagreements with my colleagues and didn't support this plan because I didn't think it was going to work. Obviously we know now, as we drive here every day, that it didn't, but I lost that debate, and that's what happens sometimes in this chamber.

Let me outline the problem that I'm trying to resolve and what I believe is a solution. As we all know and hear from constituents over and over again when companies and truck drivers and individuals drive on our roads, there is an immense amount of damage done to their vehicles—blown tires, alignment issues, rims, and things of that nature. Even last week, Crain's reported that damage done from roads is costing motorists an average of \$865 in repairs to each motorist. No matter who you are, that's a lot of money. In essence, it's a backdoor tax. For those who have tried to maneuver through the Department of Transportation to be reimbursed for the damage that was done through no fault of their own, good luck maneuvering through that bureaucracy. One of the main things they throw up in people's faces is that it had to have been reported a week in advance. Let me say this: I think I can safely say the roads in this state are terrible. MDOT, I hope you're listening. I'm reporting it. There are potholes and damaged bridges all over this state.

What I'm proposing is that we allocate \$5 million to start to address a wrong that happens to individuals all across this state. We would allocate \$5 million to MDOT so that when individuals have their car damaged—in many cases not allowing them to get to work, allowing unsafe travel for taking their kids to school, or to visit a family member—that we just say, plain and simple, if damage was done because of government failure, we'll address the issue. It's what I'm proposing today to start giving folks relief by creating an easy, one-stop reimbursement fund. We all know the roads aren't going to be fixed anytime soon but it's something we can do immediately to help our constituents.

I'm proposing a solution. If you have a better one, I'd love to hear it.
