Senator Conyers' statement is as follows:

Today I have the distinct honor of welcoming to the Michigan Senate 60 men representing the northern province of Kappa Alpha Psi—11 undergraduate and 10 graduate chapters in the state of Michigan. As a member of Kappa Alpha Psi who joined at Georgetown University in the spring of 2008, it is an honor to introduce our fraternity to you.

Kappa Alpha Psi is a college Greek letter fraternity that welcomes men of all colors, creeds, and national origins. It was founded in 1911 on the campus of Indiana University in Bloomington. #### **House Bill No. 4422, entitled**

A bill to amend 1980 PA 300, entitled "The public school employees retirement act of 1979," by amending section 61 (MCL 38.1361), as amended by 2015 PA 219.

Substitute (S-1).

The following are the amendments to the substitute recommended by the Committee of the Whole:

1. Amend page 5, line 7, after "(10)," by striking out "or".
2. Amend page 5, line 7, after "(11)" by inserting a comma and "**OR (13)**".
3. Amend page 10, following line 8, by inserting:

**"(13) SUBSECTION (1) DOES NOT APPLY TO A RETIRANT WHO RETIRES AFTER JUNE 30, 2010 AND ON OR BEFORE THE EFFECTIVE DATE OF THIS SUBSECTION AND WHO, FOLLOWING A BONA FIDE TERMINATION, BECOMES EMPLOYED BY A REPORTING UNIT AS A SCHOOL RENEWAL COACH OR HIGH IMPACT LEADERSHIP FACILITATOR AS PART OF A SCHOOL LEADERSHIP SUPPORT PROGRAM THAT IS FUNDED BY A FEDERAL GRANT AWARDED BEFORE THE EFFECTIVE DATE OF THIS SUBSECTION AND THAT MEETS THE REQUIREMENTS OF SUBSECTION (14). A RETIRANT DESCRIBED IN THIS SUBSECTION IS NOT ELIGIBLE TO USE ANY SERVICE OR COMPENSATION ATTRIBUTABLE TO THE EMPLOYMENT DESCRIBED IN THIS SUBSECTION FOR A RECOMPUTATION OF HIS OR HER RETIREMENT ALLOWANCE. THE REPORTING UNIT SHALL PAY 100% OF THE CONTRIBUTION RATES FOR THE UNFUNDED ACTUARIAL ACCRUED LIABILITY FOR RETIREE HEALTH CARE AND THE UNFUNDED ACTUARIAL ACCRUED LIABILITY FOR PENSION TO THE RETIREMENT SYSTEM FOR THE EMPLOYMENT DESCRIBED IN THIS SUBSECTION. THE REPORTING UNIT SHALL REPORT THE ENGAGEMENT OF SCHOOL RENEWAL COACHES OR HIGH IMPACT LEADERSHIP FACILITATORS TO THE RETIREMENT SYSTEM AT THE SAME INTERVAL THE REPORTING UNIT REPORTS INFORMATION TO THE RETIREMENT SYSTEM WITH REGARD TO ITS OTHER EMPLOYEES. THE REPORTING UNIT SHALL INCLUDE IN THE REPORT THE NAME OF THE SCHOOL RENEWAL COACH OR HIGH IMPACT LEADERSHIP FACILITATOR AND THE TOTAL EARNINGS PAID TO THE SCHOOL RENEWAL COACH OR HIGH IMPACT LEADERSHIP FACILITATOR FOR THAT REPORTING PERIOD.**

**(14) SUBSECTION (13) APPLIES TO RETIRANTS EMPLOYED AS PART OF A PROGRAM THAT SUPPORTS TEAMS OF SCHOOL PRINCIPALS AND TEACHER LEADERS IN ELEMENTARY SCHOOLS BY DOING ALL OF THE FOLLOWING:**

**(A) PROVIDING INTENSE PROFESSIONAL DEVELOPMENT AND SUPPORT, AND MONEY, FOR RENEWAL PROJECTS FOR TEAMS OF SCHOOL LEADERS IN A NUMBER OF PROJECT SCHOOLS THAT ARE IMPLEMENTING A SET OF NEW LITERACY ESSENTIALS.**

**(B) PLACING A TRAINED TEAM OF SCHOOL RENEWAL COACHES OR HIGH IMPACT LEADERSHIP FACILITATORS IN EACH PROJECT SCHOOL.**

**(C) PROVIDING A LOWER LEVEL OF PROFESSIONAL DEVELOPMENT SUPPORT AND FUNDING FOR LEADERS IN ADDITIONAL SCHOOLS.**

**(D) APPLYING A SET OF PROVEN SCHOOL LEADERSHIP PRACTICES FOR SCHOOL RENEWAL AND SUSTAINABLE IMPLEMENTATION.**

**(E) PROVIDING TRAINING, SUPPORT, AND OVERSIGHT FOR THE SCHOOL RENEWAL COACHES OR HIGH IMPACT LEADERSHIP FACILITATORS AS A COORDINATOR OR SUPERVISOR OF THAT WORK.”.**

A concurrent resolution to commend the Five Healthy Towns Foundation on its efforts to cultivate personal and community health and wellness for residents in their service area within the state of Michigan.

Whereas, April is National Move More Month and nutrition is a strong focus of the Five Healthy Towns Foundation; and  
Whereas, Healthy living, including good nutrition and an active lifestyle, prevents and delays chronic disease including diabetes, heart disease, some cancers, stroke, and others; and

Whereas, More Michigan residents smoke and our population is more obese than the national average, contributing up to 75% of the personal and financial cost of chronic diseases in Michigan; and

Whereas, Michigan spends more than \$13 billion per year in unnecessary health care costs, much of which is related to smoking and obesity; and

Whereas, The state of Michigan and its Legislature are committed to the prevention of chronic disease; and

Whereas, In the Governor's Health and Wellness Message, in September 2011, he stated, "Our vision is for Michiganders to be healthy, productive individuals, living in communities that support health and wellness, with ready access to an affordable, person-centered, and community-based system of care"; and

Whereas, Healthy living includes proper nutrition, regular physical activity, avoiding tobacco and other unhealthy substances, as well as a connection to a community; and

Whereas, Five Healthy Towns Foundation engages their community to facilitate healthy living by supporting and managing four Wellness Centers dedicated to health and wellness activities, education, prevention, and community edification; and

Whereas, Five Healthy Towns Foundation engages communities to support healthy living through grassroots coalitions to encourage healthy choices like eating better, moving more, avoiding tobacco and other unhealthy substances, and making healthy connections in their community; and

Whereas, Five Healthy Town Foundation engages with governmental and other state agencies and organizations to support healthy living including the Department of Natural Resources, Michigan Fitness Foundation, Michigan Health Endowment Fund, Department of Transportation, Michigan State University Extension, Department of Education, Healthy Kids Healthy Michigan, Michigan Farmer's Market Association, and others to cultivate personal and community health and wellness; and

Whereas, Living healthy will improve the quality and satisfaction of the lives of Michigan's citizens; now, therefore, be it Resolved by the Senate, That we recognize the importance of healthy living and the importance it holds for residents of Michigan; and be it further

Resolved, That we commend the Five Healthy Towns Association on its efforts to ensure healthy living for residents of Michigan.

Pending the order that, under rule 3.204, the concurrent resolution be referred to the Committee on Government Operations, Senator Kowall moved that the rule be suspended.
