## Senate Concurrent Resolution No. 41.

A concurrent resolution of tribute offered as a memorial for George H.W. Bush, Forty-first President of the United States. Whereas, It was with great sadness that the members of the Michigan Legislature learned of the passing of President George H.W. Bush. A war hero, patriot, and statesman, his commitment to service and American values left a lasting impact on the citizens of this state, the people of the entire nation, and the international community; and

Whereas, President Bush's remarkable life of service began at a young age, enlisting in the Navy on his eighteenth birthday just months after the bombing of Pearl Harbor. He came to be one of the Navy's youngest aviators, flying missions in the Pacific Theater, including one in which he was shot down in 1944. He returned stateside at the end of the war, enrolling at Yale and marrying Barbara Pierce, his wife of 73 years. After graduation, he moved to Texas and became an extremely successful businessman; and

Whereas, The call to serve his fellow citizen was too great for George H.W. Bush to remain in the private sector. After losing a race for the United States Senate in 1964, he was elected to the first of two terms in the United States House of Representatives in 1966. After another failed Senate bid in 1970, President Richard Nixon tapped him to serve as the United States Ambassador to the United Nations and then chair of the Republican National Committee. President Gerald Ford then named him Chief of the Liaison Office in China, and later Director of the Central Intelligence Agency. After losing the 1980 Republican presidential primary, George H.W. Bush accepted his party's nomination for Vice President, a position he held during both terms of the Reagan Administration; and

Whereas, George H.W. Bush won a decisive victory in the 1988 presidential election, including earning the support of nearly 54 percent of Michigan voters that year. As the 41st President of the United States, he will be most remembered for his exemplary stewardship of American interests on the world stage. He led the Free World during the reunification

of Germany and the breakup of the Soviet Union, and deftly shepherded an international coalition that repelled Saddam Hussein following the Iraqi invasion of Kuwait. At home, President Bush championed fiscal responsibility, worked hard to pass protections for Americans with disabilities, and celebrated volunteerism. In the years following his presidency, he worked on numerous humanitarian causes, often side by side with former political rivals; and

Whereas, A true exemplar of the Greatest Generation, President Bush served his country and his fellow citizens at every opportunity. His integrity, decency, civility, and seriousness have been a model for the generations of Americans who followed him into public life; now, therefore, be it

Resolved by the Senate (the House of Representatives concurring), That we offer this expression of our highest tribute to honor the memory of George H.W. Bush, the Forty-first President of the United States; and be it further

Resolved, That copies of this resolution be transmitted to the Bush family as evidence of our lasting esteem for his memory.

Pending the order that, under rule 3.204, the concurrent resolution be referred to the Committee on Government Operations, Senator Kowall moved that the rule be suspended.

My friend the Majority Leader spoke very eloquently and summed up the legacy President Bush very well. Prior to President Bush's death, I was reading John Meacham's book *Destiny and Power: The American Odyssey of George Herbert Walker Bush.* For those who haven't, it's a very good summary of a pretty amazing life.

Today we honor and remember George Herbert Walker Bush and his lifetime of service to our nation.

As the memorials have come in this week, we've heard the 41st President described as a listener, as kind and gentle, and as someone who took the Oath of Office seriously, but not himself.

He stuck to his principles and his priorities, and he went toe-to-toe with others in debates over the direction of our country, but he treated others with respect while doing so. At the end of the day, he could see the person beyond their politics. Those aren't always the qualities you expect people to appreciate in a President. I believe we value him for those quieter characteristics because they are some of the qualities our political discourse needs the most.

As we continue to have robust debate in this chamber, we should reflect on President Bush's legacy that, no matter how high the office, we must follow the Golden Rule and continue to give the kindness that we hope to receive. I hope that his family and loved ones can remember the good times with a pretty amazing man.

#### **General Orders**

Senator Kowall moved that the Senate resolve itself into the Committee of the Whole for consideration of the General Orders calendar.

The motion prevailed, and the President, Lieutenant Governor Calley, designated Senator Knezek as Chairperson.

After some time spent therein, the Committee arose; and the President, Lieutenant Governor Calley, having resumed the Chair, the Committee reported back to the Senate, favorably and with a substitute therefor, the following bill:

## Senate Bill No. 1197, entitled

A bill to amend 1952 PA 214, entitled "An act authorizing the Mackinac bridge authority to acquire a bridge connecting the upper and lower peninsulas of Michigan, including causeways, tunnels, roads and all useful related equipment and facilities, including park, parking, recreation, lighting and terminal facilities; extending the corporate existence of the authority; authorizing such authority to enjoy and carry out all powers incident to its corporate objects; authorizing the appropriation and use of state funds for the preliminary purposes of the authority; providing for the payment of the cost of such bridge and in that connection authorizing the authority to issue revenue bonds payable solely from the revenues of the bridge; granting the right of condemnation to the authority; granting the use of state land and property to the authority; making provisions for the payment and security of such bonds and granting certain rights and remedies to the holders thereof; authorizing banks and trust companies to perform certain acts in connection therewith; authorizing the imposition of tolls and charges; authorizing the authority to secure the consent of the United States government to the construction of the bridge and to secure approval of plans, specifications and location of same; authorizing employment of engineers irrespective of whether such engineers have been previously employed to make preliminary inspections or reports with respect to the bridge; authorizing the state highway department to operate and maintain such bridge or to contribute thereto and enter into leases and agreements in connection therewith; exempting such bonds and the property of the authority from taxation; prohibiting competing traffic facilities; authorizing the operation of ferries by the authority; providing for the construction and use of certain buildings; and making an appropriation," (MCL 254.311 to 254.332) by amending the title, as amended by 1992 PA 120, and by adding section 14.

Substitute (S-2).

The following are the amendments to the substitute recommended by the Committee of the Whole:

- 1. Amend page 3, following line 15, by inserting:
  - "Sec. 1. As used in this act: the following words and terms shall have the following meanings:
- (a) The word "authority" shall mean "AUTHORITY" MEANS the Mackinac bridge authority created by Act No. 21 of the Public Acts of the Extra Session of 1950, being sections 254.301 to 254.304, inclusive, of the Compiled Laws of 1948:IN 1950 (EX SESS) PA 21, MCL 254.301 TO 254.302. THIS SUBDIVISION DOES NOT APPLY TO SECTIONS 14A, 14B, 14D, AND 14E.
- (b) The word "board" shall refer to "BOARD" MEANS the members of the authority. THIS SUBDIVISION DOES NOT APPLY TO SECTION 14B.
- (c) The word "bridge" shall mean "BRIDGE" MEANS the project for the acquisition of which this act is adopted and shall mean MEANS a bridge or structure extending from the upper peninsula UPPER PENINSULA to the lower peninsula LOWER PENINSULA of Michigan, and shall be understood to include INCLUDES all of the following forming any part thereof OF THE BRIDGE or connected with or used or useful in the operation thereof, OF THE BRIDGE, causeways, bridges, tunnels, roads, fills and approaches, or any combination thereof, parking space and facilities, park and recreation

facilities, lighting facilities, terminal facilities consisting of areas, structures, and buildings in whch [sic]-WHICH rest rooms, waiting rooms, restaurant and similar facilities, and other accommodations for the traveling public may be installed, including all fixtures, utility lines, accessories, and equipment relating to any or all of the above, and including the improvement and beautification of such-terminal areas at each end of the structure as may be designed to increase the use thereof, OF THE STRUCTURE, and including in all of the foregoing-all real and personal property, tangible or intangible, licenses, franchises, easements, and rights-of-way necessary thereto.

- (d) The term "cost of the bridge" shall include-"COST OF THE BRIDGE" INCLUDES all expenditures made in connection with the acquisition and construction thereof, OF THE BRIDGE, financing charges, interest to accrue on the bonds during the period occupied by the construction of the bridge and for such-A period thereafter AFTER CONSTRUCTION OF THE BRIDGE as may be determined by the board, the aggregate of such periods, however, not to exceed 7 years, cost of engineering and legal expenses, plans, specifications and surveys, other expenses necessary or incidental to determining the feasibility of the project, the cost of all land, property, rights, easements and franchises, reimbursement of all money which THAT may have been heretofore or may hereafter-WILL be paid or advanced by the state of Michigan or any of its agencies, departments, or subdivisions, for any of the foregoing, and all other expenses properly incident to the acquisition of the bridge and the issuance of the bonds.
  - (e) The words "the state" shall mean-"THE STATE" MEANS the state of Michigan.
  - (f) The words "the bonds" shall mean "THE BONDS" MEANS all bonds authorized to be issued by this act.
- (g) The words "to construct" shall mean "TO CONSTRUCT" MEANS to acquire through construction, purchase, gift, condemnation, or any combination thereof.".

#### Senate Resolution No. 203.

A resolution of tribute for the Honorable Mike Nofs.

Whereas, As the Ninety-ninth Legislature comes to a close, the members of this legislative body are honored to pay tribute to Senator Mike Nofs for his years of service. Over the span of his career, he has exhibited commitment and dedication to his constituents of the Nineteenth District as well as citizens throughout this state; and

Whereas, Mike Nofs brought a rich and diverse background of experience and knowledge to the Senate that includes a 30-year career in law enforcement at the city, county, and state levels, including 25 years with the Michigan State Police. He also served as a member of the Calhoun County Board of Commissioners where his leadership contributed to the implementation of innovative programs that assisted victims of sexual assault and with seniors in need of prescription drug coverage; and

Whereas, In 2002, Mike Nofs was elected to the House of Representatives. Known for his adeptness at working in the spirit of bipartisanship, he ushered at least a dozen bills into law, most notably the rewrite of the Telecommunications Act and the 2008 energy package; and

Whereas, First elected to the Senate in 2009, Senator Nofs served as chair of the Energy and Technology Committee for eight years and vice chair of the Banking and Financial Institutions Committee for four years. Over the last four years, he has been a member of the Appropriations Committee and served as chair of the State Police and Military Affairs Subcommittee. He has also been a member of committees dealing with commerce, tourism, economic development, and human services issues during his tenure. Under his leadership, legislation was enacted that established a long-awaited comprehensive energy plan in 2016; now, therefore, be it

Resolved by the Senate, That we offer this expression of tribute to commend and thank the Honorable Mike Nofs for his notable contributions to this legislative body and to our state; and be it further

Resolved, That copies of this resolution be transmitted to Senator Nofs as evidence of our gratitude and best wishes.

The resolution was adopted by a unanimous standing vote of the Senate.

Senator Nofs asked and was granted unanimous consent to make a statement and moved that the statement be printed in the Journal.

Senator Nofs' statement is as follows:

Before I start, Mr. President, I'd like to say "thank you very much." I had a surprise retirement party last Friday night, and you were one of the guest speakers there and I want to publicly thank you and the Governor for the nice words you said at that party with all my family and friends involved. Thank you very much.

I want everyone to know that the last ten years of my life have really been exciting, fulfilling, and rewarding to me personally. My time in the Senate Chamber has been amazing. First, I'd like to thank the citizens of the 19th Senate District for giving me the tremendous honor of serving them and the state of Michigan. It truly has been humbling and something I will never forget. When I first got here, I never imagined that one person, working with so many other elected officials, could accomplish so many good things for our state. We, all of us, were so fortunate that we were all elected to this office at the same time. There are so many good and talented people who I was able to work with here, and what a blessing it was for me.

Now, I must say something about the leaders I worked under, and I had three. As you know, I had a couple extra years other than the normal eight-year, two terms. The first was Mike Bishop. Mike Bishop showed me how to honor and respect this institution and how we are so fortunate to be elected to it. He loved this institution and taught me to never forget that we are only here for a short period of time, so respect it and enjoy it. Then came Randy Richardville. It was amazing how he led our diverse group without losing it himself at times. He truly tried to work with everyone, and usually did. Only a special person can do that. Then there's our current leader, Arlan Meekhof. The reason I love this guy is that philosophically, we were not always on the same page, but as a true leader does, he set high expectations and stood by his promises. He said that committee chairs would have the power and the authority to run their individual committees. A lot of leaders say that, but few follow through and mean it. It was a pleasure running a committee under his leadership. He never ever let me down. Arlan, thank you for honoring your word, even when the pressure got tough. You always allowed me to run with the issue, so thanks for believing in us.

There are a few Senators who served with us in our first term, or at least my first term, who taught me so much. Such good people are so very smart. I'm talking about my friends for life. Senator Bruce Patterson, I learned so much from him and how to run a committee and to be a successful chairman. When I was chairman of the Energy and Technology Committee in the House of Representatives, he always worked with me and I was able to run with my ideas and we were able to get the job done. He never would let me fail. He offered such good and subtle advice that he could lead you in the right direction without saying it outright. I loved being around him. It was so much fun to watch how he operated his committee over here in the Senate and worked with people. Sometimes very, very entertaining. Thank you, Bruce. You inspired me all these years and I'm not sure that you realize that. One of my best friends, who deserted me four years early, former Senator Bruce Caswell—I think Bruce is up in the east Gallery today. Bruce, you were so full of knowledge and wisdom when I learned so much sitting next to you in caucus. I saw from time to time how you poured your heart out on an issue that you cared about so much because it affected someone back home in your district. You were such a good advocate for the people you served. You never gave up and you always cared. The friendship we shared will last, my friend, forever, but I'm still mad at you for leaving one term early and I've really missed you these last four years in caucus.

Next, I want to mention my Appropriations chairman, Dave Hildenbrand. You too let me run my subcommittee with little or no intrusion, and yet you guided me well. You too are a man of your word. I'm so glad that some of your goals matched up with some of mine very well. You really do care about the veterans of this state and our men and women who serve us in our military. With you, they'll have homes to reside in and the quality of care has risen significantly under your leadership. Also, your concern for the men and women of the Michigan State Police, of whom there are several up in the east Gallery also here today. Under your leadership, we have given that department what they needed and the changes that we make allows them to deliver the service our citizens want and deserve, so I truly thank you, Dave.

I must mention Senator Pat Colbeck. Thank you for putting in place a measured outcomes budget for the Michigan State Police and the Department of Military and Veterans Affairs before I became chairman. Most in those departments did not like the change, but in the end both departments knew what was expected of them and the service that our citizens expect from them and it became so much better. Thank you, Senator.

Now, to our support personnel who make us look so good. They are the brains behind the scene, like Bruce Baker from the Senate Fiscal Agency who knows these budgets inside and out. Without you and your expertise, we wouldn't know the history behind the numbers, Bruce, and I'm so glad that you were around so long. You provided immeasurable help to me as a new chairman learning the job, so I want to say thank you. Then, there's the policy person for those committees and the numbers. Her name is Stephanie McGuire. Stephanie, you made sense of some of the crazy ideas we came up with and you actually were able to put the ideas into words and help me get across what we were trying to do in that committee. I'm not sure where she is, oh there she is behind me. Thank you Stephanie. Then there's Dan Dundas—where's Dan? Right next to her. Dan has a great way of questioning you and what you're doing and then asking, "Is that what it does?" You were the person I could trust to test my ideas, if I had the votes or not, and if they were good

ideas to run with. Man, sometimes you made me think too much though. On the way home, I would think and think and think about what you said and I worked hard once I got home to make sure I had the votes and it was saying what it was supposed to say. I want to say thank you very much and the committee is so much better with your service and how you were able to do it so professionally and make an impact, so thank you very much.

Those of you who served on the committees I chaired, I want to thank all of you. I think we showed everybody how we could work across the aisle and do good committee work. I want to start with my quiet vice chair, Senator Hoon-Yung Hopgood—so honest, principled, and just a polite guy. Hoon, did I say quiet? A guy who always had no surprises for me, it was a pleasure to work with you in the excellent job we were able to do two years ago on that energy bill so thank you for all your help. Also on that committee, on and off, we had Senators Bieda, Conyers, Knezek, and Young. Well, everyone's talked about it. Senator Young, it was so much fun having you on that committee. I was so jealous when you would get up, and then you would come back with a bag of chips, then a sandwich, and later on you even got up and went to the bathroom. I was jealous because I wanted to do the same but being chairman, you just can't do that sometimes. Also on the committee was Senator Shirkey this last term, who in the beginning I thought I was going to have bumpy ride with. But, in the end we too worked out our differences on the legislation and were able to agree on a final product most of the time. You need people like Mike to make good legislation better, so Michael, thank you very much for being on that committee. Then four more important committee members who I always knew would listen for themselves and always do the right thing, my good friends Senator Tonya Schuitmaker, Senator Joe Hune, Senator Horn, and Senator Zorn—try to say that five times real quick. So much fun to work with all of you on that committee and I want to thank you for taking some tough votes sometimes on some of the legislation we had to do, and I hope that in the end—I know in the end—we did good policy and I don't think any of us suffered for it. And then, my long-time best friend, my wingman, my vice chair, Senator John Proos. I knew I could give John any assignment and he would come back to the committee with a perfect end piece to put on the bill or a standalone bill that he would author. It was perfect for the goals that we had established on the policy and where we were going. John could go out in the hallway, he could go out before groups back home in any of our districts and articulate the proposed policy so very well. Also, I never had to worry about John's support, mostly because we agreed on the major concepts. You were so important to me, John, over the years on the Energy and Technology committees in both the House and the Senate. I'm sorry you never got to be chair, but you really were in that position with me, whether you knew it or not, so thank you, my friend.

I'm proud of the bipartisan work we did here in this chamber working on the energy future. At the beginning of that discussion, I was told, "Mike, you did it in 2008, but you'll never be able to do it again in 2016." They didn't know that we had such a good committee, so thank you, all of you, who were involved in making that happen.

Now, I must say something about the good people who must stand out in the hallway and listen to us and be disappointed most of the time when they don't get their own way in this chamber. It is a tough job out there, but in a term-limited environment, you teach us new legislators so much. You have so much knowledge to offer on the institution and what has been tried before. I have too many friends out there that I can't mention all of you and I'm sorry if I don't give you a shout-out at this time, but I would like to mention a few. I want to start with Tom Hoisington. You don't know this, but the outline of the 2008 energy legislation was written on a napkin down at Troppo. Yes, Tom and I talked at the very beginning before it was all started and what that bill might entail. Through the years up here in Lansing, I was blessed to work with him before he retired. What a great guy. Then there was Dave Mengebier. I also remember our first meeting in Battle Creek where we talked about the energy legislation and got to know each other. Another amazing individual. Then there's Renze Hoeksema and Steve Young, pretty good golfers some of the time, but always a lot of fun all the time and so knowledgeable on the issues, always respectful, and would always listen to you and then they would give you some advice. You two are such good friends and always will be. And then there's Rich Studley. Now Rich—I was going to say "hard-ass" but I put in my notes "hard head" sometimes—but in the end, he always wanted what was good for his membership in the state of Michigan. Some of the positions he took on the energy bill did not make his membership happy, but he knew it was the right thing to do. That's the kind of man he is. There are so many others: Jim Ryan, Bill Wortz, Becky Bechler, Chris Horak, Jim Murray, Matt Groen, Jimmy Weeks, Bob Hantz, Jennifer Greenburg, Sue Schlaybaugh, Jim Paggett, and my former chairman in the House of Representatives on Energy and Technology, Frank Accavitti. What a pleasure it was working with all of you and I'm going to miss you.

Finally, I have to mention some others who worked with me starting back in the House with LSB and the Michigan Public Service Commission: Steve Transeth and Greg White—more amazing people. They taught me so much about energy when I first came to the scene. I knew nothing about energy except that if you stuck your finger in the socket, you'd get a shock. Both moved on, but we never lost contact, especially Steve Transeth who helped me in an enormous way in the 2016 energy legislation. The bill never would have made it through without his expertise. It's also important for me to recognize Kevin Studebaker and Tom Valli, the drafter tasked with turning our ideas into law with these very complicated issues. They both have put in long hours over the years to make sure that we got the language right, so I want to say thank you to them.

Now we all know that once legislation is passed, somebody has to implement it. In energy, that's the Michigan Public Service Commission. Chairwoman Sally Talberg and her tremendous staff worked so hard and do an amazing job implementing the legislation as they see fit. Thank you, all of you, for everything that you do at that agency and the hard dedicated workers you have underneath you.

All those Senate policy people, Senate Fiscal people, and the Secretary of the Senate, Jeff Cobb, and his staff, thank you as you all have been a pleasure to work with, but I must say a special thank you to the dedicated men who protect us each and every day here in the Capitol. Mike Ferland and his dedicated professional staff are so enjoyable to work with. Each one is friendly but yet effective in protecting us, like yesterday here at the Capitol. We know that we are safe whenever you or your staff are around; even in our home districts, we know you're not far away, so thank you and thank you to your men in the service to us over these last eight years.

I must give a shout-out to the "vulnerables" and the guy who helped us "vulnerables" get here, John Llewellyn. We "vulnerables"—Jack Brandenburg, I think Tory Rocca, Tom Casperson, and Goeff Hansen, I don't know if I left anybody else out, David Robertson, yes, Dave—we worked hard to get here and I'm so thankful that we all made it. I have enjoyed getting to know each and every one of you and becoming good friends with each of you, so thank you very much.

Finally, I want to acknowledge my staff who have done such a great job for the 19th Senate District and me. While I have been in the Senate, I have been blessed with people who work in my office that are just over the top. Let's start with the individuals who are no longer working here. First, my chief of staff and director of legislation Greg Moore, and Greg's up in the balcony. I would not be as successful as I have been without you, Greg. I would not be the person that I am without you. To me, you're like a younger brother. You're unbelievable. When I go home for the night, I'd get most of my work done after 11 p.m. in my computer room. Everything was quiet, everybody was probably in bed, and I'd do my e-mails and messages and I'd send some of the e-mails to Greg at his e-mail address and tell him something that needs to be looked at and if he could help me out with it. Right away, I'd get a response and it would be Greg saying, "I've got that boss. I'll take care of it." I'd text back and say, "Greg, it's 2 o'clock in the damn morning. Get your butt to bed. I've got to pick you up in four hours. We're going to work." But that was Greg. I cannot tell you enough about all the stuff he did for me. I really do love you like a brother. Thank you. Also Carmen Siciliano—I love saying the name Siciliano, so much fun, Siciliano, Siciliano, Siciliano. When Greg left my staff, Carmen stepped right up and went from director of constituent services in my office to chief of staff and did so without missing a beat. He jumped right into the energy fray and even the 5G bill that we just got done, and all the committees I chair and the work that we did. Everyone up here right away learned, Carmen, you were not going to be an easy pushover. He reads everything, he keeps me informed, and he gives me a heads-up whenever it's warranted, and believe me, he's tuned in, and the rumor mill has helped us a lot, and you've done well. You're such a good man, Carmen, and I appreciate everything you do for me each and every day.

Then there are others who worked for me before and I think they're up in the Gallery, like Drew Beardslee, a young guy who kept the office going and a lot of fun. There he is, Drew. Dedicated and always willing to do what was asked, and we always teased him because he was a young guy and we're an old group in my office, and he was the young one who kept us alive and jumping and smiling and had a lot of fun. Thank you, Drew, for everything you've done. Then there's Steve Sachs who helped me in my special election for the Senate seat. If you remember, we Republicans got our butts kicked in 2008. We had the special election and I happened to be the candidate representing statewide whether or not the Republicans could win, and I know every county in this state worked really, really hard, working every precinct, including in the U.P.—I got calls back then where they would adopt a precinct and try to call the people in that district—and so I want to thank everyone here, especially Steve Sachs who coordinated all that and worked so hard day and night to make sure that we were successful, and I'm glad he was. Thank you to all your districts or anyone who helped me.

Finally, we all know the person who runs the office is the director of administrative services for our offices, otherwise known as the gatekeeper and the boss, Patty Pastor. She has been with me since the beginning. She does all the tedious jobs in the office like letter-mailing, phone calls, and finances to keep us afloat, everything. She has also had to deal with all of us men in the office. Her smile and wit was always refreshing. Such a wonderful person who has blessed us and given us so many fond memories, especially birthday and holiday parties, and we even had her give Senate tributes from time to time, and she doesn't like public speaking, but she ran all of the golf outings we had every year, and everybody up here in Lansing said it was the best golf outing every year and they looked forward to it and were kind of upset when we stopped them a couple years ago. You did a great job, Patty. I want to thank you and appreciate everything you've done. You made life so much fun and enjoyable, we all appreciate you for the sweet person you are.

Now I'd like to thank my family, my mom and dad who left us within the last six years, my brothers and sisters—I come from a family of eight brothers and sisters, I'm a twin in the middle and have a twin sister—their husbands and their children, and my two sons, Michael John Nofs and Matthew Scott Nofs and their families, and my friend Sharlie Jones. They all helped me get elected and came to my golf outings and my two sons who lost out having their dad attend so many of their events while they were growing up in school. Thank you for understanding, and I know that your dad was not always there, but I tried to get to as many as I could. For that, I am sorry. But I will now be retired and your dad will be at everything, so get ready.

Finally, I have to tell you the one special moment I had up here in the 16 years that I've been up here. It was back in 2009 after I was elected in that special election, and it was Veterans Day. We, at the time, the Republican group, were doing a package of bills for veterans and because I was the vulnerable, Jack, they made me the lead speaker in the rotunda for the press conference. A ton of people showed up, a lot of veterans, and I was nervous. I got up there. Greg Moore did a great job on my speech. I did what I usually did—I'd start going on the speech and then I forgot everything and just went off on my own. The reason I went off is because I wanted to touch that group and I told a story about my dad who

was a World War II veteran who was on a minesweeper in the South Pacific and a kamikaze plane dive-bombed and sunk the ship. As soon as that plane hit the ship, they were in the water in five minutes. My dad was a good swimmer, he was even a coach and taught us all how to swim. He was 17 years old at the time and one of his friends next to him starts screaming and hollering as the ship was going down that he couldn't swim. My dad has his life preserver on, took it off, and gave it to the other man. My dad then treaded water for four hours. I know it because in the *Port Huron Times*, the paper, there was a story I found one time when I was helping him clean the basement. He never talked about it much, but it talked about James Bernard Nofs treading water for four hours and then finally swimming toward a diesel smokestack on the horizon that was another ship. He was one of the first ones who survived. Going back to the package of bills, when I was up there on the podium talking I looked out in the crowd and my dad was in a wheelchair at the time and I saw him and made contact with him in his eyes. I could tell how proud he was of his son. I then told that story about him and what veterans of World War II and that great generation went through and how blessed we were for all the sacrifices they made. At the end, I went out to talk to my dad in the crowd. He gave me a hug and he said, "Michael, I am so glad that I was able to live that day so I could watch you today." It's the best moment I've had up here in this building, and it's a blessed building, but I'll never forget that and I'm so thankful for him, my mom and dad, and my family.

Finally, I'd like to thank everybody for all the good times and memories they shared with me. You have enriched my life being you and accepting me for who I am. I'm going to miss all of you. In our family, we never say "goodbye"—I think someone else said this in their speech—in our family, we say "so long. So long until we meet again." So I want to say, so long. Thank you. God bless each and every one of you, and I really do appreciate all of you. Thank you.

In 2007, he accomplished a long-time goal to complete his education by completing the Return to Work Program at Madonna University, earning a bachelor's degree in criminal justice; and

Whereas, Senator Gregory first joined the Michigan Legislature in 2009 upon his election to the House of Representatives. He was first elected to the Senate in 2010 where he served as minority vice chair of the Appropriations Committee and several Appropriations subcommittees: Capital Outlay, Health and Human Services, Corrections, and State Police and Military Affairs. He also served as a minority vice chair of the Families, Seniors and Human Services, the Veterans, Military Affairs and Homeland Security, and the Oversight committees. He dedicated a lifetime of service to the public, and as a member of this esteemed institution worked to advance the concerns of veterans and vulnerable populations around the state; now, therefore, be it

Resolved by the Senate, That we offer this expression of tribute to commend and thank the Honorable Vincent Gregory for his notable contributions to this legislative body and to our state; and be it further

Thank you Madam President and members for allowing me this opportunity to express my most humble gratitude for the privilege to have served with you in the Senate.

I want to begin by expressing my love, heartfelt gratitude, and appreciation to my lovely wife and partner, Yvonne—who is here with me today—for allowing me to follow my heart and supporting me in every endeavor along the way. I also want to say a special thank you to all my children, some of them are here in the west Gallery: Lawrence, Troi, Vanessa, Cortney, and Kristen; and my nine grandchildren: Lawrence, Kelsey, Elijah, Caiden, Eric, Caleb, Kaylin, Reagan, and Kaylie—Kaylie is the youngest one here today. Thank you for your unfailing love and support. I wouldn't be the man I am today without you. I'd like to say a special prayer for our son and my namesake, Vincent Jr., who passed away a few months before I took office in the Senate. I love you all with all my heart and thank you for your unfailing and everlasting support.

This day seems to have come much too quickly. When I arrived to the State Capitol Building, I had many goals, ambitions, and an indelible determination to do good—I'm sure as most of us all have—and to solve all the problems facing the state; to make a difference in the lives of the people who elected me to represent them in Lansing; and to leave a mark that would live on into the future.

Having served in the House for one term and two terms in the Senate, I can now look back over these past 10 years with a different perspective and a new appreciation for this process. During my tenure in the Legislature, my goal was to be a passionate champion for my district, for veterans, for police officers, and residents throughout the state. I wanted to be a strong voice for the people in the 14 communities that compromise the very diverse 11th Senate District in Oakland County. I trust I have served them well.

In all matters before this body, I chose to speak when necessary, but to be firm and expeditious in my decision-making to ensure order. Some called me soft spoken and a man of few words. Today, I promise will be no different. I promise to be as brief as I possibly can.

As the Senate minority vice chair of Appropriations, I worked tirelessly to extend needed programs and assistance to help women, families, and children in our communities. I pushed for fair and equitable treatment of workers, veterans, seniors, and fought on behalf of those in need. I sought to ensure that Michigan would be a state where all its citizens would have fair access to opportunities and can enjoy the fruits of all our programs. I want to thank Chairman Dave Hildenbrand for all his support and his friendship.

I knew it was important to be impartial and decisive while working on sensitive issues, and I would strive daily to work with my colleagues across the aisle on important and life changing issues impacting our communities. These past eight years have been met with many difficult but oftentimes necessary decisions. My focus was to provide the citizens of Michigan with a quality of life, improving our infrastructure, maintaining a strong economy while providing adequate social safety nets for the less fortunate among us. I strove daily to write and pass meaningful legislation that addressed real issues and problems facing our constituents. Some of those included my first bill that was signed into law. That was for overseas voters to have their ballots sent electronically.

There were also bills to revise assessment of commercial rental property, provide counseling programs for children found to be victims of human trafficking; to extend the date by which certain doctoral programs must receive certain designations or accreditations, notifications to the children's ombudsman regarding death of a child who is a ward of the state, and provide a tax credit for home modifications for the disabled. This bill has been the one I wanted to get done more than others. In the eight years that I have been here, I ran this through the first time and all of you, my Senate colleagues, supported it. It didn't get through the House. We ran it again the second time, and again, my colleagues here and Chairman Brandenburg pushed the bill and helped me with it. We got it through again in the Senate, it is now in the House, and I'm hoping that the House will get a chance to hear this bill before the session ends. I'm still holding out hope that they will get a chance to do that. Also, I had a bills to expand service bonuses for certain Vietnam veterans, to create a credit for certain employers that provide employment for veterans, and to create a specialty plate to recognize women veterans.

I'm very proud to say that I was appointed to the subcommittee for Medicaid expansion, and was a part of helping over 600,000 Michiganders gain healthcare. These were just a few of the things I was involved in, trying to make a difference. I personally want to thank Senator Nofs, who just spoke about the veterans, for his help with getting some help with veterans in this next budget. Thank you, Senator Nofs.

While serving in the Senate, I am most proud to serve as co-chair of the Senate Legislative Breakfast, to have the opportunity to break bread with my colleagues, past and present, and to share some of our more personal and intimate thoughts and aspirations. I am grateful to be a part of this amazing group. I joined this group, and because of the Senate Legislative Breakfast, I learned a lot more about my colleagues than I would have ever known. When I became to co-chair, the other co-chair was Senator John Moolenaar. He wanted to not just be a co-chair, but he wanted to get to know each other. He said to me, "How about we meet in your district of Southfield. I will come out to Southfield and we will spend a day together." That's exactly what we did. I got a chance to know him, and I got a chance to know a lot of other people because of the Senate Legislative Breakfast. For that, I will always be grateful.

I want to say a special thank you to Senate Minority Leader Jim Ananich for his strong leadership of this caucus, and also his friendship. Also, a special thank you to Majority Leader Arlan Meekhof for his tenacity and leadership of this body, to strive to serve the citizens of Michigan with dignity and conscience of mind. Indeed, we may have been on opposite sides on many issues—and we were on many issues—but I know we made significant gains in recent years and that there remains much left to be done.

I have met and worked with some amazing people in this legislative journey. I want to express my sincere appreciate for the work of my staff. My chief of staff and constituent relations director, Karen Adams-Powell, who has been my solid rock, my right hand, and who has kept me together over the past eight years. Madelyn Day, who assisted me while she served on the Senate Dem Policy staff and later became my legislative director, a position she has served me well in over the past four years. My receptionist and scheduler, Tina Magee, who keeps me on track each and every day, who greets visitors in the office, and whose voice welcomes each caller. To my district liaison, Charles Robinson, my long-time friend and commuting partner who keeps me in the loop with all the happenings in the community. And, to those who have assisted me along the way, including Victoria Spector, who started this legislative journey with me in the House and transitioned to the Senate as my chief of staff. Without you and would still be lost. To my former legislative assistant, Spencer Tobias, I will always be grateful for your eagerness and willingness to do whatever it takes to get the job done.

To the staff of the Senate Fiscal Agency, Senate Democratic Policy and Communications staffs, Legislative Service Bureau, Secretary of the Senate's staff, and the Sergeants who keep us safe, thank you all so very much for your work, assistance, and support. A very special thank you to the Secretary of the Senate, Jeff Cobb, who was involved in the process of getting the portrait of the first elected African-American to be placed in the Capitol. Jeff contacted me early on about this and had me involved in this process, and for that I will always be grateful. Thank you, Jeff.

As I summarize my farewell, I want to thank each and every one of you, my Senate colleagues. It has been my utmost privilege to walk this walk alongside you, to graciously serve with you, and for the comradery you extended to me. I want to mention my good friend, Senator Morris Hood. We have traveled many journeys together, and I have a feeling that this won't be the last one. Also, my Oakland County colleague, Senator Mike Kowall, thank you for your friendship and your support. I wish everyone well in the future.

Lastly, as we leave these walls and hand over the responsibility to the next class, I say to those of you who will be here the next four years, please continue to create good jobs for our workers and provide adequate education so our students are ready to take on those good jobs. Please continue to maintain quality and affordable healthcare and give Michiganders the care that they deserve. Of course, these issues are complex and there is no straightforward way to address them all. Facing up to them will involve compromise and making trade-offs. But if there is one phrase I'd like to leave, I would have to steal it from my dear friend, Governor-elect Gretchen Whitmer, and that is "Let's get it done."

It has been my honor to serve this body, to represent the 11th Senate District, and to maintain the trust that the people of the state of Michigan have in this government. With that, I will say, "Thank you."
