

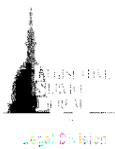
HOUSE BILL NO. 4684

May 28, 2019, Introduced by Reps. Vaupel, Howell, Sabo, Calley, Tate and Jones and referred to the Committee on Military, Veterans and Homeland Security.

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
by amending section 803k (MCL 257.803k), as amended by 1999 PA 183.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 803k. (1) A person who was a member of the armed services
2 during the Vietnam War or a person whose spouse was a member of the
3 armed services during the Vietnam War may ~~make application~~ **apply** to
4 the secretary of state for a special registration plate ~~which~~



1 ~~shall display~~ **that displays** an appropriate vignette preceding the
2 registration numbers and ~~shall have~~ **has** the word "veteran"
3 inscribed beneath the registration numbers.

4 (2) Application for a special registration plate ~~shall~~ **must** be
5 on a form prescribed by the secretary of state, and ~~shall~~ **must** be
6 accompanied by any proof of the applicant or applicant's spouse
7 having been a Vietnam War veteran that the secretary of state may
8 require. ~~The application for a special registration plate shall~~
9 ~~also be accompanied with payment of a \$5.00 service fee.~~

10 (3) Upon proper application, ~~and payment of the \$5.00 service~~
11 ~~fee,~~ the secretary of state shall issue 1 or more special
12 registration plates for each applicant for use on a passenger
13 vehicle. A person who is disabled who ~~makes application~~ **applies** for
14 a special registration plate under this section ~~and who makes~~
15 ~~payment of the \$5.00 service fee shall~~ **must** be issued a tab for
16 persons with disabilities as provided in section 803f for his or
17 her special registration plate. The secretary of state shall
18 require the same proof that the applicant is a disabled person as
19 is required for issuance of a permanent windshield placard under
20 section 675. A person issued 1 or more special registration plates
21 under subsection (1) ~~shall~~ **must** be assessed the applicable tax
22 provided in section 801.

23 (4) The use of a special registration plate on a vehicle other
24 than the vehicle for which the plate is issued, or by a person who
25 does not qualify under this section, is a misdemeanor.

26 (5) The special registration plate issued under this section
27 ~~shall expire~~ **expires** on the birthday of the vehicle owner. ~~When new~~
28 ~~plates are issued by the secretary of state,~~ application for
29 ~~renewal of the special registration plate shall be accompanied by a~~



1 ~~\$5.00 service fee.~~ The applicant ~~shall~~**is** not ~~be~~ required to
 2 furnish the proof provided in subsection (2) **for an application for**
 3 **renewal of the special registration plate.**
