

HOUSE SUBSTITUTE FOR  
SENATE BILL NO. 1070

A bill to amend 1949 PA 300, entitled  
"Michigan vehicle code,"  
by amending section 819 (MCL 257.819), as amended by 2016 PA 280.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 819. (1) Except as otherwise provided in this section,  
2 revenue from the increases in fees provided in 1987 PA 232 ~~shall~~  
3 **must** be deposited in the transportation economic development fund  
4 established in section 2 of 1987 PA 231, MCL 247.902, and ~~shall~~  
5 **must** not be appropriated for any other purpose in any act making  
6 appropriations of state funds.

7           (2) For the fiscal year ending September 30, 1989, and each  
8 fiscal year thereafter, of the revenue from the increases in fees  
9 provided in 1987 PA 232, \$2,500,000.00 ~~shall~~**must** be deposited in



1 the state treasury and credited to the general fund, except that  
2 not more than \$1,000,000.00 ~~shall~~**must** be credited to the gasoline  
3 inspection and testing fund established in section 8 of the motor  
4 fuels quality act, 1984 PA 44, MCL 290.648.

5 (3) Except as provided in subsection (2), for the fiscal year  
6 ending September 30, 2008, of the revenue from the increases in  
7 fees provided in 1987 PA 232, \$13,000,000.00 ~~shall~~**must** be  
8 deposited in the state treasury and credited to the general fund.

9 (4) Except as provided in subsection (2), for the fiscal year  
10 ending September 30, 2009, of prior and current revenues from the  
11 increases in fees provided in 1987 PA 232, \$18,000,000.00 ~~shall~~  
12 **must** be deposited in the state treasury and credited to the general  
13 fund and for the fiscal year ending September 30, 2010,  
14 \$12,000,000.00 ~~shall~~**must** be deposited in the state treasury and  
15 credited to the general fund.

16 (5) Except as provided in subsection (2), for the fiscal year  
17 ending September 30, 2017, of the revenue from the increases in  
18 fees provided in 1987 PA 232, \$9,423,700.00 ~~shall~~**must** be deposited  
19 in the state treasury and credited to the general fund.

20 (6) **Except as provided in subsection (2), for the fiscal year**  
21 **ending September 30, 2020 only, of the revenue from the increases**  
22 **in fees provided in 1987 PA 232, \$13,000,000.00 must be deposited**  
23 **in the state treasury and credited to the general fund.**

24 (7) **Except as provided in subsection (2), for the fiscal year**  
25 **ending September 30, 2021 only, of the revenue from the increases**  
26 **in fees provided in 1987 PA 232, \$13,000,000.00 must be deposited**  
27 **in the state treasury and credited to the general fund.**
