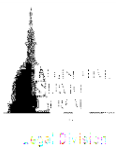

6 PROVISIONS CONCERNING APPROPRIATIONS

7 **GENERAL SECTIONS**

8 Sec. 201. In accordance with section 30 of article IX of the
9 state constitution of 1963, total state spending from state sources
10 in this appropriation act for the fiscal year ending September 30,
11 2020 is \$40,000.00 and state spending from state sources to be paid
12 to local units of government is \$0.00.

13 Sec. 202. The appropriations made and expenditures authorized
14 under this act and the departments, commissions, boards, offices,
15 and programs for which appropriations are made under this act are
16 subject to the management and budget act, 1984 PA 431, MCL 18.1101
17 to 18.1594.

18 **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

19 Sec. 301. From the funds appropriated in part 1 for project
20 ECHO opioid intervention, the department shall allocate \$40,000.00
21 to a nonprofit center for rural health housed within a 4-year state
22 university located in a county with a population between 280,000
23 and 285,000 according to the most recent decennial census for an
24 opioid response consortium in northern Michigan. To be eligible to
25 receive funding, the consortium must have a stated objective to
26 develop and implement strategies to address the opioid epidemic
27 across the Northern Michigan Opioid Response Consortium 14-county
28 region.
