## **HOUSE BILL NO. 5392**

January 23, 2020, Introduced by Reps. Miller and Hernandez and referred to the Committee on Appropriations.

A bill to amend 1979 PA 94, entitled "The state school aid act of 1979,"

by amending sections 11 and 17b (MCL 388.1611 and 388.1617b), section 11 as amended by 2019 PA 162 and section 17b as amended by 2007 PA 137.

- Sec. 11. (1) For the fiscal year ending September 30, <del>2020,</del> **2021**, there is appropriated for the public schools of this state
