

HOUSE BILL NO. 5907

June 24, 2020, Introduced by Reps. Crawford, Webber, Cambensy and LaFave and referred to the Committee on Regulatory Reform.

A bill to amend 1972 PA 230, entitled
"Stille-DeRossett-Hale single state construction code act,"
by amending sections 13e and 28 (MCL 125.1513e and 125.1528),
section 13e as added by 2005 PA 50 and section 28 as amended by

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 13e. This act does not prohibit the sharing of an
