A bill to amend 1846 RS 83, entitled "Of marriage and the solemnization thereof,"

by amending sections 2, 3, 4, and 9 (MCL 551.2, 551.3, 551.4, and 551.9), sections 2, 3, and 4 as amended by 1996 PA 324; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 2. So far as its validity in law is concerned, marriage 2 is a civil contract between a man and a woman, 2 parties, to which





- 1 the consent of parties capable in law of contracting is essential.
- 2 Consent alone is not enough to effectuate a legal marriage on and
- 3 after January 1, 1957. Consent shall must be followed by obtaining
- 4 a license as required by section 1 of Act No. 128 of the Public
- 5 Acts of 1887, being section 551.101 of the Michigan Compiled Laws,
- 6 1887 PA 128, MCL 551.101, or as provided for by section 1 of Act
- 7 No. 180 of the Public Acts of 1897, being section 551.201 of the
- 8 Michigan Compiled Laws, 1897 PA 180, MCL 551.201, and solemnization
- 9 as authorized by sections 7 to 18. of this chapter.
- Sec. 3. A man shall not marry his mother, sister, grandmother,
- 11 daughter, granddaughter, stepmother, grandfather's wife, spouse,
- 12 son's wife, spouse, grandson's wife, wife's spouse, spouse's
- 13 mother, wife's spouse's grandmother, wife's spouse's daughter,
- 14 wife's spouse's granddaughter, brother's daughter, sister's
- 15 daughter, father's sister, mother's sister, or cousin of the first
- 16 degree. , or another man.
- Sec. 4. A woman shall not marry her father, brother,
- 18 grandfather, son, grandson, stepfather, grandmother's husband,
- 19 spouse, daughter's husband, spouse, granddaughter's husband,
- 20 husband's spouse, spouse's father, husband's spouse's grandfather,
- 21 husband's spouse's son, husband's spouse's grandson, brother's son,
- 22 sister's son, father's brother, mother's brother, or cousin of the
- 23 first degree. , or another woman.
- 24 Sec. 9. In the solemnization of marriage, no particular form
- 25 shall be is required, except that the parties shall solemnly
- 26 declare, in the presence of the person solemnizing the marriage and
- 27 the attending witnesses, that they take each other as husband and
- 28 wife; spouses; and in every case, there shall be at least 2
- 29 witnesses, besides the person solemnizing the marriage, present at



the ceremony.
Enacting section 1. Section 1 of 1846 RS 83, MCL 551.1, is
repealed.
Enacting section 2. This amendatory act does not take effect
unless Senate Joint Resolution _____ or House Joint Resolution T
(request no. 02690'19) of the 100th Legislature becomes a part of
the state constitution of 1963 as provided in section 1 of article

XII of the state constitution of 1963.
