HOUSE BILL NO. 6221

September 15, 2020, Introduced by Reps. Meerman, LaGrand, Stone and Peterson and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure,"

by amending section 22 of chapter XVII (MCL 777.22), as amended by 2003 PA 134, and by adding section 49p to chapter XVII.
