And I believe that the world is in desperate need of such maladjustment. And with such maladjustment we would be able to emerge from the bleak and desolate midnight of man's inhumanity to man into the bright and glittering daybreak of freedom and justice.

And as we struggle to realize the American dream, let us realize that we do not struggle alone.'

Colleagues, these powerful words were spoken in 1965, but so relevant today. Let us pray that we can struggle together, both Republicans and Democrats, struggle together to bring bright and glittering justice and freedom for Michigan.

Colleagues, let us be maladjusted, and be aware of the flaws and imperfections in our society, and work together to recover from the pandemic and improve Michigan for everyone and make the American Dream a reality.
