

**SUBSTITUTE FOR
HOUSE BILL NO. 5734**

A bill to amend 1917 PA 165, entitled

"An act to authorize highway officials to close roads under construction, improvement or repair, or any portion of a highway whereon a bridge is being constructed or repaired; to require such officials to place in good repair and to mark by proper signs suitable detours around roads, or portions of roads, which are closed hereunder; to provide suitable barriers, and lights shall be maintained at the end of such roads or portions of roads which are thus closed and at the intersections thereof with other roads; to require the removal of signs and barriers located and placed hereunder; and to provide a penalty for a violation of the provisions hereof,"

by amending section 1 (MCL 247.291) and by adding sections 1a and 1b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. ~~The~~**Subject to section 1a, the** officials in charge of

 14 ~~includes roads and streets.~~

15 **Sec. 1a. (1) Except as otherwise provided in subsection (2),**
 16 **if the state transportation department closes any freeway or**
 17 **portion of freeway under its jurisdiction for construction,**
 18 **improvement, or repair of that freeway, a portion of freeway, or a**
 19 **bridge located upon that freeway or portion of freeway, both of the**
 20 **following apply:**

21 (a) **If the freeway is closed completely to traffic, it must be**
 22 **closed using concrete barriers or equivalent crashworthy temporary**
 23 **traffic barriers.**

24 (b) **If the freeway is not closed completely to traffic and a**
 25 **portion of the freeway is closed at any time between a half hour**
 26 **after sunset to a half hour before sunrise for work scheduled to be**
 27 **done at that time in a contract between a contractor and the state**
 28 **transportation department, concrete barriers or equivalent**
 29 **crashworthy temporary traffic barriers must separate any road**



1 workers who are present from traffic.

2 (2) This section does not apply if the freeway or portion of
3 freeway described in subsection (1) is closed for an emergency
4 repair that must be made immediately by employees of the state
5 transportation department to protect the safety of motorists. As
6 used in this subsection, "emergency repair" does not include a
7 repair performed by a contractor under a contract with the state
8 transportation department.

9 Sec. 1b. As used in this act:

10 (a) "Crashworthy" means that term as defined in the Michigan
11 manual on uniform traffic control devices.

12 (b) "Freeway" means that term as defined in section 18a of the
13 Michigan vehicle code, 1949 PA 300, MCL 257.18a.

14 (c) "Highway" includes roads and streets.

15 (d) "Michigan manual on uniform traffic control devices" means
16 the manual on uniform traffic control devices adopted under section
17 608 of the Michigan vehicle code, 1949 PA 300, MCL 257.608.

18 (e) "Suitable barrier" means a barrier that conforms to the
19 Michigan manual on uniform traffic control devices.
