## SUBSTITUTE FOR SENATE BILL NO. 500

A bill to ensure access to quality complex rehabilitation technology in the Medicaid program for people with complex medical needs; and to prescribe the powers and duties of certain state departments.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act may be cited as the "complex needs patient
  act".
- 3 Sec. 5. The department shall establish focused policies and
- 4 promulgate focused rules for complex rehabilitation technology
- 5 products and services. The focused policies and rules must take
- 6 into consideration the individually configured nature of complex
- 7 rehabilitation technology and the broad range of services necessary
- 8 to meet the unique medical and functional needs of an individual

- 1 with complex medical needs by doing all of the following:
- 2 (a) Designating specific HCPCS billing codes for complex
- 3 rehabilitation technology and any new codes in the future as
- 4 appropriate.
- 5 (b) Establishing specific supplier standards for a company or
- 6 entity that provides complex rehabilitation technology and
- 7 restricting providing complex rehabilitation technology to only a
- 8 qualified complex rehabilitation technology supplier or an
- 9 individual, company, or entity approved by the department, but only
- 10 if a qualified complex rehabilitative technology supplier is
- 11 unavailable.
- 12 (c) Requiring a complex needs patient receiving a complex
- 13 rehabilitation manual wheelchair, power wheelchair, or seating
- 14 component to be evaluated by both of the following:
- 15 (i) A qualified health care professional.
- 16 (ii) A qualified complex rehabilitation technology
- 17 professional.
- 18 (d) Maintaining payment policies and rates for complex
- 19 rehabilitation technology to ensure payment amounts are adequate to
- 20 provide complex needs patients with access to those items. These
- 21 policies and rates must take into account the significant
- 22 resources, infrastructure, and staff needed to appropriately
- 23 provide complex rehabilitation technology to meet the unique needs
- 24 of a complex needs patient.
- 25 (e) Exempting the related complex rehabilitation technology
- 26 HCPCS billing codes from inclusion in bidding, selective
- 27 contracting, or similar initiative.
- 28 (f) Requiring that managed care Medicaid plans adopt the
- 29 regulations and policies outlined in this act and include these

- regulations and policies in their contracts with qualified complexrehabilitation technology suppliers.
- 3 (g) Making other changes as needed to protect access to4 complex rehabilitation technology for complex needs patients.
- 5 Enacting section 1. This act does not take effect unless
- 6 Senate Bill No. 499 of the 101st Legislature is enacted into law.
