GENERAL SECTIONS

27 Sec. 201. In accordance with section 30 of article IX of the
 28 state constitution of 1963, total state spending from state sources
 29 in this appropriation act for the fiscal year ending September 30,

1 2022 is \$45,592,200.00. State appropriations paid to local units of
 2 government are \$34,322,200.00 as follows:

10 **MICHIGAN NATURAL RESOURCES TRUST FUND**

11 Sec. 301. (1) The department of natural resources shall enter
 12 into agreements with local units of government to administer the
 13 grants identified in part 1. Among other provisions, the agreements
 14 must require that grant recipients dedicate to public outdoor
 15 recreation uses in perpetuity the land acquired or developed; to
 16 replace lands converted or lost to other than public outdoor
 17 recreation use; and, for parcels acquired that are larger than 5
 18 acres, to provide this state with a nonparticipating 1/6 minimum
 19 royalty interest in any acquired minerals that are retained by the
 20 grant recipient.

21 (2) The agreements under subsection (1) must also provide that
 22 the full payments of grants be made only after proof of
 23 acquisition, or proof of completion of the development project, is
 24 submitted by the grant recipient and all costs are verified by the
 25 department of natural resources. This requirement may be waived by
 26 the department of natural resources.

 29 section 248 of the management and budget act, 1984 PA 431, MCL
