

SENATE BILL NO. 861

February 08, 2022, Introduced by Senator MCBROOM and referred to the Committee on Education and Career Readiness.

A bill to amend 1976 PA 451, entitled "The revised school code," by amending sections 1526, 1531, and 1531d (MCL 380.1526, 380.1531, and 380.1531d), section 1526 as amended by 1995 PA 289, section 1531 as amended by 2018 PA 235, and section 1531d as added by 2003 PA 18.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1526. **(1)** For the first 3 years of his or her employment
2 in classroom teaching, a teacher ~~shall~~**must** be assigned by the

1 school in which he or she teaches to 1 or more master teachers, or
2 college professors or retired master teachers, who shall act as a
3 mentor or mentors to the teacher. During the 3-year period, the
4 teacher ~~shall~~**must** also receive intensive professional development
5 induction into teaching, based on a professional development plan
6 that is consistent with the requirements of section 3a of article
7 II of ~~Act No. 4 of the Public Acts of the Extra Session of 1937,~~
8 ~~being section 38.83a of the Michigan Compiled Laws, 1937 (Ex Sess)~~
9 **PA 4, MCL 38.83a**, including classroom management and instructional
10 delivery. ~~During~~**Subject to subsection (2), during** the 3-year
11 period, the intensive professional development induction into
12 teaching ~~shall~~**must** consist of at least 15 days of professional
13 development, the experiencing of effective practices in university-
14 linked professional development schools, and regional seminars
15 conducted by master teachers and other mentors.

16 **(2) Except as otherwise provided in this subsection, for**
17 **teachers employed in classroom teaching on or after August 1, 2023,**
18 **except for individuals who have physical limitations that make it**
19 **impracticable for the individual to complete the course and**
20 **instruction and obtain the required certification under this**
21 **subsection, the 15 days of professional development described in**
22 **subsection (1) must include a course approved by the department in**
23 **first aid and cardiopulmonary resuscitation that includes a test**
24 **demonstration on a mannequin and instruction in foreign body airway**
25 **obstruction management that results in valid certification in these**
26 **topics issued by the American Red Cross, American Heart**
27 **Association, or a comparable organization or institution approved**
28 **by the department. The course, instruction, and certification**
29 **required under this subsection must be completed within the first**

1 year of the 3-year period described in subsection (1). This
 2 subsection does not apply to an individual who has successfully
 3 completed the course and instruction and holds the valid
 4 certification described in section 1531d(1)(a) on or before July
 5 31, 2023.

6 (3) An individual who has completed the course and instruction
 7 and obtained the certification described in subsection (2) and who
 8 performs first aid, cardiopulmonary resuscitation, or foreign body
 9 airway obstruction management on another individual in the course
 10 of his or her employment as a teacher is not liable in a civil
 11 action for damages resulting from an act or omission occurring in
 12 that performance except for an act or omission constituting gross
 13 negligence or willful or wanton misconduct.

14 (4) This section does not create a duty to act on the part of
 15 an individual who holds the certification described in subsection
 16 (2).

17 Sec. 1531. (1) Except as **otherwise** provided in this act, the
 18 superintendent of public instruction shall determine the
 19 requirements for and issue all licenses, ~~and certificates, and~~
 20 **endorsements** for teachers, including preprimary teachers ~~—and the~~
 21 ~~requirements for an endorsement of teachers as qualified~~
 22 ~~counselors, and an endorsement of teachers for teaching a foreign~~
 23 ~~language in an elementary grade in the public schools of the~~ **this**
 24 state.

25 (2) Except as otherwise provided in this act, the
 26 superintendent of public instruction shall only issue a teaching
 27 certificate **or additional endorsement** to an individual who has
 28 passed appropriate **available** examinations. ~~as follows:~~

29 ~~(a) For a secondary level teaching certificate, has passed the~~

2 ~~area in which he or she applies to be certified.~~

8 ~~(3) Except as otherwise provided in this act, the~~
9 ~~superintendent of public instruction shall issue a Michigan~~
10 ~~teaching certificate to an individual holding a certificate from~~
11 ~~another state or a teaching degree from an out-of-state teacher~~
12 ~~preparation institution who applies for a Michigan teaching~~
13 ~~certificate only if the individual passes appropriate examinations~~
14 ~~as follows:~~

15 ~~(a) For a secondary level teaching certificate, pass the~~
16 ~~appropriate available subject area examination for each subject~~

1 (3) ~~(4)~~ Except as otherwise provided in this act, the
 2 superintendent of public instruction shall only issue a teaching
 3 certificate to an individual who has met the elementary or
 4 secondary, as applicable, reading credit requirements established
 5 under superintendent of public instruction rule. If an individual
 6 holds a teaching certificate, ~~then beginning July 1, 2009,~~
 7 notwithstanding any rule to the contrary, the superintendent of
 8 public instruction shall not advance the individual's certification
 9 to professional certification unless the individual has
 10 successfully completed at least a 3-credit course of study with
 11 appropriate field experiences in the diagnosis and remediation of
 12 reading disabilities and differentiated instruction. To meet this
 13 requirement, the course of study should include the following
 14 elements, as determined by the department to be appropriate for the
 15 individual's certification level and endorsements: interest

 18 screening, phonemics, phonics, vocabulary, fluency, comprehension,
 19 spelling and writing assessment tools, and instructional
 20 strategies. An individual may complete the course of study either
 21 as part of his or her teacher preparation program. ~~or during the~~
 22 ~~first 6 years of his or her employment in classroom teaching.~~

23 (4) ~~(5)~~ ~~Not later than January 11, 2002, the superintendent of~~
 24 ~~public instruction, in cooperation with appropriate curriculum~~
 25 ~~specialists and teacher educators, shall revise~~ **Any revisions to**
 26 existing reading standards ~~to recognize~~ **must include the**
 27 **recognition of** reading disorders and ~~to enable~~ teachers to make
 28 referrals for instruction and support for pupils with reading
 29 disorders.

1 (5) ~~(6)~~ Subject to subsection (8), if an individual holding a
 2 teaching certificate from another state, **country, or federally**
 3 **recognized Indian tribe** applies to the superintendent of public
 4 instruction for a Michigan teaching certificate and meets the

29 (6) ~~(c) Has met the~~ **Subject to subsection (8), an individual**

1 holding a teaching certificate from another state, country, or
2 federally recognized Indian tribe is eligible for a Michigan
3 professional education certificate if the individual meets both of
4 the following:

5 (a) The individual has taught successfully for at least 3
6 years in a position for which the individual's teaching
7 certification from the other state, country, or federally
8 recognized Indian tribe was valid.

9 (b) The individual meets the elementary or secondary, as
10 applicable, reading credit requirement established under
11 superintendent of public instruction rule **as described in**
12 **subsection (3).**

13 ~~(7) An individual who receives a teaching certificate and~~
14 ~~endorsement or endorsements under subsection (6) is eligible to~~
15 ~~receive 1 or more additional endorsements comparable to~~
16 ~~endorsements the individual holds in another state only if the~~
17 ~~individual passes the appropriate subject area examinations~~
18 ~~required under subsection (2) or (3).~~ **Subject to subsection (8), if**
19 **an individual holding a teaching certificate from another state,**
20 **country, or federally recognized Indian tribe applies to the**
21 **superintendent of public instruction for an additional endorsement**
22 **on a valid Michigan teaching certificate and meets the requirements**
23 **of this subsection, the superintendent of public instruction shall**
24 **issue the individual an endorsement comparable to that which the**
25 **individual holds in the other state or country or with the**
26 **federally recognized Indian tribe without requiring that the**

6 Michigan teaching certificate **or endorsement** to an individual
7 described in subsection (5), (6), **or (7)** for fraud, material
8 misrepresentation, or concealment in the individual's application
9 for a certificate or for a conviction for which an individual's
10 teaching certificate may be **suspended or** revoked under section
11 1535a.

12 ~~(9) The department, based upon criteria recommended under~~
13 ~~subsection (11), shall provide to approved teacher education~~
14 ~~institutions approved guidelines and criteria for use in the~~
15 ~~development or selection of subject area examinations.~~

16 (9) ~~(10)~~For the purposes of this section, the superintendent
17 of public instruction, based upon criteria recommended ~~under~~
18 ~~subsection (11),~~ **by a committee of teachers, representatives of**
19 **approved teacher education institutions, Michigan education**
20 **organizations and associations, and experts in measurement and**
21 **assessment**, shall develop, select, or develop and select 1 or more
22 subject area examinations. In addition, the superintendent of
23 public instruction, based upon criteria recommended ~~under~~
24 ~~subsection (11),~~ **by the committee described in this subsection,**
25 shall approve an ~~elementary certification examination and a reading~~
26 subject area examination. If the department develops for use under
27 this subsection an examination that had previously been contracted
28 for using a competitive bid process, then the department shall not
29 expend on the development of that examination an amount that

1 exceeds the amount that the department expended on procurement of
2 the most recent competitively-bid version of that examination. **The**
3 **competitive bid process must address validity, reliability, and**
4 **other technical standards of the examinations and of the**
5 **appropriate administration and use of those examinations.**

6 ~~(11) The superintendent of public instruction shall appoint an~~
7 ~~11-member teacher examination advisory committee composed of~~
8 ~~representatives of approved teacher education institutions and~~
9 ~~Michigan education organizations and associations. Not more than~~
10 ~~1/2 of the members comprising this committee shall be certified~~
11 ~~teachers. This committee shall recommend criteria to be used by the~~
12 ~~superintendent of public instruction in the development, selection,~~
13 ~~or development and selection of subject area examinations. In~~
14 ~~addition, the committee shall recommend guidelines for the use and~~
15 ~~administration of those examinations.~~

16 ~~(12) The superintendent of public instruction shall appoint a~~
17 ~~7-member standing technical advisory council composed of~~
18 ~~individuals who are experts in measurement and assessment. This~~
19 ~~council shall advise the superintendent of public instruction and~~
20 ~~the teacher examination committee on the validity, reliability, and~~
21 ~~other technical standards of the examinations that will be used or~~
22 ~~are being used and of the administration and use of those~~

24 **(10)** ~~(13)~~ Not later than November 30 of each year, the
25 superintendent of public instruction shall submit in writing a
26 report on the development or selection and use of ~~the elementary~~
27 ~~certification examination and the subject area examinations to the~~
28 house and senate education committees. The report shall **must** also
29 contain a financial statement regarding revenue received from the

1 assessment of fees levied under subsection ~~(15)~~ **(12)** and the amount
2 of and any purposes for which that revenue was expended.

4 ~~subject area examinations~~ required by this section may be taken at

14 public instruction, ~~shall~~ **must** not exceed the actual cost of the
15 examination and of administering the examination. Fees received by
16 the department ~~shall~~ **must** be expended solely for administrative
17 expenses that it incurs in implementing this section. If the

20 implementing the fee increase, the department shall notify each

3 temporary teaching certificate, good for 1 year, to the individual.

20 **state, country, or federally recognized Indian tribe" means an**
21 **individual with a valid teaching certificate or an individual who**
22 **is eligible for a teaching certificate in the state or country or**
23 **with the federally recognized Indian tribe in which or with which**
24 **the individual is certificated or eligible for certification.**

26 **related to a specific area of certification, which examination has**
27 **been developed or selected by the superintendent of public**
28 **instruction an endorsement area for the purpose of demonstrating**
29 **the applicant's knowledge and understanding of the subject matter**

1 and determining whether or not an applicant is eligible for a
2 Michigan teaching certificate **or endorsement**.

29 Sec. 1531d. (1) ~~Beginning July 1, 2004, the~~ **Subject to**

1 **subsection (4), the** superintendent of public instruction shall not
2 issue an initial teaching certificate to a person unless the person
3 presents evidence satisfactory to the superintendent of public
4 instruction that the person meets 1 of the following:

5 (a) Has successfully completed a course approved by the
6 department in first aid and cardiopulmonary resuscitation,
7 including a test demonstration on a mannequin, and has successfully
8 completed instruction approved by the department in foreign body
9 airway obstruction management, and holds valid certification in
10 these topics issued by the American ~~red cross,~~ **Red Cross**, American
11 ~~heart association,~~ **Heart Association**, or a comparable organization
12 or institution approved by the department.

13 (b) Has physical limitations that make it impracticable for
14 the person to complete the instruction and obtain the required
15 certification under subdivision (a).

16 (2) A person who meets the requirements described in
17 subsection (1) (a) and who performs first aid, cardiopulmonary
18 resuscitation, or foreign body airway obstruction management on
19 another person in the course of his or her employment as a teacher
20 is not liable in a civil action for damages resulting from an act
21 or omission occurring in that performance except an act or omission
22 constituting gross negligence or willful ~~and or~~ wanton misconduct.

23 (3) This section does not create a duty to act on the part of
24 a person who holds the certification described in subsection
25 (1) (a).

26 **(4) Subsection (1) does not apply after July 31, 2023.**
