#### Introduction of Bills

Rep. Weiss introduced

#### House Bill No. 5270, entitled

A bill to amend 1979 PA 94, entitled "The state school aid act of 1979," by amending section 11 (MCL 388.1611), as amended by 2021 PA 48, and by adding section 29b.
