**Introduction of Bills**

Rep. Alexander introduced

**House Bill No. 6499, entitled**

A bill to amend 1995 PA 279, entitled "Horse racing law of 1995," by amending sections 6a and 20 (MCL 431.306a and 431.320), as amended by 2019 PA 153.

The bill was read a first time by its title and referred to the Committee on Regulatory Reform.

Rep. Alexander introduced

**House Bill No. 6500, entitled**

A bill to make, supplement, and adjust appropriations for various state departments and agencies for the fiscal year ending September 30, 2023; to provide for certain conditions on appropriations; and to provide for the expenditure of the appropriations.

The bill was read a first time by its title and referred to the Committee on Appropriations.

Rep. Alexander introduced

**House Bill No. 6501, entitled**

A bill to amend 1995 PA 279, entitled "Horse racing law of 1995," by amending sections 12 and 14 (MCL 431.312 and 431.314), as amended by 2016 PA 271.

The bill was read a first time by its title and referred to the Committee on Regulatory Reform.

**House Bill No. 6502, entitled**

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," (MCL 257.1 to 257.923) by adding section 811hh; and to repeal acts and parts of acts.

**House Bill No. 6506, entitled**

A bill to amend 1976 PA 331, entitled "Michigan consumer protection act," by amending section 3h (MCL 445.903h), as added by 2008 PA 310.

The bill was read a first time by its title and referred to the Committee on Regulatory Reform.

A bill to amend 1913 PA 188, entitled "An act relating to the conduct of hotels, inns and public lodging houses," (MCL 427.1 to 427.15) by adding section 3a.

**House Bill No. 6508, entitled**

A bill to amend 1978 PA 368, entitled "Public health code," by amending section 20954 (MCL 333.20954), as amended by 2000 PA 375.

The bill was read a first time by its title and referred to the Committee on Health Policy.

**House Bill No. 6509, entitled**

A bill to amend 1937 PA 306, entitled "An act to promote the safety, welfare, and educational interests of the people of this state by regulating the construction, reconstruction, and remodeling of, and the installation of certain security devices at, certain public or private school buildings or additions to those buildings and by regulating the construction, reconstruction, and remodeling of, and the installation of certain security devices at, buildings leased or acquired for school purposes; to define the class of buildings affected by this act; to prescribe the powers and duties of certain state agencies and officials; to prescribe penalties for the violation of this act; and to repeal acts and parts of acts," (MCL 388.851 to 388.855a) by adding section 1e.

The bill was read a first time by its title and referred to the Committee on Education.

The bill was read a first time by its title and referred to the Committee on Education.

**House Bill No. 6511, entitled**

A bill to amend 1994 PA 451, entitled “Natural resources and environmental protection act,” (MCL 324.101 to 324.90106) by adding subpart 3 to part 147.

The bill was read a first time by its title and referred to the Committee on Commerce and Tourism.

**House Bill No. 6512, entitled**

A bill to amend 2020 PA 68, entitled “Michigan reconnect grant recipient act,” by amending sections 11, 15, 18, and 21 (MCL 390.1711, 390.1715, 390.1718, and 390.1721).

The bill was read a first time by its title and referred to the Committee on Appropriations.

**House Bill No. 6513, entitled**

A bill to amend 1893 PA 206, entitled “The general property tax act,” by amending section 7u (MCL 211.7u), as amended by 2020 PA 253.

The bill was read a first time by its title and referred to the Committee on Local Government and Municipal Finance.

A bill to amend 2020 PA 84, entitled “Michigan reconnect grant act,” by amending section 1 (MCL 390.1701).

**House Bill No. 6519, entitled**

A bill to amend 1846 RS 83, entitled “Of marriage and the solemnization thereof,” by amending sections 7 and 16 (MCL 551.7 and 551.16), section 7 as amended by 2014 PA 278 and section 16 as amended by 2006 PA 419.

The bill was read a first time by its title and referred to the Committee on Families, Children, and Seniors.

**House Bill No. 6520, entitled**

A bill to amend 1846 RS 171, entitled “Of county jails and the regulation thereof,” by amending section 3 (MCL 801.3).

The bill was read a first time by its title and referred to the Committee on Health Policy.

**House Bill No. 6523, entitled**

A bill to amend 1967 PA 281, entitled “Income tax act of 1967,” (MCL 206.1 to 206.847) by adding section 684.

The bill was read a first time by its title and referred to the Committee on Tax Policy.

**House Bill No. 6524, entitled**

A bill to amend 2008 PA 295, entitled “Clean and renewable energy and energy waste reduction act,” by amending sections 22, 28, and 45 (MCL 460.1022, 460.1028, and 460.1045), sections 22 and 28 as added and section 45 as amended by 2016 PA 342, and by adding section 32.

The bill was read a first time by its title and referred to the Committee on Energy.

A bill to amend 1961 PA 236, entitled “Revised judicature act of 1961,” (MCL 600.101 to 600.9947) by adding section 2980.

The bill was read a first time by its title and referred to the Committee on Judiciary.

**House Bill No. 6526, entitled**

A bill to amend 1877 PA 67, entitled “An act relative to the organization of the meetings of the legislature,” (MCL 4.41 to 4.45) by adding section 2a.

The bill was read a first time by its title and referred to the Committee on Government Operations.

Rep. Pepper introduced

**House Bill No. 6527, entitled**

A bill to amend 1978 PA 368, entitled “Public health code,” (MCL 333.1101 to 333.25211) by adding section 17748g.

The bill was read a first time by its title and referred to the Committee on Health Policy.

Rep. Pepper introduced

**House Bill No. 6528, entitled**

A bill to amend 1982 PA 295, entitled “Support and parenting time enforcement act,” by amending sections 3 and 5 (MCL 552.603 and 552.605), section 3 as amended by 2014 PA 378 and section 5 as added by 2001 PA 106.

The bill was read a first time by its title and referred to the Committee on Judiciary.

Rep. Pepper introduced

**House Bill No. 6529, entitled**

A bill to amend 1949 PA 300, entitled “Michigan vehicle code,” by amending section 811 (MCL 257.811), as amended by 2021 PA 71.

The bill was read a first time by its title and referred to the Committee on Military, Veterans and Homeland Security.

Rep. Pepper introduced

**House Bill No. 6530, entitled**

A bill to prohibit limited services pregnancy centers from publishing deceptive statements regarding certain services; to provide for the powers and duties of certain state and local governmental officers and entities; and to provide remedies.

The bill was read a first time by its title and referred to the Committee on Judiciary.

Rep. Pepper introduced

**House Bill No. 6531, entitled**

A bill to amend 1947 PA 336, entitled “An act to prohibit strikes by certain public employees; to provide review from disciplinary action with respect thereto; to provide for the mediation of grievances and the holding of elections; to declare and protect the rights and privileges of public employees; to require certain provisions in collective bargaining agreements; to prescribe means of enforcement and penalties for the violation of the provisions of this act; and to make appropriations,” by amending section 10 (MCL 423.210), as amended by 2014 PA 414.

The bill was read a first time by its title and referred to the Committee on Elections and Ethics.

Rep. Rabhi introduced

**House Joint Resolution Y, entitled**

A joint resolution proposing an amendment to the state constitution of 1963, by amending sections 15 and 29 of article VII and adding section 31 to article V, to create a state public utility.

The joint resolution was read a first time by its title and referred to the Committee on Energy.
