Senators Runestad and Barrett offered the following resolution:

1 A resolution to condemn the federal government's expansion of

the Internal Revenue Service through the proposed Inflation

4 Whereas, The Inflation Reduction Act will allow nearly five

5 hundred billion dollars in new spending by our federal government

6 over the next decade, with almost eighty billion dollars being

7 directed to the Internal Revenue Service's (IRS) budget. The budget

allocations of this law spell out the current Administration's big-

9 government intentions for the future of the IRS. Over forty-five

10 billion dollars will be directed to "enforcement" while a meager

11 three billion is expected to be used for "taxpayer services." As

12 part of these budgetary expansions, the IRS would hire eighty-seven

13 thousand new employees, making this agency larger than the FBI,

- 1 Pentagon, State Department, and Border Patrol combined. This Act is
- 2 not intended to benefit Americans it is just the latest
- 3 development in this Administration's police state agenda; and
- 4 Whereas, This bloating of the IRS's budget and staff also
- 5 comes at the same time Americans are learning of the massive
- 6 stockpiling of weapons and ammunition by the government agency. The
- 7 latest data, released in a 2020 report analyzing the militarization
- 8 of federal agencies in years prior, found that the IRS had
- 9 thousands of rifles, shotguns, pistols, and submachine guns as well
- 10 as an arsenal of over five million rounds of ammunition.
- 11 Additionally, a 2017 report by the Treasury Inspector General for
- 12 Tax Administration found that the IRS's Criminal Investigation
- 13 Division repeatedly violated the civil rights of Americans under
- 14 the guise of enforcing tax laws and seizing taxpayer property.
- 15 Michiganders are right to fear a massive budget expansion for a tax
- 16 collection agency that feels it necessary to arm itself to the
- 17 teeth in pursuit of collecting our citizens' hard-earned money with
- 18 little to no restraint; and
- 19 Whereas, In 1974, then-President Gerald Ford warned Congress
- 20 that "[a] government big enough to give you everything you want is
- 21 a government big enough to take from you everything you have." This
- 22 Administration represents just the latest installment in a half-
- 23 century long tradition of paying no heed to past generations'
- 24 commonsense understanding that government should play a minimal
- 25 role in our lives. As the only President who was a fellow
- 26 Michigander, it is appropriate for our citizens to take seriously
- 27 President Ford's warning and strongly condemn this massive
- 28 expansion of a federal agency that only exists by virtue of our
- 29 collective tax dollars. The Inflation Reduction Act would hand over

- 1 tens of billions of dollars to create an IRS big enough and well-
- 2 armed enough to take whatever it wants from our citizens whenever
- 3 it pleases; now, therefore, be it
- 4 Resolved by the Senate, That we condemn the expansion of the
- 5 Internal Revenue Service through the Inflation Reduction Act of
- 6 2022; and be it further
- 7 Resolved, That copies of this resolution be transmitted to the
- 8 President of the United States, the Speaker of the United States
- 9 House of Representatives, the President of the United States
- 10 Senate, and the members of the Michigan congressional delegation.
