HOUSE RESOLUTION NO.144

Reps. Green and Carra offered the following resolution: 1 A resolution to urge the Congress of the United States to 2 submit the Keep Nine Amendment to the states for ratification. 3 Whereas, For over 150 years, there have been nine seats on the Supreme Court of the United States. While the country has grown and 4 changed during that period, the Supreme Court has repeatedly 5 6 demonstrated its ability to fulfill its constitutional role as the 7 nation's highest court and remain an independent arbiter of the law 8 without additional justices; and Whereas, In recent months, there have been calls to increase 9 the number of justices on the Supreme Court in an effort to gain 10 11 political advantage, including the Judiciary Act of 2021, H.R. 2584 12 of 2021 and S. 1141 of 2021, which would increase the number of justices to 13. The number of justices on the Supreme Court has 13

1 been fixed by federal law since 1869 and efforts to expand the size

- 2 of the Supreme Court in the century and a half since have been met
- 3 with significant resistance from the American people; and
- 4 Whereas, The legitimacy of the Supreme Court is its most
- 5 valuable asset. The Supreme Court's ability to issue rulings which
- 6 are followed nationwide rests on the American people's respect for
- 7 the institution's independence and separation from day-to-day
- 8 politics; and
- 9 Whereas, The federal judiciary, particularly the Supreme
- 10 Court, must remain insulated from partisan disputes. Politicizing
- 11 the Supreme Court by adding seats for the purpose of generating an
- 12 ideological shift would be enormously detrimental for the public's
- 13 faith in the judicial branch as an independent and impartial branch
- 14 of government. The framers of the U.S. Constitution envisioned a
- 15 system in which Supreme Court justices and federal judges would
- 16 serve lifetime appointments, ensuring that the judiciary would not
- 17 experience the kinds of political pressures that are present in the
- 18 elected branches; and
- 19 Whereas, Subjecting the Supreme Court to major structural
- 20 changes as a consequence of shifting partisan control of the
- 21 executive and legislative branches would bring the judiciary into
- 22 the political fray in a way that would harm its ability to fulfill
- 23 its critical role in our system; and
- 24 Whereas, The President and Congress should refrain from
- 25 undermining the independence of the Supreme Court by changing the
- 26 number of justices; and
- Whereas, Legislation has been introduced in Congress, H.J. Res
- 29 Amendment to the states for ratification; now, therefore, be it

- 1 Resolved by the House of Representatives, That we urge the
- 2 Congress of the United States to submit the following
- 3 constitutional amendment, known as the Keep Nine Amendment, to the
- 4 states for ratification:
- 5 The Supreme Court of the United States shall be composed
- 6 of nine justices.
- 7 ; and be it further
- 8 Resolved, That copies of this resolution be transmitted to the
- 9 President of the United States Senate, the Speaker of the United
- 10 States House of Representatives, and the members of the Michigan
- 11 congressional delegation.
