

## HOUSE RESOLUTION NO. 206

The Speaker, on behalf of the entire membership of the House of Representatives, offered the following resolution:

1           A resolution of tribute offered as a memorial for Stephen  
2 Ehardt, former member of the House of Representatives.

3           Whereas, It was with deep sadness that the members of this  
4 body learned of the passing of Stephen Ehardt. He will be  
5 remembered for the passion with which he served his constituents in  
6 the 83<sup>rd</sup> District and the entire state of Michigan; and

7           Whereas, Stephen Ehardt was born in Port Huron and graduated  
8 from Croswell Lexington High School in 1973. He then attended  
9 Ferris State University where he earned his degree in pharmacy.  
10 Upon graduation, Stephen returned to Lexington and started Ehardt's  
11 Pharmacy, where he would serve as president and CEO for 36 years.  
12 Even after starting his own practice, he continued his education in

1 pharmacy, earning a Certificate in Geriatric Pharmacy from Ferris  
2 State University in 1995 and completing a Community Pharmacy  
3 Management Program through the American Pharmacists Association in  
4 1996; and

5       Whereas, Stephen Ehardt's contributions to pharmacy in  
6 Michigan extend far beyond his practice. He served as an adjunct  
7 professor or instructor at St. Clair County Community College, the  
8 University of Michigan-Flint, and Wayne State University School of  
9 Pharmacy, passing his knowledge to the next generation. In 1997, he  
10 was elected president of the Michigan Pharmacists Association and  
11 received the Distinguished Achievement Award in Community Pharmacy  
12 Practice from the American Pharmacists Association. In 2005, he was  
13 named the Michigan Pharmacists Association's Pharmacist of the  
14 Year; and

15       Whereas, Throughout his life, Stephen Ehardt was willing to  
16 serve his community. He was a member of the Greater Croswell-  
17 Lexington Chamber of Commerce Executive Board for 17 years,  
18 including time as president and treasurer, and was appointed to the  
19 Thumb Michigan Works! community advisory board in 1996. Stephen  
20 also served his community in local elected office, including four  
21 years on the Lexington Planning Commission and ten years as a  
22 village trustee; and

23       Whereas, Stephen Ehardt was first elected to the Michigan  
24 House of Representatives in 1998. Bringing his experience as a  
25 pharmacist, Representative Ehardt became a leader on health policy,  
26 including serving as the chair of the Health Policy Committee  
27 during his last two terms. He also served as vice chair of the  
28 Veterans Affairs Committee and as a member of the committees on  
29 Agriculture and Resource Management; Conservation and Outdoor

1 Recreation; Insurance; Insurance and Financial Services; Health  
2 Insurance; and Land Use and Environment. Representative Erhardt was  
3 also chosen to serve as Associate Speaker Pro Tempore for the 2001  
4 to 2002 and 2003 to 2004 sessions; and

5       Whereas, Representative Erhardt was a consummate public  
6 servant, spending two decades in elected office and contributing to  
7 the betterment of his community in countless other endeavors. His  
8 passion for policy and representing his constituents will serve as  
9 an example for those that follow in his footsteps; now, therefore,  
10 be it

11       Resolved by the House of Representatives, That we offer this  
12 expression of our highest tribute to honor the memory of Stephen  
13 Erhardt, a member of the House of Representatives from 1998 to 2004;  
14 and be it further

15       Resolved, That copies of this resolution be transmitted to the  
16 Erhardt family as evidence of our lasting esteem for his memory.
