## **HOUSE BILL NO. 4561**

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

by amending section 609h (MCL 436.1609h), as added by 2022 PA 225.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 609h. A manufacturer or supplier may offer electronic
- 2 rebate coupons directly to a retail customer after the retail
- 3 customer purchases alcoholic liquor from a retailer. An electronic
- 4 rebate coupon issued under this section must comply with all the
- 5 following:
- 6 (a) A manufacturer or supplier shall only issue coupons that

- 1 state a specific expiration date and specific cash refund value on
- 2 the coupons. The refund may be paid by cash, by check, by debit
- 3 card, through electronic funds transfer to a bank account, or
- 4 through an internet or mobile payment account.
- 5 (b) A manufacturer or supplier shall not issue coupons that
- 6 result in the retail customer's purchase of alcoholic liquor being
- 7 below the retailer's cost.make any alcoholic liquor free.
- 8 (c) A manufacturer or supplier may issue coupons that can be
- 9 applied to more than 1 specific product sold by that manufacturer
- 10 or supplier but must state the manufacturer or supplier to which
- 11 they apply.
- 12 (d) A manufacturer or supplier shall issue coupons that
- 13 require the retail customer to purchase at least 1 product of
- 14 alcoholic liquor to redeem a coupon. A manufacturer or supplier may
- 15 issue coupons that require the retail customer to purchase 2 or
- 16 more alcoholic liquor products from the same manufacturer or
- 17 supplier to redeem the coupon.
- 18 (e) A manufacturer or supplier shall not may issue coupons
- 19 that require the purchase of a product other than alcoholic liquor.
- (f) A wholesaler shall not pay for or participate in the
- 21 offering of coupons except for providing signs that promote the
- 22 electronic rebate coupon in accordance with section 610a.
- 23 (g) A manufacturer shall only issue coupons that may be
- 24 redeemable after a purchase of alcoholic liquor at all retail
- 25 locations where that alcoholic liquor is sold.
