

**SUBSTITUTE FOR
SENATE BILL NO. 12**

A bill to amend 1976 PA 451, entitled
"The revised school code,"
by amending section 1280f (MCL 380.1280f), as added by 2016 PA 306.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1280f. (1) The department shall do all of the following
2 to help ensure that more pupils will achieve a score of at least
3 proficient in English language arts on the grade 3 state
4 assessment:

5 (a) Approve 3 or more valid and reliable screening, formative,
6 and diagnostic reading assessment systems for selection and use by
7 school districts and public school academies in accordance with the
8 following:

9 (i) Each approved assessment system ~~shall~~**must** provide a

1 screening assessment, monitoring capabilities for monitoring
2 progress toward a growth target, and a diagnostic assessment.

3 (ii) In determining which assessment systems to approve for use
4 by school districts and public school academies, the department
5 shall also consider at least the following factors:

6 (A) The time required to conduct the assessments, with the
7 intention of minimizing the impact on instructional time.

8 (B) The level of integration of assessment results with
9 instructional support for teachers and pupils.

10 (C) The timeliness in reporting assessment results to
11 teachers, administrators, and parents.

12 (b) Recommend or develop an early literacy coach model with
13 the following features:

14 (i) An early literacy coach shall support and provide initial
15 and ongoing professional development to teachers in all of the
16 following:

17 (A) Each of the 5 major reading components listed in
18 subsection (3) (a) (iv) (B) as needed, based on an analysis of pupil
19 performance data.

20 (B) Administering and analyzing instructional assessments.

21 (C) Providing differentiated instruction and intensive
22 intervention.

23 (D) Using progress monitoring.

24 (E) Identifying and addressing reading deficiency.

25 (ii) An early literacy coach shall also do all of the
26 following:

27 (A) Model effective instructional strategies for teachers.

28 (B) Facilitate study groups.

29 (C) Train teachers in data analysis and using data to

1 differentiate instruction.

2 (D) Coach and mentor colleagues.

3 (E) Work with teachers to ensure that evidence-based reading
4 programs such as comprehensive core reading programs, supplemental
5 reading programs, and comprehensive intervention reading programs
6 are implemented with fidelity.

7 (F) Train teachers to diagnose and address reading deficiency.

8 (G) Work with teachers in applying evidence-based reading
9 strategies in other content areas, including, but not limited to,
10 prioritizing time spent on those teachers, activities, and roles
11 that will have the greatest impact on pupil achievement and
12 prioritizing coaching and mentoring in classrooms.

13 (H) Help to increase instructional density to meet the needs
14 of all pupils.

15 (I) Help lead and support reading leadership teams at the
16 school.

17 (J) Continue to increase his or her knowledge base in best
18 practices in reading instruction and intervention.

19 (K) For each teacher who teaches in a classroom for grades K
20 to 3, model for the teacher, and coach the teacher in, instruction
21 with pupils in whole and small groups.

22 (iii) In the context of performing the functions described in
23 subparagraph (ii), an early literacy coach ~~shall~~**must** not be asked
24 to perform administrative functions that will confuse his or her
25 role for teachers.

26 (iv) An early literacy coach must meet all of the following:

27 (A) Have experience as a successful classroom teacher.

28 (B) Have sufficient knowledge of scientifically based reading
29 research, special expertise in quality reading instruction and

1 infusing reading strategies into content area instruction, and data
2 management skills.

3 (C) Have a strong knowledge base in working with adults.

4 (D) Have a minimum of a bachelor's degree and advanced
5 coursework in reading or have completed professional development in
6 evidence-based literacy instructional strategies.

7 (v) An early literacy coach ~~shall~~**must** not be assigned a
8 regular classroom teaching assignment, but ~~shall~~**must** be expected
9 to work frequently with pupils in whole and small group instruction
10 or tutoring in the context of modeling and coaching in or outside
11 of teachers' classrooms.

12 (2) Subject to subsection ~~(14)~~, ~~beginning in the 2017-2018~~
13 ~~school year,~~ **(10)**, the board of a school district or board of
14 directors of a public school academy shall do all of the following
15 to ensure that more pupils will achieve a score of at least
16 proficient in English language arts on the grade 3 state
17 assessment:

18 (a) Select 1 valid and reliable screening, formative, and
19 diagnostic reading assessment system from the assessment systems
20 approved by the department under subsection (1)(a). A school
21 district or public school academy shall use this assessment system
22 for pupils in grades K to 3 to screen and diagnose difficulties,
23 inform instruction and intervention needs, and assess progress
24 toward a growth target. A school district or public school academy
25 periodically shall assess a pupil's progress in reading skills at
26 least 3 times per school year in grades K to 3. The first of these
27 assessments for a school year ~~shall~~**must** be conducted within the
28 first 30 school days of the school year.

29 (b) For any pupil in grades K to 3 who exhibits a reading

1 deficiency at any time, based upon the reading assessment system
2 selected and used under subdivision (a), provide an individual
3 reading improvement plan for the pupil within 30 days after the
4 identification of the reading deficiency. The individual reading
5 improvement plan ~~shall~~**must** be created by the pupil's teacher,
6 school principal, and parent or legal guardian and other pertinent
7 school personnel, and ~~shall~~**must** describe the reading intervention
8 services the pupil will receive to remedy the reading deficiency. A
9 school district or public school academy shall provide intensive
10 reading intervention for the pupil in accordance with the
11 individual reading improvement plan until the pupil no longer has a
12 reading deficiency.

13 (c) If a pupil in grades K to 3 is identified as having an
14 early literacy delay or reading deficiency, provide written notice
15 to the pupil's parent or legal guardian of the delay or reading
16 deficiency in writing and provide tools to assist the parent or
17 legal guardian to engage in intervention and to address or correct
18 any reading deficiency at home.

19 (d) Require a school principal or chief administrator to do
20 all of the following:

21 (i) For a teacher in grades K to 3, target specific areas of
22 professional development based on the reading development needs
23 data for incoming pupils.

24 (ii) Differentiate and intensify professional development for
25 teachers based on data gathered by monitoring teacher progress in
26 improving pupil proficiency rates among their pupils.

27 (iii) Establish a collaborative system within the school to
28 improve reading proficiency rates in grades K to 3.

29 (iv) Ensure that time is provided for teachers to meet for

1 professional development.

2 (e) Utilize, at least, early literacy coaches provided through
3 the intermediate school district in which the school district or
4 public school academy is located, as provided for under section
5 35a(4) of the state school aid act of 1979, MCL 388.1635a. However,
6 a public school academy may use an early literacy coach provided by
7 the public school academy, at the expense of the public school
8 academy, rather than using an early literacy coach provided through
9 an intermediate school district if the early literacy coach and the
10 usage of the early literacy coach otherwise meet the requirements
11 of this section.

12 (3) Subject to subsection ~~(14)~~, **(10)**, a school district or
13 public school academy shall provide reading intervention programs
14 for pupils in grades K to 3, including at least all of the
15 following:

16 (a) For pupils who exhibit a reading deficiency, a reading
17 intervention program intended to ensure that pupils are proficient
18 readers by the end of grade 3 and that includes some or all of the
19 following features:

20 (i) Is provided to each pupil in grades K to 3 who is
21 identified with a reading deficiency based on screening and
22 diagnostic tools, and identifies and addresses the pupil's reading
23 deficiency.

24 (ii) Periodically screens and monitors the progress of each
25 pupil's reading skills, at least 3 times per year.

26 (iii) Provides evidence-based core reading instruction that is
27 comprehensive and meets the majority of the general education
28 classroom needs.

29 (iv) Provides reading intervention that meets, at a minimum,

1 the following specifications:

2 (A) Assists pupils exhibiting a reading deficiency in
3 developing the ability to read at grade level.

4 (B) Provides intensive development in the 5 major reading
5 components: phonemic awareness, phonics, fluency, vocabulary, and
6 comprehension.

7 (C) Is systematic, explicit, multisensory, and sequential.

8 (D) Is implemented during regular school hours in addition to
9 regular classroom reading instruction.

10 (v) Provides parents, legal guardians, or other providers of
11 care for the pupil with a ~~"Read at Home"~~ **read-at-home** plan,
12 including parent, guardian, or care provider training workshops and
13 regular home reading.

14 (vi) Documents efforts by the pupil's school to engage the
15 pupil's parent or legal guardian and whether or not those efforts
16 were successful.

17 (vii) Documents any dissenting opinions expressed by school
18 personnel or a parent or legal guardian concerning the individual
19 reading improvement plan provided for the pupil under subsection
20 (2) (b) .

21 (b) For grade 3 pupils exhibiting a reading deficiency as
22 determined by the pupil's teacher through the diagnostic reading
23 assessment system selected by the school district or public school
24 academy under subsection (2) (a), a reading intervention program
25 intended to correct the identified area or areas of reading
26 deficiency and that includes all of the following features as
27 needed by the individual pupil:

28 (i) Is evidence-based and has proven results in accelerating
29 pupil reading achievement within the same school year.

1 (ii) Provides more dedicated time than the pupil's previous
2 school year in evidence-based reading instruction and intervention.

3 (iii) Provides daily targeted small group or 1-to-1 reading
4 intervention based on pupil needs as determined by assessment data,
5 including explicit and systematic instruction with more detailed
6 and varied explanations, more extensive opportunities for guided
7 practice, and more opportunities for error correction and feedback.

8 (iv) Provides administration of ongoing progress monitoring
9 assessments to frequently monitor pupil progress.

10 (v) Provides supplemental evidence-based reading intervention
11 delivered by a teacher, tutor, or volunteer with specialized
12 reading training that is provided before school, after school,
13 during school hours but outside of regular English language arts
14 classroom time, or any combination of these.

15 (vi) Provides parents, legal guardians, or other providers of
16 care for a pupil with a ~~"Read at Home"~~ **read-at-home** plan, including
17 parent, guardian, or care provider training workshops and regular
18 home reading.

19 (vii) Documents efforts by the pupil's school to engage the
20 pupil's parent or legal guardian and whether or not those efforts
21 were successful.

22 (viii) Documents any dissenting opinions expressed by school
23 personnel or a parent or legal guardian concerning the individual
24 reading improvement plan provided for the pupil under subsection
25 (2) (b) .

26 (c) Subject to subsection ~~(15)~~, **(11)**, for pupils identified as
27 English language learners by the pupil's teacher or by the
28 diagnostic reading assessment selected by the school district or
29 public school academy under subsection (2) (a), intervention

1 services that include at least all of the following:

2 (i) Ongoing assessments that provide actionable data for
3 teachers to use in interventions.

4 (ii) Instruction in academic vocabulary.

5 (iii) Instruction in the 5 major reading components listed in
6 subdivision (a) (iv) (B).

7 (iv) Common English language development strategies such as
8 modeling, guided practice, and comprehensive input.

9 (4) For all pupils exhibiting a reading deficiency as
10 determined by the pupil's teacher through the diagnostic reading
11 assessment system selected by the school district or public school
12 academy under subsection (2) (a), school districts and public school
13 academies are encouraged to offer summer reading camps staffed with
14 highly effective teachers of reading, as determined by the teacher
15 evaluation system under section 1249, providing reading
16 intervention services and supports to correct pupils' identified
17 areas of reading deficiency.

18 ~~(5) Beginning with pupils enrolled in grade 3 during the 2019-~~
19 ~~2020 school year, all of the following apply:~~

20 ~~(a) Subject to subsection (6), the superintendent of the~~
21 ~~school district or chief administrator of the public school academy~~
22 ~~in which the pupil is enrolled shall ensure that a pupil whose~~
23 ~~parent or legal guardian has been provided with the notification~~
24 ~~under subdivision (d) is not enrolled in grade 4 until 1 of the~~
25 ~~following occurs:~~

26 ~~(i) The pupil achieves a reading score that is less than 1~~
27 ~~grade level behind as determined by the department based on the~~
28 ~~grade 3 state English language arts assessment.~~

29 ~~(ii) The pupil demonstrates a grade 3 reading level through~~

1 ~~performance on an alternative standardized reading assessment~~
 2 ~~approved by the superintendent of public instruction.~~

3 ~~(iii) The pupil demonstrates a grade 3 reading level through a~~
 4 ~~pupil portfolio, as evidenced by demonstrating competency in all~~
 5 ~~grade 3 state English language arts standards through multiple work~~
 6 ~~samples.~~

7 ~~(b) Subject to subsection (6), if a child younger than 10~~
 8 ~~years of age seeks to enroll for the first time in a school~~
 9 ~~district or public school academy in grade 4, the superintendent of~~
 10 ~~the school district or chief administrator of the public school~~
 11 ~~academy shall not allow the child to enroll in grade 4 unless 1 of~~
 12 ~~the following occurs:~~

13 ~~(i) The child achieves a grade 3 reading score as determined by~~
 14 ~~the department based on the reading portion of the grade 3 state~~
 15 ~~English language arts assessment.~~

16 ~~(ii) The child demonstrates a grade 3 reading level through~~
 17 ~~performance on an alternative standardized reading assessment~~
 18 ~~approved by the superintendent of public instruction.~~

19 ~~(iii) The child demonstrates a grade 3 reading level through a~~
 20 ~~pupil portfolio, as evidenced by demonstrating competency in all~~
 21 ~~grade 3 state English language arts standards through multiple work~~
 22 ~~samples.~~

23 ~~(5) (c) Not later than May 23 of each year or not later than~~
 24 ~~14 days after **After** the department finalizes the scoring for the~~
 25 ~~grade 3 state assessments, whichever is earlier, the department~~
 26 ~~shall provide CEPI with the grade 3 state assessment scores for~~
 27 ~~every grade 3 pupil enrolled in a public school in this state who~~
 28 ~~was administered 1 or more of those assessments.~~

29 ~~(6) (d) Not later than June 1 of each year or not later than~~

1 ~~14 days after~~ **After** CEPI receives the grade 3 state assessment
2 results from the department under ~~subdivision (c), whichever is~~
3 ~~earlier,~~ **subsection (5)**, using those state assessment results, CEPI
4 shall identify each pupil completing grade 3 that year who is
5 ~~subject to not being advanced to grade 4 due to the operation of~~
6 ~~subdivision (a) (i) and who is not eligible to enroll in grade 4~~
7 ~~under subsection (6) (a),~~ **has a reading deficiency** and shall notify
8 the parent or legal guardian and the school district or public
9 school academy of each of these pupils that the pupil ~~is subject to~~

11 **an explanation in the notification concerning what constitutes a**

20 ~~(i) That, based on standardized testing, this state has~~
21 ~~determined that the pupil may be required to be retained in grade 3~~
22 ~~as provided under state law, with a reference to this section along~~
23 ~~with an explanation that even if the pupil is not eligible to~~
24 ~~enroll in grade 4 based on state assessments, the pupil may still~~
25 ~~be allowed to enroll in grade 4 if he or she demonstrates a grade 3~~
26 ~~reading level through performance on an alternative standardized~~
27 ~~reading assessment or through a pupil portfolio.~~

28 ~~(ii) That the parent or legal guardian has the right to request~~
29 ~~a good cause exemption under this section that, if granted, will~~

4 ~~by CEPI and must direct the request to the school district or~~

8 ~~a meeting with school officials to discuss the retention~~

11 ~~(e) If a parent or legal guardian receives a notification from~~
12 ~~CEPI under subdivision (d), the parent or legal guardian may~~

15 ~~good cause exemption from that requirement. If a parent or legal~~

26 ~~(6) Subject to subsection (11), if a pupil or child~~
27 ~~demonstrates both of the following, then subsection (5) (a) and (b)~~
28 ~~do not apply and he or she may be enrolled in grade 4:~~

29 ~~(a) That he or she is proficient in all subject areas assessed~~

1 ~~on the grade 3 state assessment other than English language arts,~~
 2 ~~as evidenced by his or her scores on those assessments.~~

3 ~~(b) That he or she is proficient in science and social studies~~
 4 ~~as shown through a pupil portfolio and as determined by the teacher~~
 5 ~~who provided the grade 3 instruction to the pupil in science or~~
 6 ~~social studies, as applicable.~~

7 (7) ~~For~~ **Except as otherwise provided in this section, for a**
 8 **grade 3** pupil who is not promoted to grade 4 or a child who is not
 9 enrolled in grade 4 due to the operation of subsection (5), and for
 10 a pupil or child described in subsection (6) or (11), **has a reading**
 11 **deficiency based on the grade 3 state English language arts**
 12 **assessment**, the school district or public school academy shall
 13 provide, **only through grade 4**, a reading intervention program that
 14 is intended to correct the pupil's specific reading deficiency, as
 15 identified by a valid and reliable assessment. This program ~~shall~~
 16 **must** include effective instructional strategies necessary to assist
 17 the pupil in becoming a successful reader, and all of the following
 18 features, as appropriate for the needs of the individual pupil:

19 (a) Assigning to a pupil 1 or more of the following:

20 (i) A highly effective teacher of reading as determined by the
 21 teacher evaluation system under section 1249.

22 (ii) The highest evaluated grade 3 teacher in the school as
 23 determined by the teacher evaluation system under section 1249.

24 (iii) A reading specialist.

25 (b) Reading programs that are evidence-based and have proven
 26 results in accelerating pupil reading achievement within the same
 27 school year.

28 (c) Reading instruction and intervention for the majority of
 29 pupil contact time each day that incorporates opportunities to

1 master the grade 4 state standards in other core academic areas, if
2 applicable.

3 (d) Daily targeted small group or 1-to-1 reading intervention
4 that is based on pupil needs, determined by assessment data, and on
5 identified reading deficiencies and that includes explicit and
6 systematic instruction with more detailed and varied explanations,
7 more extensive opportunities for guided practice, and more
8 opportunities for error correction and feedback.

9 (e) Administration of ongoing progress monitoring assessments
10 to frequently monitor pupil progress toward a growth target.

11 (f) Supplemental evidence-based reading intervention delivered
12 by a teacher or tutor with specialized reading training that is
13 provided before school, after school, during regular school hours
14 but outside of regular English language arts classroom time, or any
15 combination of these.

16 (g) Providing parents, legal guardians, or other providers of
17 care for the pupil with a ~~"Read at Home"~~ **read-at-home** plan,
18 including parent, guardian, or care provider training workshops and
19 regular home reading.

20 ~~(8) If the superintendent of the pupil's school district or~~
21 ~~chief administrator of the pupil's public school academy, or his or~~
22 ~~her designee, grants a good cause exemption from the requirements~~
23 ~~of subsection (5) (a) for a pupil, then a pupil may be promoted to~~
24 ~~grade 4 without meeting the requirements of subsection (5) (a). A~~
25 ~~good cause exemption may be granted only according to the~~
26 ~~procedures under subsection (10) and only for 1 of the following:~~

27 ~~(a) The pupil is a student with an individualized education~~
28 ~~program or with a section 504 plan and the pupil's individualized~~

8 ~~2 or more years but still demonstrates a reading deficiency and was~~
9 ~~previously retained in kindergarten, grade 1, grade 2, or grade 3.~~

10 ~~(d) The pupil has been continuously enrolled in his or her~~
11 ~~current school district or public school academy for less than 2~~
12 ~~years and there is evidence that the pupil was not provided with an~~
13 ~~appropriate individual reading improvement plan under subsection~~
14 ~~(2) (b) by the school district or public school academy in which the~~
15 ~~pupil was previously enrolled.~~

16 ~~(e) The pupil's parent or legal guardian has requested a good~~
17 ~~cause exemption within the time period provided under subsection~~
18 ~~(10) (d) and the superintendent or chief administrator, or his or~~
19 ~~her designee, determines that the good cause exemption is in the~~
20 ~~best interests of the pupil.~~

21 ~~(9) Subject to subsection (14), if a pupil is promoted to~~
22 ~~grade 4 due to a good cause exemption granted under subsection (8),~~
23 ~~the pupil remains eligible for reading intervention services~~
24 ~~designed to enable the pupil to achieve proficiency in reading. The~~
25 ~~services for a pupil described in this subsection shall be similar~~
26 ~~to those provided to pupils in grade 3 under this section.~~

27 ~~(10) The superintendent of a school district or chief~~
28 ~~administrator of a public school academy, or his or her designee,~~
29 ~~shall grant a good cause exemption under subsection (8) only~~

1 ~~through the following procedure:~~

2 ~~(a) For a good cause exemption under subsection (8)(a) to (d),~~
3 ~~at the request of the pupil's parent or legal guardian or upon the~~

22 ~~program, with the pupil's individualized education program team.~~
23 ~~After this discussion, the chief administrator or his or her~~
24 ~~designee shall make a determination in writing of whether or not to~~
25 ~~grant the good cause exemption for the pupil. The decision by the~~
26 ~~chief administrator or his or her designee is final.~~

27 ~~(d) For a pupil for whom a request has been received from the~~
28 ~~pupil's parent or legal guardian, as described in subsection~~
29 ~~(8)(e), if the request is received within 30 days after the~~

1 notification by CEPI under subsection (5) (d), the superintendent of
 2 the school district or chief administrator of the public school
 3 academy, as applicable, or his or her designee, shall review the
 4 request and any supporting information and shall consider whether
 5 or not the good cause exemption is in the best interests of the
 6 pupil. After this consideration, he or she shall make a
 7 determination in writing of whether or not to grant the good cause
 8 exemption. This determination shall be made and communicated to the
 9 parent or legal guardian at least 30 days before the first day of
 10 school for the school year. The decision of the superintendent or
 11 chief administrator, or his or her designee, is final.
