

HOUSE BILL NO. 4226

March 09, 2023, Introduced by Reps. Filler, Breen, Bezotte, Harris, Bierlein, Brabec, Rheingans, Scott, Hood, Tyrone Carter, Andrews, Stone, Fitzgerald, Grant, MacDonell, Brenda Carter, Young, Haadsma, Glanville, Rogers and Aiyash and referred to the Committee on Appropriations.

A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
by amending section 11 (MCL 388.1611), as amended by 2023 PA 3, and
by adding section 97g.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 11. (1) ~~For the fiscal year ending September 30, 2022,~~
2 ~~there is appropriated for the public schools of this state and~~
3 ~~certain other state purposes relating to education the sum of~~
4 ~~\$14,511,014,700.00 from the state school aid fund, the sum of~~

1 ~~\$98,119,400.00 from the general fund, an amount not to exceed~~
 2 ~~\$72,000,000.00 from the community district education trust fund~~
 3 ~~created under section 12 of the Michigan trust fund act, 2000 PA~~
 4 ~~489, MCL 12.262, and an amount not to exceed \$100.00 from the water~~
 5 ~~emergency reserve fund.~~ For the fiscal year ending September 30,
 6 2023, there is appropriated for the public schools of this state
 7 and certain other state purposes relating to education the sum of
 8 ~~\$16,754,072,900.00~~ **\$16,754,073,000.00** from the state school aid
 9 fund, the sum of \$124,200,000.00 from the general fund, an amount
 10 not to exceed \$72,000,000.00 from the community district education
 11 trust fund created under section 12 of the Michigan trust fund act,
 12 2000 PA 489, MCL 12.262, and an amount not to exceed
 13 \$140,400,000.00 from the MPERS retirement obligation reform
 14 reserve fund created under section 147b. In addition, all available
 15 federal funds are only appropriated as allocated in this article
 16 for the fiscal ~~years~~ **year** ending ~~September 30, 2022 and~~ September
 17 30, 2023.

18 (2) The appropriations under this section are allocated as
 19 provided in this article. Money appropriated under this section
 20 from the general fund must be expended to fund the purposes of this
 21 article before the expenditure of money appropriated under this
 22 section from the state school aid fund.

23 (3) Any general fund allocations under this article that are
 24 not expended by the end of the fiscal year are transferred to the
 25 school aid stabilization fund created under section 11a.

26 **Sec. 97g. (1) From the state school aid fund money**
 27 **appropriated in section 11, there is allocated an amount not to**
 28 **exceed \$100.00 for 2022-2023 to districts as prescribed in this**
 29 **section.**

1 (2) To receive funding under this section, a district must
2 apply for the funding in a form and manner prescribed by the
3 department.

4 (3) From the money allocated under this section, the
5 department shall pay each district that has applied for funding as
6 described in subsection (2) for the development and implementation
7 of a numbering system as required under section 1e of 1937 PA 306,
8 MCL 388.851e, which includes, but is not limited to, the purchasing
9 of materials and payment to staff or workers as related to the
10 numbering system described in this subsection.

11 (4) Notwithstanding section 17b, the department shall make
12 payments under this section on a schedule determined by the
13 department.

14 Enacting section 1. This amendatory act does not take effect
15 unless Senate Bill No.____ or House Bill No. 4225 (request no.
16 00378'23) of the 102nd Legislature is enacted into law.
