A bill to require certain training and equipment with respect to cardiac arrest in senior living facilities; to provide for the powers and duties of certain state and local governmental officers and entities; and to prescribe civil sanctions.

- 2 (a) "Activities of daily living" includes, but is not limited

- 7 (d) "Assisted living facility" means an unlicensed entity that
- 8 offers community-based residential care for not fewer than 3

- 11 (e) "Home for the aged" means that term as defined in section
- 12 20106 of the public health code, 1978 PA 368, MCL 333.20106.

- 15 (g) "Senior living facility" means all of the following:

- Sec. 5. Beginning 1 year after the effective date of this act,
- 22 the owner or operator of a senior living facility shall do all of

- 24 (a) Provide a training course taught by the American Red

- 26 organization approved by the department of licensing and regulatory
- 27 affairs, to employees of the senior living facility and interested

- 29 (i) Basic cardiopulmonary resuscitation.

- 1 (ii) AED use.
- (b) Have available on the premises of the senior living
 facility an AED deployed in a manner that provides obvious and
 ready accessibility to employees, residents, and guests of the
 senior living facility.
- Sec. 7. A person who violates this act is responsible for a state civil infraction and may be ordered to pay a civil fine of not more than \$500.00.
