THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 201. As used in this article:
- 2 (a) "Employer" means a person that has 1 or more employees,
- 3 and includes an agent of that person.
- 4 (b) "Employment agency" means a person regularly undertaking

- 1 with or without compensation to procure, refer, recruit, or place
- 2 an employee for an employer or to procure, refer, recruit, or place
- 3 for an employer or person the opportunity to work for an employer
- 4 and includes an agent of that person.
- 5 (c) "Labor organization" includes:
- 6 (i) An organization of any kind, or an agency or employee
- 7 representation committee, group, association, or plan, in which
- 8 employees participate and that exists for the purpose, in whole or

- 10 disputes, wages, rates of pay, hours, or other terms or conditions

- (b) "Public service" means a public facility, department, 7 8 agency, board, or commission, owned, operated, or managed by or on 9 behalf of this state, a political subdivision, or an agency of this 10 state or of a political subdivision or a tax exempt private agency 11 established to provide service to the public, except that public 12 service does not include a state or county correctional facility 13 with respect to actions and decisions regarding an individual 14 serving a sentence of imprisonment.
