Senator Polehanki's statement is as follows:

This letter is an explanation of my "no" vote on Senate Bill No. 803 of 2024. Although I am not categorically opposed to the practice of hunting, I cannot in good conscience support the practice of canned hunting. I am opposed to this legislation due to my belief that it promotes the practice of canned hunting in our state. Please include this as an official record in the Senate Journal.
