## SUBSTITUTE FOR HOUSE BILL NO. 4024

A bill to require that certain educational institutions in this state, when providing students with multiple-occupancy restrooms, changing areas, and similar facilities, do so in a manner that ensures each student's privacy from individuals of the opposite sex; and to provide for the powers and duties of certain state and local governmental officers and entities.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act may be cited as the "student restroom privacy act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Educational institution" means a public educational
- 5 institution or a separate school or department of a public
- 6 educational institution, including, but not limited to, an academy,

- 1 college, elementary or secondary school, extension course,
- 2 kindergarten, nursery, local school system, or university; a
- 3 business, nursing, professional, secretarial, technical, or
- 4 vocational school; any educational institution that receives funds
- 5 from this state; or an agent of an educational institution.
- 6 (b) "Multiple-occupancy restroom or changing area" means an
- 7 area in an educational institution designed or designated to be
- 8 used by more than 1 student at a time, where students may be in
- 9 various stages of undress in the presence of other students or
- 10 individuals. Multiple-occupancy restroom or changing area includes,
- 11 but is not limited to, a restroom, locker room, changing room, or
- 12 shower room.
- 13 (c) "Sex" means the biological indication of male or female,
- 14 as listed on an individual's original birth certificate that was
- 15 issued at or near the time of the individual's birth.
- Sec. 3. (1) An educational institution shall require every
- 17 multiple-occupancy restroom or changing area to be used by
- 18 individuals based on the individuals' sex.
- 19 (2) This section does not apply to an individual who enters a
- 20 multiple-occupancy restroom or changing area designated for use by
- 21 the opposite sex if the individual enters for any of the following
- 22 circumstances:
- 23 (a) Custodial purposes if only the individual performing the
- 24 custodial purposes is present.
- 25 (b) Maintenance or inspection purposes if only the individual
- 26 performing the maintenance or inspection purposes is present.
- (c) To render medical assistance.
- 28 (d) To accompany a student needing assistance if the assisting
- 29 individual is an employee of the educational institution or the

- 1 student's parent or legal guardian or authorized caregiver and if
- 2 the multiple-occupancy restroom or changing area is cleared of
- 3 other students or individuals.
- 4 (e) If the individual is a minor child, to accompany the minor
- 5 child's parent or guardian into the multiple-occupancy restroom or
- 6 changing area of the parent's or guardian's sex.
- 7 (f) When the multiple-occupancy restroom or changing area has
- 8 been temporarily designated for use by those of the individual's
- 9 sex.
- 10 (3) This section does not prohibit an educational institution
- 11 from allowing a single-occupancy restroom or changing area to be
- 12 used by an individual of either sex.
