

HOUSE BILL NO. 4934

September 11, 2025, Introduced by Reps. Frisbie, Borton, Martin, Wozniak, Schuette and Alexander and referred to Committee on Health Policy.

A bill to amend 1978 PA 368, entitled
"Public health code,"
by amending section 18223 (MCL 333.18223), as amended by 2018 PA
24.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 18223. (1) The department, in consultation with the
2 board, shall promulgate rules requiring that to be granted a
3 license under this part, except as provided in subsection (2), an
4 individual must meet both of the following requirements:

1 (a) Have been granted a doctoral degree in psychology, or a
2 doctoral degree in a closely related field, from a doctoral degree
3 program that meets all of the following requirements:

4 (i) Is offered by a regionally accredited or other college,
5 university, or institution approved by the board, and includes
6 education and training appropriate to the practice of psychology.

7 (ii) Has obtained the Association of State and Provincial
8 Psychology Boards' national register designation, has been
9 accredited by the American Psychological Association or the
10 Canadian Psychological Association, or has obtained a similar
11 designation from or been accredited by an entity approved by the
12 board. However, a program that is in the process of obtaining the
13 designation or becoming accredited as required in this subparagraph
14 before August 1, 2011, and that obtains the designation or becomes
15 accredited on or before August 31, 2020, meets the requirements of
16 this subparagraph.

17 (b) Have not less than 1 year of postdoctoral experience in
18 the practice of psychology in an organized health care setting or
19 other arrangement, as established by the board.

20 (2) In addition to section 16182, the board shall grant a
21 limited license to an individual granted a master's degree in
22 psychology from a regionally accredited college, or university, or
23 institution approved by the board, if the individual has education,
24 training, and experience appropriate to the practice of psychology,
25 as established by the board. An individual who applies for an
26 initial limited license under this subsection before March 31, 2018
27 is not required to take an examination that is approved by the
28 board to be granted a limited license under this part if the
29 individual was granted a master's degree in psychology after

1 January 1, 2007 but before June 30, 2010 from the college,
2 university, or institution described in this subsection, the
3 individual has continuously held the temporary license described in
4 this section since it was initially granted by the board, and the
5 disciplinary subcommittee has not imposed a sanction against the
6 individual while holding the temporary license described in this
7 section. Except for duties performed as an employee of a
8 governmental entity or of a nonprofit organization serving
9 benevolent and charitable purposes, the board shall place 2
10 limitations on a license granted to an individual under this
11 subsection. The limitations must require supervision by a
12 psychologist who has a license other than a limited license and
13 must prohibit advertising or other representation to the public
14 that will lead the public to believe the individual is engaging in
15 the practice of psychology. A limited license granted under this
16 subsection is renewable under part 161. An individual who is
17 applying for a limited license under this subsection must have 1
18 year of supervised postgraduate experience in an organized health
19 care setting or other arrangement, as established by the board. The
20 individual must be supervised by a psychologist who has a license
21 other than a limited license, or if a psychologist who has a
22 license other than a limited license is not available, by a
23 psychologist who has at least a master's degree in psychology and
24 at least 3 years of experience in the practice of psychology or by
25 any other individual approved by the board.

26 (3) The board shall grant a temporary license to an individual
27 described in subsection (2) for the purpose of obtaining the 1 year
28 of postgraduate experience described in that subsection. ~~Beginning~~
29 ~~on March 31, 2018, a~~ **A** temporary license granted under this

1 subsection is valid for 24 months and may be renewed for 1
2 additional 24-month term. If an individual described in subsection
3 (2) was granted a temporary license by the board before March 31,
4 2018, ~~his or her~~ **the individual's** temporary license may be renewed
5 for 1 additional 24-month term.

6 (4) The board shall grant a temporary license to an individual
7 who is enrolled in a doctoral degree program that meets the
8 requirements of subsection (1). ~~Beginning on March 31, 2018, a~~ **A**
9 temporary license granted under this subsection is valid for 24
10 months and may be renewed for 3 additional 24-month terms. If an
11 individual enrolled in a doctoral program that meets the
12 requirements of subsection (1) was granted a temporary license by
13 the board before March 31, 2018, ~~his or her~~ **the individual's**
14 temporary license may be renewed for 3 additional 24-month terms.

15 (5) **If a temporary license granted to an individual under**
16 **subsection (3) or (4) lapses and the individual is relicensed under**
17 **section 16201, the relicensure of the temporary license is**
18 **considered 1 renewal under subsection (3) or (4).**
