GENERAL SECTIONS

Sec. 201. In accordance with section 30 of article IX of the state constitution of 1963, for the fiscal year ending September 30, 2026, total state spending from state sources under part 1 is \$0.00 and total state spending from state sources under part 1 to be paid to local units of government is \$0.00.

DEPARTMENT OF ATTORNEY GENERAL

7 assault, and stalking, including collaborating to develop and
8 enforce arrest policies and policies aimed at enforcement of
9 protection orders.
